Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AGBU Manoogian-Demirdjian School 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1. PLAN DESCRIPTION

The following description of the AGBU Manoogian-Demirdjian School 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all full-time employees of AGBU Manoogian–Demirdjian School (the School). Employees are eligible for participation after completion of 60 days of service. Plan entry dates are the first day of each month. The Plan was adopted on January 1, 1990 as a defined contribution plan and is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts and Contributions: Participants may contribute up to 100% of pretax and up to 75% of after-tax annual compensation, as defined in the Plan. Total participant contributions are subject to annual limits under the IRC. The maximum participant deferral limit was \$23,000 for the year ended December 31, 2024. Catch-up contributions of \$7,500 were available to participants who had attained age 50 or older by December 31, 2024, and had not exceeded the contribution limit for the Plan year.

Effective January 1, 2023, the Plan was amended to allow the School to make safe harbor matching contributions of 100% of employee deferrals up to 5% of compensation. The School may also make discretionary profit sharing contributions to the Plan, which are determined by the Board of the School, subject to formula limitations, as defined by the Plan. The School made safe harbor matching contributions of \$243,610 for the year ended December 31, 2024. The School did not make any discretionary profit sharing contributions for the year ended December 31, 2024.

Each participant's account is credited or charged by: participant's own contributions; rollover contributions from participant's other qualified plan(s); the School's safe harbor matching contributions; the School's discretionary profit sharing contributions; investment earnings; and administrative expenses.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon, as well as their rollover contributions plus actual earnings thereon. Safe harbor matching contributions are 100% vested when made and are not subject to forfeiture. Vesting in the School's discretionary employer matching contributions made prior to January 1, 2023, and profit-sharing contributions, plus earnings thereon, is based on years of continuous service in accordance with the following schedule:

NOTE 1. PLAN DESCRIPTION (Continued)

Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies or (3) terminates employment by reason of permanent disability, the School discretionary matching and profit sharing contributions become 100% vested without regard to years of service.

Benefit Payments: Upon termination of service, for reasons other than death, payment may be made immediately as a lump sum distribution. For termination of service due to a participant's death, the entire account balance will be payable based on the Plan document. Involuntary cash-outs will be payable based on the Plan document. Annuities are not permitted as a form of distribution. The Plan has no early retirement provision.

In-service distributions are allowed when a participant either attains age 59-1/2 or experiences a financial hardship as defined by the IRC. The Plan provides for hardship withdrawals, not to exceed an amount required to meet the immediate need created by the hardship, and then only to the extent such immediate need cannot be satisfied by other sources reasonably available to the participants. Such withdrawals are subject to applicable excise and income taxes and may only be made with the approval of the Plan Administrator.

Plan Termination: Although it has not expressed any intent to do so, the School has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Notes Receivable from Participants: Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested balance. The notes receivable from participants are secured by the vested balance in the participant's account and bear interest at the prevailing market rate as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. The maximum number of loans outstanding at any one time, is one. Loan terms may not exceed five years, except notes receivable used to purchase a participant's primary residence.

Forfeitures: Terminated participants' unvested School contributions, if any, would be retained in the Plan as forfeitures and may be used to reduce future School contributions or pay administrative expenses. The balance of forfeitures available for future use was immaterial at December 31, 2024.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition: Investments are reported at fair market value. Investments in shares of registered investment companies (mutual funds) are valued at quoted market prices, which represent the net asset value of shares held at year-end. Money market funds are stated at their carrying values, which approximate fair values.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments consists of net realized gains or losses and the net unrealized appreciation or depreciation in the fair value of investments.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance, plus accrued but unpaid interest at the end of the period.

Administrative Expenses: The School incurs certain expenses in administering the Plan, which if not paid by the School are paid by the Plan.

Benefit Payments: Benefits are recorded when paid.

NOTE 3. CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, investment transactions, investment income, notes receivable from participants, and the schedule of assets held at end of year have been derived from information certified as complete and accurate by Ascensus, the Plan trustee, in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4. INCOME TAX STATUS

The School has adopted a volume submitter plan that has received an opinion letter dated November 30, 2020 from the Internal Revenue Service (IRS), which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since that date. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

NOTE 4. INCOME TAX STATUS (Continued)

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment funds which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

Level 1 Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following methods and assumptions were used to estimate the fair value of investments. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money Market Funds: The carrying value approximates fair value.

Mutual Funds: Valued using quoted market prices in active markets which represent the net asset value of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7. DELINQUENT CONTRIBUTIONS

During the year ended December 31, 2023, the School inadvertently failed to remit participant deferrals timely in the amount of \$701. The DOL considers late deposits to be prohibited transactions. The School self-corrected the issue during 2024. The contributions, along with applicable lost earnings, were deposited into the affected participant accounts.

During the year ended December 31, 2024, the School inadvertently failed to deposit participant contributions timely in the amount of \$3,074. The contributions were deposited within the plan year and the School is in the process of self-correcting the delinquency.

NOTE 8. SUBSEQUENT EVENTS

Management has evaluated subsequent events for recognition and disclosure through September 22, 2025, which is the date the financial statements were available to be issued.
