Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the DTRIC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements
December 31, 2024 and 2023

1. Description of the Plan

The following description of the DTRIC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

a. General

The Plan was adopted by DTRIC Insurance Company, Ltd. effective June 27, 2017 as a spin-off from the Royal State Corporation 401(k) Profit Sharing Plan. The Plan was amended and restated as of January 1, 2024. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan covers the employees of DTRIC Management Company, Ltd (DMCL) and DTRIC Insurance Company, Ltd (DTRIC) (collectively, the Company).

b. Administration

The Plan Administrative Committee of the DTRIC 401(k) Profit Sharing Plan (the Committee) is appointed by the Board of Directors of the Company and is responsible for management and administration of the Plan. DTRIC is the trustee of the Plan and Ascensus Trust Company (Custodian) is the custodian of the Plan's assets. The primary functions of the custodian are to execute transactions as specified by the Plan Administrator and maintain accounts and records of the Plan's assets.

The Plan's administrative expenses are paid by either the Plan or the Company.

c. Eligibility

Employees are eligible to participate in the Plan upon attainment of age 18 and completion of three months of service.

d. Participant Contributions

Eligible employees of the Company are entitled to make salary deferrals to the Plan up to the Internal Revenue Code (IRC) limitations. Participants may elect to start, increase, reduce or totally suspend their deferral amounts each pay period. Participants are allowed to direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

e. Employer Contributions

For the year ended December 31, 2024, the Company made a safe harbor matching contribution of approximately \$264,000 which is an amount equal to 100% of the matched employee contributions that are not in excess of 4% of the employee's eligible compensation.

f. Participant Accounts

Each participant account is credited with the participant's contribution, and an allocation of the Company's safe harbor matching contributions. Plan earnings are allocated to each participant's account in the proportion that the value of each participant's account bears to the value of all such accounts.

g. Vesting

Participants are immediately and fully vested in their voluntary contributions and employer safe harbor matching contributions, plus actual earnings thereon. For non-elective contributions, participant interest will vest based on a five-year graded vesting schedule.

h. Notes Receivable from Participants

Upon approval of the Plan Administrator, participants may elect to obtain loans from their accounts in amounts up to the lesser of \$50,000 or 50 percent of their vested account balance, subject to various limitations and eligibility requirements. The loans are secured by the balance in the participant's account. The interest rate is the prime rate plus 1%. The loan must provide for at least quarterly payments under a level amortization schedule. The term of repayments, other than those executed for a home loan, may not exceed 5 years. If the proceeds are used for a home loan, the Plan Administrator may fix the term of the repayment for a period not to exceed 15 years. At December 31, 2024, participant loans bear interest at rates ranging from 4.25 to 9.50 percent and mature through June 2036.

i. Payment of Benefits

Upon termination, a participant is entitled to receive the value of their account balance. If a participant's balance in his or her account is \$1,000 or less, the participant's balance will be distributed in a lump sum as soon as practicable.

Prior to termination of employment, certain withdrawals pertaining to death, disability, or hardship are permitted.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP).

b. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

c. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions when a distributable event has occurred such as termination of employment, death or disability.

d. Payment of Benefits

Benefits are recorded when paid.

e. Management's Use of Estimates

In preparing financial statements in conformity with US GAAP, the Plan Administrator is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accounts subject to such estimates and assumptions include the fair value of investments. Actual results could differ from those estimates.

f. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

g. Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued, and it was determined that all subsequent events had been properly accounted for.

active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. At December 31, 2024 and 2023, the Plan's assets at fair value were measured using level 1 measurements, consisting of quoted market prices based on the net asset value of shares held by the Plan at year end. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by the Custodian. The non-standardized pre-approved plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the non-standardized pre-approved plan's qualified status. The non-standardized pre-approved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the non-standardized pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

US GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan years from December 31, 2021 are open for examination for federal tax purposes.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its matching contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Exempt Party-in-Interest Transactions

The Plan's investments in a money market fund and certain mutual funds that are managed by The Vanguard Group Inc., an affiliate of the Custodian, and therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.
