NOTE A - DESCRIPTION OF PLAN

The following description of United Medical 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2015. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering substantially all employees of United Medical Imaging, Inc. and United Medical Imaging Healthcare, Inc. (collectively referred to as "the Company") who have completed one year of service, are age 21 or older, and are not employees covered by a collective bargaining agreement, leased employees, nonresident aliens or employees who became employees as a result of a Code §410(b)(6)(C) transaction. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants are automatically enrolled in the Plan on the first day of the Plan quarter coinciding with or next following the date the eligibility requirements are met. Unless a participant makes an affirmative election, participants are automatically enrolled to contribute 3% of compensation each pay period on a pre-tax basis. Participants may elect to contribute on a pre-tax basis or post-tax (Roth) basis from 1% up to the maximum allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make flexible discretionary matching contributions and discretionary qualified nonelective contributions to the Plan. During the years ended December 31, 2024 and 2023, the Company made flexible discretionary matching contributions equal to 25% of participant contributions up to 6% of compensation for the years ended December 31, 2024 and 2023. The Company did not make any discretionary qualified nonelective contributions to the Plan during the years ended December 31, 2024 and 2023. Participants direct the investment of their Company contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's flexible discretionary matching contributions, if any, an allocation of any Company discretionary qualified nonelective contributions, if any, and Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in their contributions and any Company discretionary qualified nonelective contributions plus actual earnings thereon. Vesting in the Company's flexible discretionary matching contributions and earnings thereon is based on years of service as follows:

If a participant dies or is disabled prior to attaining normal retirement age, the participant becomes 100% vested.

Notes Receivable from Participants

The Plan does not allow participant loans.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship withdrawals are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments are made in the form of lump sum distributions or partial withdrawals. Effective January 1, 2024, participants who terminate employment with a balance of less than \$7,000 may receive an automatic direct rollover of their account balance into an individual retirement account. Effective through December 31, 2023, participants who terminated employment with a balance of less than \$5,000 may have received an automatic direct rollover of their account balance into an individual retirement account.

Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. Forfeitures may first be used to pay the Plan's expenses and then may be used to reduce future Company contributions. As of December 31, 2024 and 2023, the forfeiture balance was \$4,321 and \$7,961, respectively. Forfeitures of \$23,793 and \$6,725 were used to pay a portion of the Plan's expenses during the years ended December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash

The Plan considers cash to be highly liquid non-interest-bearing funds held in the Plan with an original maturity date of three months or less.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company's flexible discretionary matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation. The Company's discretionary qualified nonelective contributions, if any, are recorded in the year in which the participant's compensation is earned.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund: Valued at the NAV of units of the collective investment trust fund as reported by the fund, which is based on the value of the underlying assets reported in the fund's financial statements. The NAV is used as a practical expedient to estimate fair value. Units of beneficial interest are not registered with the SEC; however, these funds publish their daily NAV and transact at that price. There are no unfunded commitments. The redemption frequency is daily. The fund requires a 60 day advance written notice for withdrawals other than benefit payments and transfers. There is a market adjustment upon the withdrawal of participation in the fund by the Plan. As of December 31, 2024 and 2023, the plan administrator does not believe any events which would limit the unit holders to transact at net asset value are probable of occurring.

Fixed index annuity: Valued at the cash value. The cash value is the value that is paid if the annuity is cancelled or cashed in. The cash value is equal to the accumulation value adjusted by a market value adjustment (MVA). The accumulation value reflects all money put into the annuity plus any interest credited minus withdrawals and fees. The MVA is applied to premiums that have been in the contract for less than 10 years for full withdrawals, annuity payments that begin before the 5th contract anniversary, or a partial withdrawal that is taken that is not a lifetime withdrawal, cumulative withdrawal, or a required minimum distribution. The MVA is calculated by measuring the difference in the MVA reference rate from the last business day prior to the date that the MVA is applied to the MVA reference rate for each annual contribution amount. The MVA reference rate for each annual contribution amount is the weighted average for each premium of MVA reference rates from the last business day prior to the date the premium was placed in the contract. The difference in the MVA reference rate and contract values are used to calculate the MVA, which is applied to annual contribution amounts withdrawn or applied to annuity payments. The MVA is limited so that it never exceeds the lesser of the difference of the accumulation value minus the guaranteed minimum value (guaranteed minimum value is 87.5% of the money put into the annuity plus any interest credited and minus any withdrawals) or the sum of the MVA limits for each annual contribution amount where the MVA limit for each annual contribution amount is equal to that annual contribution amount multiplied by the MVA limit percentage for that MVA period contract year.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determination fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F – TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan is designed in accordance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

TRI-AD Actuaries, Inc. and its affiliate TRI-AD Capital Management, Inc. (collectively referred to as "TRI-AD") provide recordkeeping, third-party administration, and investment advisory services to the Plan. Fees paid to TRI-AD qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules, and are included in administrative expenses.

Plan investments are held and managed by Charles Schwab Trust Company. Charles Schwab Trust Company is the trustee for the Plan and, therefore, is a party-in-interest. Investment fees paid to Charles Schwab through revenue sharing are included in the net appreciation in fair value of investments.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I – PROHIBITED TRANSACTION

During the year ended December 31, 2024, the Company inadvertently failed to deposit \$83 of participant contributions within the required timeframe as stated by the Department of Labor resulting in a prohibited transaction. The Company is in the process of correcting the delinquent participant contributions.

NOTE J – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500
