We have performed audits of the financial statements of Forge Resource Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### Note 1. Plan Description

The following description of Forge Resource Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined-contribution plan sponsored by Forge Resource Group LLC (the Company). Employees are eligible for the salary deferral portion of the Plan following two months of service, as defined by the Plan, and may enter the Plan the first day of the following quarter. Employees are eligible to participate in the Company matching contribution portion of the Plan upon completion of one year of service, as defined by the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions:** Each year participants may contribute up to an amount not to exceed a dollar limit which is set by the Internal Revenue Code (IRC). Participants may designate some or all of their contributions as Roth contributions subject to the IRC limitations. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan at a 6% deferral rate unless they affirmatively elect not to participate in the Plan or change their deferral rate. This deferral rate automatically increases by 1% annually, up to a maximum of 8%, for those employees who continued to be auto-enrolled as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. The Company contributes a matching contribution to the Plan equal to 100% of the first 4% and 50% of the next 2% of participants' compensation deferred to the Plan. The Company may contribute a discretionary contribution if it chooses to do so. During the year ended December 31, 2024, there were no discretionary contributions.

**Participant accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contributions, and Company discretionary contributions, if any, and (b) Plan earnings and charged with an allocation of administrative expenses and applicable loan fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A general method is used where if 1,000 hours were worked in a Plan year, a year of service is credited. Participants are 100% vested in Company safe-harbor matching contributions, plus actual earnings thereon. The Plan includes previously frozen profit-sharing contributions for which vesting is ratable annually resulting in a participant being 100% vested after six years of credited service. In the event of death, disability or retirement at designated ages, participants become fully vested.

**Investment options:** Upon enrollment in the Plan, participants may direct their account balances in a variety of investment options, as more fully described in the Plan's literature. Participants may change their investment options daily.

#### Note 1. Plan Description (Continued)

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding loan balance in a participant's account during the prior 12-month period or (b) 50% of the participant's vested balance. Notes are available for any purpose. Note terms range up to five years, or up to 10 years for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear a rate of interest commensurate with local prevailing rates as determined by the Plan Administrator at the time the note is made. Principal and interest payments are required and are paid through payroll deductions.

**Payment of benefits:** On termination of service, death, disability or retirement, participants may elect to receive the value of their accounts in the form of a lump sum equal to the value of the participant's vested amount in his or her account. Installment payments and partial withdrawal payments are also allowed under the Plan. Distributions may also be made from the Plan in cases of financial hardship as defined in the plan agreement. In addition, participants over age 59½ may withdraw all or a portion of their vested account balance while still employed. Participants over age 72 are required to receive minimum annual distributions as required in the plan document. Account balances less than \$5,000 but more than \$1,000 at date of termination are distributed to an individual retirement account or annuity for the participant's benefit upon termination, while account balances less than \$1,000 at date of termination are paid in a lump sum upon termination.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts were approximately \$10,800 and \$30, respectively. These accounts can be used to pay plan expenses, reduce Company contributions or can be reallocated to participants. In 2024, approximately \$6,100 was used to reduce Company contributions and approximately \$400 was used to pay plan expenses.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the Plan's trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accounted for on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

**Payment of benefits:** Benefits paid directly to participants are recorded when paid.

**Subsequent events:** The Plan's management has evaluated subsequent events through August 26, 2025, the date on which the financial statements were available to be issued.

#### Note 3. Information Certified or Provided by Fidelity Management Trust Company (Fidelity)

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Units of collective investment trust:** This investment is valued based on the net asset value (NAV) of units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Shares of registered investment companies:** Shares of registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets measured at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of the transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

The following tables summarize investments measured at NAV as a practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments. The redemption notice period is applicable only to the Plan.

#### Note 5. Related-Party and Party-in-Interest Transactions

Certain plan investments are shares of registered investment companies that are managed by an affiliate of Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services to Fidelity amounted to \$26,392 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company for which no compensation is received from the Plan.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company may discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

#### Note 7. Income Tax Status

The Plan has adopted a pre-approved defined contribution plan sponsored by FMR LLC. The pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service as to the pre-approved defined contribution plan's qualified status. The pre-approved defined contribution plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved defined contribution plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
