## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator  
Cardinale Automotive Group 401(k)  
Profit Sharing Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Cardinale Automotive Group 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Cardinale Automotive Group 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established on January 1, 1995, and generally covering all non-union full-time employees of the Cardinale Automotive Group (the "Company") who are at least 21 years of age and have completed at least six months of service.

Cardinale Automotive Group consists of: Zero Moment of Truth, Inc., Cardinale Nissan, Inc., Cardinale Protective Services, Inc., Cardinale Automotive Group Arizona, Inc., Saul Chevrolet, Inc., Cardinale Group, Inc., Cardinale AG Nevada, Inc., Cardinale Way Nevada AG, Inc., Cardinale Motors SLO, Inc., JT-CGS, Inc., TSC Motors, Inc., Bay Area AG, Inc., NoCal AG, Inc., Cardinale Oldsmobile GMC Truck Inc. and CCP Auto Group Inc.

Entry into the Plan is available on the first day of the month following the date that an employee becomes eligible. The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and was most recently restated effective June 3, 2022, to conform to current tax laws.

***Basis of accounting*** – The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of estimates*** – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Administration*** – The Company is the Plan Administrator and is responsible for the operation and administration of the Plan. The Company has appointed certain officers to hold the office of Trustees. Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, (collectively "Empower"), were appointed by the Trustees to act as the Plan's custodians. Except for certain investment advisory fees and recordkeeping fees that are paid by the Plan, the Company generally pays all expenses to administer the Plan.

***Vesting*** - Participants are fully vested in their voluntary contributions, plus earnings thereon, at all times. Participants generally become fully vested in any Company contributions ratably depending upon their date of hire. Employees hired prior to July 27, 2021, vest in any Company contributions ratably over a five-year period and those employees hired on or after July 27, 2021, vest in any Company contributions ratably over a six-year period.

***Investments, at fair value*** – The majority of the Plan’s investments are reported at estimated fair values, which are determined, presented, and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*. Investment income from such investments is intended to provide a significant source of support for the Plan’s future operations. Fair value is the amount that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date.

***Investment income recognition*** – Gains or losses that result from market fluctuations are recognized in the period such fluctuations occur. Purchases and sales of investments are recorded on a trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes realized and unrealized gains and losses recognized during the current period.

***Forfeited amounts*** – Forfeited accounts may be used to pay administrative expenses or to reduce any Company contributions. As of December 31, 2024 and 2023, unallocated forfeitures were \$582 and \$562, respectively. For the year ended December 31, 2024, no forfeitures were used to reduce Company contributions or pay for Plan expenses, respectively.

***Employee contributions*** - Participants may elect to have the Company contribute a percentage of their pre-tax compensation to the Plan, up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants may also elect to have the Company contribute a portion of their compensation on an after-tax basis in the form of Roth salary deferral, up to the annual additions limit. Participants may also elect to contribute amounts representing distributions from other qualified plans.

The Plan also includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate. The default deferral rate for automatically enrolled participants is 2% of eligible compensation. Contributions are automatically invested in a designated balanced investment option until changed by the participant.

***Employer contributions*** - The Plan permits discretionary Company matching and profit-sharing contributions. Company matching contributions, if any, are allocated to participant accounts based on eligible salary deferral contributions. Company profit-sharing contributions, if any, are allocated to participants based on their relative proportion of eligible

compensation for each defined employment classification. For the year ended December 31, 2024, there were no matching and employer profit-sharing contributions.

*Participant accounts* - The participants' accounts are credited with their voluntary contributions and an allocation of (a) the Company's contributions, if any, and (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account balances into various investment options offered under the Plan.

*Payment of benefits* - Benefits are recorded when paid. Benefits are generally paid in lump-sum amounts equal to the value of the participant's vested account balance upon termination or, if requested, upon attainment of age 59 ½. In some cases, benefits may be paid in regular installments.

*Notes receivable from participants* - The Plan provides a provision which allows a participant to borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested balance, bear interest at the available market financing rates and are repaid to the Plan through payroll deductions generally within five years. The specific terms and conditions of such loans are established by the Plan Administrator. Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

*Subsequent Events* - The Plan's management evaluates events or transactions occurring after the balance sheet date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. For the purposes of the accompanying combined financial statements, subsequent events have been evaluated through September 25, 2025, which represents the date the financial statements were available to be issued.

## 2. INVESTMENT VALUATION

The Plan's investments are stated at fair value following the guidance of U.S. GAAP for measuring the fair value of investments. Those principles establish a framework for measuring fair value and provide a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market

data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Mutual funds are valued at fair market value as of the last day of the Plan year as quoted by the Plan's custodian based on reported asset values obtained on a daily basis from a national exchange.

*Fixed annuity:* Investments in a fixed annuity is valued at fair value, which approximates contract value, calculated based on the earnings of the underlying assets compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

The Plan's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has been amended since receiving its latest determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in material compliance with the applicable requirements of the Internal Revenue Code.

#### 5. PRIORITIES ON TERMINATION

The Company intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to terminate the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA.

#### 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are owned and managed by Empower or one or more of its affiliates. Since Empower is the Plan's custodian, investment activities involving these investments qualify as party-in-interest transactions.
