Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Legacy Early College 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Legacy Early College 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A – DESCRIPTION OF PLAN

The following description of the Legacy Early College 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

GENERAL

The Plan is a defined contribution plan covering employees, excluding non-resident aliens, of Legacy Advancement (the “Company”) who are age twenty or older. The Board of Directors of the Company controls and manages the operation and administration of the Plan. Ascensus, Inc., as an agent for Ascensus Trust Company, serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

CONTRIBUTIONS

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan Document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company makes a matching safe harbor contribution of one hundred percent (100%) of participant’s deferrals of first three percent (3%) of base compensation and a matching contribution of fifty percent (50%) of participant’s deferrals on the next two percent (2%) of base compensation. The matching contribution cannot exceed four percent (4%) of the participant’s compensation. Contributions are subject to certain limitations.

The Company makes discretionary contributions each plan year, as allowed by the Plan. These discretionary contributions allow the Company to match two-thirds of a percent (2/3%) of participant contributions up to six percent (6%) of the participant’s base compensation, allowing a maximum of four percent (4%) of the participant’s compensation to be matched by the Company.

NOTE A – DESCRIPTION OF PLAN (Continued)

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings (losses), and charged with benefit payments, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

INVESTMENT OPTIONS

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and money market funds as investment options for participants.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participant reaches the age of 59.5 years.

VESTING

Participants are immediately vested in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portions of their accounts plus actual earnings thereon is based on years of service. A participant is one hundred percent (100%) vested after six years of credited service. Entitlement to full vesting is also earned upon retirement at age sixty-five (65) or later, termination due to permanent disability, or death.

NOTE A – DESCRIPTION OF PLAN (Continued)

FORFEITURES

The Plan permits forfeitures to be used to reduce future Company contributions, restore forfeitures, reallocate as Company contributions or pay Plan fees. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$287,768 and \$156,037, respectively. These accounts will be used to reduce future employer contributions. Subsequent to year end, forfeited accounts totaling \$167,306 have been used to reduce employer contributions through the date of issue of these financial statements.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

INVESTMENT VALUATION AND INCOME RECOGNITION (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded upon distribution.

EXPENSES

The Plan's administrative expenses are paid by the Company. Certain administrative functions are performed by employees of the Company.

No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

SUBSEQUENT EVENTS

Subsequent events were evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

NOTE C – RELATED-PARTY TRANSACTIONS

The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. The Company also incurs some expenses on behalf of the Plan, which are both individually and collectively immaterial in amount.

The Vanguard Group, Inc. dba Vanguard Retirement Plan Access Services (VRPAS) serves as the third-party administrator (“TPA”) and manages the day to day operations of the Plan. To facilitate these services, VRPAS contracts Ascensus, Inc. In addition, VRPAS provides certain administrative services to the Plan pursuant to a recordkeeping service agreement, and therefore these transactions qualify as exempt party-in-interest transactions. VRPAS may receive revenue from mutual funds service providers for services they provide to the funds. This revenue is credited back directly to the participant accounts to offset any fees charged to the Plan. Expenses paid directly by the Company are excluded from these financial statements. No fees were paid by the Plan in 2024 or 2023.

NOTE D – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting the Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Ascensus Trust Company, an affiliate of Ascensus, Inc., the custodian, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedule. Accordingly, Ascensus Trust Company has certified to the completeness and accuracy of the mutual funds and money market funds, including investments as reflected in the statement of net assets available for benefits, the statement of changes in net assets available for benefits, and the supplemental schedule of assets held for investment purposes at end of year as of December 31, 2024 and 2023. The following is a summary of the investments from participants certified by the custodian as of December 31, 2024 and 2023.

Ascensus Trust Company certified to the completeness and accuracy of the interest and dividend income of \$188,582 and \$103,562 and the net appreciation of \$547,408 and \$574,211 for the years ended December 31, 2024 and 2023, respectively.

NOTE E – TAX STATUS

The Employer has adopted the Ascensus, LLC Volume Submitter 401(k) Profit Sharing Plan. The Internal Revenue Service has determined by letter dated June 30, 2020, that this prototype plan document satisfies the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore the Plan continues to be qualified and the related trust continues to be tax-exempt.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become one hundred percent (100%) vested in their accounts.

NOTE G – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means;
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Collective investment fund: Valued at the market value of underlying assets.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. Mutual funds are required to publish their daily NAV and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023.

NOTE I – SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. There were no amendments during 2024 and accordingly no material impact to the Plan's 2024 financial statements.
