Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cardiac Study Center, Inc. P.S. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC as of December 31, 2024 and for the period from April 11, 2024 to December 31, 2024, and Vanguard Fiduciary Trust Company as of December 31, 2023, and for the period from January 1, 2024 to April 10, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

NOTE 1. Description of the Plan

The following description of the Cardiac Study Center, Inc. P.S. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General:

The Plan is a contributory defined contribution plan covering all eligible employees of the Sponsor and provides for salary deferrals. Employees are eligible following thirty consecutive days of continuous service. The Plan also provides for matching and profit sharing contributions to all eligible employees of the Sponsor except leased employees and those covered by collective bargaining agreements. Employees are immediately eligible to participate in the Plan upon completion of one year service with at least 1,000 hours and reaching age twenty-one.

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law, which provides both required and optional future enhancements to tax qualified retirement plans and their participants. The provisions of the SECURE 2.0 Act may be effective and operationalized prior to formally amending the Plan document. The Plan has until the last day of the first plan year beginning on or after January 1, 2025 to formally amend the Plan documents. The Plan is implementing the required provisions in accordance with the applicable effective dates and is also continually evaluating the optional provisions.

Contributions:

Upon meeting eligibility requirements, participants are automatically enrolled in the Plan with salary deferrals at 3 percent of eligible compensation unless the participant makes a contrary election with a 1 percent annual, automatic increase up to 6 percent. Each year participants may contribute up to the maximum amount allowed by the Internal Revenue Code of annual compensation as defined in the Plan. Participant contributions may be made as pre-tax or Roth elective deferrals.

The employer may contribute a discretionary matching contribution. This matching contribution for the year ended December 31, 2024, was 75 percent of the participant deferrals limited by 6 percent of compensation as defined by the Plan.

The Sponsor may also contribute an additional amount as a discretionary profit sharing contribution. The discretionary profit sharing contribution is allocated to the participants' accounts on a pro-rata basis, based on eligible compensation. For the year ended December 31, 2024, the Sponsor made a discretionary profit sharing contribution of 4.5 percent of eligible compensation.

Participant Accounts and Investment Options:

Contributions from Plan participants and the related Sponsor's matching contribution and profit sharing contribution are recorded in the year in which the employee contributions are withheld from compensation.

Contributions to participant accounts are deposited into participant directed funds at Vanguard Fiduciary Trust Company through April 10, 2024 and Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC thereafter. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor periodically reviews the investment fund options available to participants and drops or adds investment funds as warranted.

Each participant account is credited with the participant's contribution, an allocation of the Sponsor's contribution, as determined above, accounting earnings, and forfeitures of terminated participant's nonvested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

The participants are 100 percent vested in participant salary deferral contributions and QNEC contributions and the related earnings at all times. Vesting in the Sponsor's matching and discretionary profit sharing contributions and the related earnings is based on years of credited service. Generally, a participant is 100 percent vested after six years of vesting service or upon retirement, death, total disability, or termination of the Plan.

Forfeitures:

Nonvested participant account balances forfeited into the Plan during the years ended December 31, 2024 and 2023 totaled \$102,329 and \$32,804, respectively.

Forfeitures of nonvested account balances are first used to pay Plan expenses. Any remaining forfeitures are available to reduce the Sponsor's contributions. During the year ended December 31, 2024, \$99,612 of forfeitures were used to pay Plan expenses.

Payment of Benefits:

On termination of service a participant with an accrued benefit of \$5,000 or less will receive a lump-sum amount equal to the value of his or her vested account. Terminated participants with an accrued benefit in excess of \$5,000 may leave the funds in the Plan or elect to receive a lump-sum distribution equal to the value of his or her account, an annuity, or a series of payments made over a period of time not exceeding the life expectancy of the participant or the designated beneficiary.

Upon death or disability, a beneficiary or participant will receive 100 percent of their account balance paid.

Pre-retirement and hardship distributions are allowed in accordance with the terms of the Plan.

All distributions are made as soon as administratively feasible after the distribution application is received by the Administrator.

NOTE 2. Summary of Significant Accounting Policies

Basis of Presentation:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America and present the net assets available for Plan benefits and the changes in those net assets.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition:

At December 31, 2024 and 2023, the Plan's investments are held in participant directed accounts at Vanguard Fiduciary Trust Company through April 10, 2024 and Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC thereafter. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Administrative and Investment Management Expenses:

The Plan's expenses are paid either by the Plan or Plan Sponsor, as determined by the trustees, plan document, or service provider agreements. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements and are not intended to be reimbursed by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Date Through Which Subsequent Events Evaluated:

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is September 23, 2025, which is the date on which the financial statements were available to be issued.

NOTE 3. Risks and Uncertainties

The Plan is exposed to market and credit risk due to the various foreign and domestic investment securities that may be selected by the participant in any combination. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of change in net assets available for benefits.

NOTE 4. Information Certified by Custodians

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC as of December 31, 2024 and for the period from April 11, 2024 to December 31, 2024, and Vanguard Fiduciary Trust Company as of December 31, 2023 and for the period from January 1, 2024 to April 10, 2024 as follows:

- Investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest and dividends reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investments reflected on the supplementary Schedule of Assets (Held at End of Year) at December 31, 2024.

NOTE 5. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Fixed Annuities: The Guaranteed Income Fund (GIF) is reported at fair value and not benefit responsive. The fair value of the GIF equals the accumulated cash contributions, interest credited to the Plan's contracts, less any withdrawals and transfers. The GIF is not available for sale or transfer on any securities exchange. However, all of the inputs are generally considered obtainable and observable through the review of existing contracts and readily available financial information . The value is reported daily based on the valuation method disclosed in the annuity contract and there are no unobservable inputs.

NOTE 5. (Continued)

Stable Value Collective Investment Trusts: These funds are Collective Investment Trusts valued at net asset value per unit as calculated by the Fund. This net asset value per unit is determined mostly by the Fund's various underlying investments' value at the close of the New York Stock Exchange each day. While the resulting net asset per unit value is not the same as the underlying investments' value, the financial trend should be the same. In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. The collective trusts have daily redemption frequencies with a five day notice period for redemption.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. Party-in-Interest Transactions and Administration of Plan Assets

The Plan's investment options are held in participant directed accounts at Vanguard Fiduciary Trust Company through April 10, 2024 and Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC thereafter as the custodian of the Plan; therefore, any transaction executed with Vanguard Fiduciary Trust Company through April 10, 2024 and Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC thereafter qualifies as a party-in-interest transaction.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activities to various service providers. These transactions are party-in-interest transactions.

The Plan Sponsor, Cardiac Study Center, Inc., P.S., is a party-in-interest. Certain administrative functions are performed by employees of the Sponsor. No such employee receives compensation from the Plan. The Sponsor has the discretion to appoint or remove any trustee or agent of the Plan. The Trustees have the full power to administer the Plan and apply all of its provisions on behalf of the Sponsor.

NOTE 7. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by Randall & Hurley, Inc. which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. Although the opinion letter is not specific to the Plan, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code; therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no material uncertain tax positions that require adjustment to the financial statements; therefore, no provision or liability for income taxes has been included in the financial statements.

NOTE 8. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.


