### 1. Description of Plan

The following description of the Organogenesis Inc. 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan qualified under Section 401(a) of the Internal Revenue Code (“IRC”) covering substantially all employees of Organogenesis Inc. (the “Company” or “Employer”) who meet the eligibility requirements of the Plan. The Plan became effective on January 1, 1992, for the purpose of providing benefits to participants upon retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Company and the assets of the Plan are held and invested by John Hancock Trust Company LLC (the “Trustee”).

#### ***Eligibility***

Substantially all employees who are 21 years of age and have maintained a three month service requirement are auto enrolled at 3% to participate in the Plan on the first day of the following month in which the service requirement has been met. This auto enrollment rate will increase by one percent every year up to a maximum of 10%. This escalation shall be applied on the first day of every July. Employees who have achieved the other eligibility requirements are eligible to participate in any Company profit-sharing and matching contributions after completing 1,000 hours of service, as defined by the Plan.

#### ***Contributions***

Each year, participants may elect to have a percentage deducted on a pre-tax or Roth basis from their compensation, as defined by the Plan. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Company. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution retirement plans. There is an annual dollar limit as to the amount that can be contributed into the Plan which is determined by the Internal Revenue Service (“IRS”) and adjusted annually.

Under the terms of the Plan, the Company has the option of making both a matching contribution and a profit-sharing contribution. These contributions are discretionary. The Company has elected to only make matching contributions for the year ended December 31, 2024.

### 1. Description of Plan (*continued*)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All Investments are participant directed.

#### ***Vesting***

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon and are immediately 100% vested in amounts representing Employer matching and profit-sharing contributions.

#### ***Forfeitures***

Any balance in the Employer contribution account of a participant who has separated from service, to which he or she is not entitled, can be used to reduce Employer contributions or can be allocated among active participants. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. There were no forfeited nonvested amounts utilized to reduce Employer contributions or allocated among active participants during the year ended December 31, 2024.

#### ***Investment Options***

Participants must direct their salary deferral contributions to various investment options offered by the Plan. Participants may change their investment options at any time.

#### ***Payment of Benefits***

Benefits are paid upon retirement (age 65), age 59 ½, death, disability, or termination of employment. Upon termination of service, a participant's balance may be paid in a lump-sum amount equal to the participant's account balance. Upon termination, if a participant's vested account is \$5,000 or less, the participant will receive the value of his or her account in a single lump-sum distribution.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

#### ***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of the vested account balance or \$50,000 (whichever is less). The loans are secured by the balance in the participant's account and bear interest at the prime rate in effect at the time of its issuance plus 1%. Loan terms range from one to five years, or a maximum of twenty years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Such funds are considered to be actively traded. The common/collective trust is valued using NAV as a practical expedient. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 16, 2025.

### 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, LLC, a qualified institution.

### 5. Common/Collective Trust

The John Hancock Stable Value Fund (the "Fund") is a common/collective trust that preserves capital and provides stability of principal while earning current income that exceeds money market rates over the long term. The Fund invests primarily in diversified fixed income funds and separately managed bond accounts. The fixed income portfolios are managed to provide current income with a AA minimum average credit quality objective.

Units of the Fund are valued each day and the NAV of the Fund is calculated as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit value.

The Fund sells new units and repurchases outstanding units on a daily basis. Unit purchases and redemptions are transacted at the NAV of the Fund as of the close of business each day. The Fund has no unfunded commitments due from the Plan at December 31, 2024.

### **6. Tax Status**

The Company has adopted a pre-approved profit sharing plan. The IRS has issued a letter, dated June 30, 2020, which stipulates that an employer who adopts this volume submitter plan will be considered to have a plan qualified under Section 401(a) of the IRC provided all terms of the Plan are followed. Although the Plan has been amended since receiving the letter, the plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes the Plan is qualified and the related trust is tax-exempt as of the date of the auditors' report.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **7. Plan Termination**

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **8. Party-in-Interest Transactions**

Certain Plan investments are units of mutual funds and a common/collective trust managed by the Trustee, as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
