We have performed audits of the financial statements of Baptist Health Enterprises, Inc. 401(k) Employee Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Baptist Health Enterprises, Inc. 401(k) Employee Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for the Plan's information.

***General***

The Plan is a defined contribution plan covering the employees of Baptist Health Enterprises, Inc. (the "Plan Sponsor" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan became effective April 1, 1993.

***Eligibility and Enrollment***

Employees of the Employer are eligible to participate in the Plan as of the date their employment begins. An employee is automatically enrolled at six percent of eligible compensation, on a pre-tax basis, upon completing 30 days of service. An employee becomes eligible to participate in the allocation of Employer Contributions after the employee completes ninety days of continuous employment. Participants must work at least 1,000 hours during the payroll calendar year and be employed on the last day of the Plan year to receive Employer contributions.

***Plan Administration***

Transamerica Retirement Solutions ("Transamerica" or "Recordkeeper") processes and maintains the records of participant data. State Street Bank and Trust Company is the Plan's trustee ("State Street" or "Trustee"). Transamerica Life Insurance Company ("TLIC") is the custodian of the Transamerica Guaranteed Investment Option investment ("GIO"), and Transamerica Financial Life Insurance Company ("TFLIC") is the custodian of the Insurance Company General Account investment ("ICGA"). State Street is the custodian for all remaining investments within the Plan.

***Contributions***

Participants may contribute up to 100% of their compensation, as defined in the Plan document, as pre-tax or Roth deferrals, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Eligible employees are automatically enrolled in the Plan with a 6% deferral rate (4% for employees hired before January 1, 2015). Eligible employees who do not wish to participate in the Plan may affirmatively elect to opt out, or they may elect a different deferral percentage. If an automatically enrolled employee does not select a particular combination of investments, contributions will be allocated to the T.Rowe Price Fund designated for their projected retirement date.

The Plan provides for an Employer matching contribution. The Employer will match 50% deferrals up to 4% of eligible compensation for eligible participants, as defined in the Plan agreement.

The Plan also provides for a discretionary Employer basic contribution. If elected, the Employer will contribute 3% of eligible compensation for eligible participants, as defined in the Plan agreement during the year. The Employer elected to make a basic contribution for the year ended December 31, 2024.

***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Employer's matching and basic contributions, if any, and applicable earnings or losses, less expenses, of the individual funds in which the account is invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investment Options***

Upon enrollment in the Plan, a participant may direct his or her contributions, plus actual earnings thereon, to be invested in any of the investment options offered by the Plan. Participants may change their investment options daily.

***Vesting***

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Employer's basic and matching contributions, plus actual earnings thereon, is based on three years of service, at which time the participant becomes 100% vested.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the highest outstanding loan balance. With certain exceptions, participants may only have two outstanding loans at any given time. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal on the day the participant applies for the loan. Generally, principal and interest are paid ratably over the term of the loan through payroll deductions.

***Payment of Benefits***

Upon a participant's retirement, termination, disability or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$7,000. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by the Trustee. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 73. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

***Forfeited Accounts***

Forfeitures may be used to reduce Employer contributions. For the year ended December 31, 2024, forfeitures in the amount of \$277,000 were used to reduce Employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$272,084 and \$130,181, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan provides for investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits or the statement of changes in net assets available for benefits.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value except for the TLIC GIO, a fully benefit-responsive investment contract, which is stated at contract value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation of investments is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments and includes gains and losses on investments bought and sold as well as held during the period.

Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

***Administrative Expenses***

Certain expenses to maintain the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

***Benefit Payments***

Benefit payments to participants are recorded upon distribution.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Valued at the closing price reported on the active market on which the individual securities are traded.

*Self-Directed Brokerage Fund* - The Plan's investments in the self-directed brokerage fund are stated at fair value based on quoted market prices.

*Insurance Company General Account* - Primarily consist of cash and short-term money market funds. Valued at cost plus accrued interest, which approximates fair value. The funds have no restrictions from redemption.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

**NOTE 4 - GROUP ANNUITY CONTRACT**

During 2021, the Plan entered into a fully benefit-responsive investment contract with TLIC. TLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. TLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus applicable interest credited, less previous withdrawals or transfers and administrative charges. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. There are no unfunded commitments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

**NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Transamerica and its affiliates; therefore, these transactions qualify as party-in-interest transactions. Certain administrative expenses of the Plan are paid by the Employer. The Plan also has notes receivable from certain of its participants. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 - FEDERAL INCOME TAX STATUS**

The Plan received a favorable determination letter from the Internal Revenue Service ("IRS") dated November 2, 2021, stating that the Plan is designed in accordance with the applicable provision of the IRC. The Plan has since been amended, but the Plan Sponsor and Plan management believe that the Plan is currently designed in compliance with applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
