## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Pride Ag Resources 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Pride Ag Resources 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5—Information Prepared and Certified by Custodian to the financial statements, is complete and accurate.

### Opinion

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. #### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pride Ag Resources 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023

NOTE 1—DESCRIPTION OF PLAN

The following description of Pride Ag Resources 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering all employees of The Dodge City Cooperative Exchange d/b/a Pride Ag Resources (the Cooperative) over the age of eighteen who have met certain service requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan utilizes Section 401(k) of the Internal Revenue Code. As a result, the participants may elect to reduce the amount of compensation actually received by deferring a portion of their compensation and have that deferral amount contributed to the Plan by the Cooperative, not to exceed 100% of the participant's compensation subject to the maximum amount allowable under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Cooperative may contribute as a matching contribution, to be determined by the Cooperative's board of directors within the limits of the Internal Revenue Code, a percentage of the participant's contribution. In addition, the Cooperative may make a discretionary contribution, which would be allocated to the participants on the basis of the individual participant's compensation as a proportion of the total compensation of all participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Cooperative's contribution, if any, (b) Plan earnings, (c) forfeitures of terminated participant's nonvested accounts, and (d) charged with withdrawals and an allocation of Plan losses and administrative fees. Allocations are based on participant compensation and contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals and their employee contributions made with "after tax" dollars. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after five years of service.

Direction of Investments

All investments are participant directed.

### Loan Provision

Loans to participants are permitted. Loan advances must be for a minimum of \$1,000, not to exceed the lesser of \$50,000 or half of the participant's vested account balance. Loans are limited to individuals who experience an event of hardship or financial necessity, which includes loss of income due to the participant's death, illness, or disability, significant medical expenses, or the purchase of a principal residence. The loans are secured by the balance in the participant's traditional 401(k) account and bear a fixed rate of interest equal to the prime interest rate. Principal and interest is paid ratably through payroll deductions. Interest rates for the loans outstanding were between 4.50% to 9.50%.

### Payment of Benefits

On termination of service, if a participant's vested account balance exceeds \$5,000, the Plan has authorized payments to be made in one lump sum or in periodic installments over a number of years. If a participant's vested account balance does not exceed \$5,000, the Plan may distribute to the participant without the participant's consent.

### Forfeitures

Forfeitures of contributions other than matching contributions shall be added to the Cooperative's contribution under the Plan. Forfeitures of matching contributions shall be used to reduce the Cooperative's matching contribution. During the year ended December 31, 2024, \$0 in employer contributions were reduced from forfeited nonvested accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,361 and \$3,448, respectively.

## NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

The Plan investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability and are included in benefits paid to participants.

### Payment of Benefits

Benefit payments to participants are recorded when paid.

### Notes Receivable from Participants

Participant loans are measured at their unpaid principal balances plus any accrued but unpaid interest.

### NOTE 3—DESCRIPTION OF PRIORITIES UPON TERMINATION OF THE PLAN

In the event of termination of the Plan, the interest of all participants become fully vested and nonforfeitable. The employer would distribute all assets as soon as administratively feasible after the date of termination.

### NOTE 4—TAX STATUS

The Plan has adopted a prototype-standardized plan designed to qualify under Section 401(k) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the prototype plan has received an opinion letter dated June 30, 2020, that this Plan is relying on. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provision of the IRC, exempting it from income taxes.

### NOTE 5—SUMMARY OF INFORMATION CERTIFIED BY CUSTODIAN OF PLAN UNDER SECTION 29 CFR 2520.103-8 OF THE DEPARTMENT OF LABOR'S RULES AND REGULATIONS FOR REPORTING AND DISCLOSURE UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974. THE FOLLOWING INFORMATION INCLUDED IN THE ACCOMPANYING FINANCIAL STATEMENTS AND SUPPLEMENTAL SCHEDULE WAS OBTAINED FROM DATA THAT HAS BEEN PREPARED AND CERTIFIED TO AS COMPLETE AND ACCURATE BY THE CUSTODIAN AS OF DECEMBER 31:

The custodian of the Plan held all of the Plan's investment assets and executed transactions therein. Financial information relating to those assets is included in the accompanying financial statements based on information provided by the custodian. The Plan administrator has obtained certification from the custodian, Alerus Financial, N.A., as of and for the years ended December 31, 2024 and 2023, that such information is complete and accurate. ### NOTE 6—RELATED PARTY TRANSACTIONS

The Plan made payments to the custodian, Alerus Financial, N.A., for administrative and investment advisory services rendered to the Plan for 2024 in the amount of \$30,940.

The Plan sponsor absorbs certain significant expenses of administering the Plan, including administrative and recordkeeping costs.

### NOTE 7—FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

**Mutual Funds:** are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Common Collective Trust Funds:** are valued at the NAV as determined by the trustee of such funds based upon the underlying securities stated at fair value. The NAV as provided by the trustee of the fund is used as a practical expedient to estimate fair value.

#### NOTE 8—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 9—SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 8, 2025, the date which the financial statements were available for issue.
