Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kawasaki Motors Corp., U.S.A. Employees' Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kawasaki Motors Corp., U.S.A. Employees' Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kawasaki Motors Corp., U.S.A. Employees' Pension Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Use of Liquidation Basis of Accounting

As further discussed in Note 8 to the financial statements, the company of Kawasaki Motors Corp., U.S.A. Employees' Pension Plan approved to terminate the Plan in December 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting to the liquidation basis of accounting used in presenting the 2023 and 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of Kawasaki Motors Corp., U.S.A. Employees' Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Participating and affiliated employers include Kawasaki Motors Corp., U.S.A. (the "Company" or "AKM"), Kawasaki Motors Manufacturing Corp., U.S.A. ("KMM"), Kawasaki Motors Finance Corporation ("KMFC"), and Kawasaki Precision Machinery U.S.A., Inc. ("KPM").

General

The Plan is a defined benefit pension plan organized by the Company to provide retirement benefits to eligible employees. The Plan was effective on September 1, 1974, and subsequently amended, thereby covering substantially all employees of AKM and KMM provided they have completed one year of service and 1,000 hours of employment. Employees of KMM must receive an Internal Revenue Service ("IRS") Form W-2 from KMM to be eligible for any Plan benefits. Effective January 1988, the Plan was amended to adopt qualified employees of KMFC into the Plan. Effective January 1, 2006, the Plan was amended to adopt qualified employees of KPM into the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective December 31, 2015, the Plan was amended to freeze participation. After December 31, 2015, participants no longer accrue additional benefits.

The Plan sponsor approved a plan to terminate the Plan effective December 31, 2023. See Note 8 for additional discussion on Plan termination.

Administration

The Plan is administered by the pension committee appointed by the board of directors of the Company. The Company's contract administrator is Principal Life Insurance Company ("Principal"). As of December 31, 2024 and 2023, the assets of the Plan are maintained under the custody of Principal.

The board of directors of the Company has the discretion to appoint or remove any committee member, trustee, or agent of the Plan. With consultation from the board of directors, the pension committee has the power to administer the Plan and apply all of its provisions on behalf of the Company.

Pension Benefits and Vesting

A participant becomes 100% vested in benefits upon completion of five years of service with the Company. If employees terminate before rendering five years of service, they forfeit the right to receive the portion of the accumulated plan benefits attributable to the Company's contributions. Upon the determination of the termination of the Plan, subject to Plan provisions, all participants became fully vested. Upon withdrawal from the Plan, employees with five or more years of service are eligible to commence receiving the vested portion of accrued pension benefits beginning at normal retirement age (65) or early retirement age (55). The distributable age 65 benefit calculates at a rate equal to 1 2/3% of the participant's average compensation, as defined by the Plan, multiplied by the participant's years of benefit service, subject to a maximum of 30 years, less 1 2/3% of the participant's Social Security benefit, multiplied by the participant's years of benefit service subject to a maximum of 30 years, multiplied by the participant's earned benefit percentage. Employees may elect to receive any percentage of their benefit in a single-sum payment and the remaining percentage under any other option form described in the Plan agreement. The mandatory minimum distribution limit is \$5,000. Accounts with balances over \$5,000 will remain in the Plan until a terminated participant requests a distribution. Accounts with balances between \$1,000 and \$5,000 or less will be distributed in a direct rollover to an individual retirement plan designated by the Plan administrator. Accounts with balances under \$1,000 will be distributed in a lump-sum payment.

Death and Disability Benefits

If a vested employee dies at age 55 or older, a death benefit equal to 50% of the employee's vested accrued pension benefit at the time of death, with no reduction for early distribution, is paid to the employee's beneficiary. If an active employee dies before retirement, a death benefit may be payable to the employee's beneficiary. See the Plan agreement for a complete description of this provision. Active employees who become totally disabled receive disability benefits at their normal retirement date computed as though they had been employed to a normal retirement age with their annual compensation remaining the same as at the time they became disabled.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan terminated December 31, 2023. As a result, the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023 and changes in net assets available for benefits in liquidation for the year ended December 31, 2024 are presented on the liquidation basis.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, the actuarial present value of accumulated plan benefits at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are measured at quoted prices in an active market and have been certified complete and accurate by Principal, the custodian of the Plan (see Note 6). Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments recorded at fair value consist solely of pooled separate accounts ("PSAs") valued at net asset value ("NAV") as a practical expedient. Accordingly, these investments are excluded from the fair value hierarchy disclosures.

PSAs are valued at NAV which is based on the fair value of the underlying investments of the PSAs, less any liabilities. The underlying investments of the PSAs are mainly equity and fixed income securities and short-term investments. The fair value of the underlying investments is determined using Level 1 or 2 pricing inputs. The investment strategies of the Plan's PSAs vary generally based on the investment objectives of the asset class of which they are a part.

Such investment strategies include investments in fixed income securities and investments in equity securities in domestic and international markets for growth and value objectives as well as to replicate market indexes and to invest in emerging markets. For the Principal U.S. Property Separate Account, the underlying assets of the account consist primarily of mortgage loans and also commercial real estate held by the insurance company. The fair value of the underlying real estate is estimated using discounted cash flow valuation models that utilize public real estate market data inputs such as transaction prices, marketable rents, vacancy levels, leasing absorption, market cap rates, and discount rates. In addition, each property is appraised annually by an independent appraiser. PSAs can be redeemed on a daily basis, and the redemption notice period is daily. The Plan had no unfunded commitments related to PSAs.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits in liquidation. In addition, certain investment-related expenses are included in net depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits in liquidation and are not readily determinable.

Subsequent Events

The Plan's management evaluated subsequent events that occurred after December 31, 2024 through October 1, 2025, the date these financial statements were available to be issued. Other than the event mentioned in Note 8, there were no material subsequent events that required recognition or additional disclosure in these financial statements.

3. Funding Policy

Prior to September 1, 1989, all participants were eligible to, and permitted to, make voluntary after-tax contributions. As of September 1, 1989, only nonhighly compensated participants were eligible to, and permitted to, make employee contributions. Effective September 1, 2001, participants were no longer permitted to make contributions to the Plan.

The Company shall contribute to the Plan such amounts as deemed necessary by a qualified actuarial consultant to fund the benefits provided by the Plan on an acceptable basis in accordance with the funding requirements of ERISA and the IRS. The calculation of accumulated plan benefits is estimated by utilizing beginning of the year information. Any actuarial gains or losses arising from the actual experience under the Plan will be used to adjust future employer contributions and will not be used to change any benefits payable under the Plan. The minimum funding requirements under ERISA have been met in 2024 and 2023.

4. Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than Level 1 prices, such quoted prices for similar assets or liabilities, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

As of December 31, 2024 and 2023, the Plan's investments consisted of PSAs, which are excluded from the fair value hierarchy.

5. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service that employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. The accumulated plan benefits for active employees are based on their average compensation for the five consecutive years out of the ten latest compensation years that gives the highest average as of the date for which the benefit information is presented (valuation date).

The actuarial present value of accumulated plan benefits is determined by an actuary from Principal and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money and the probability of payment between the valuation date and the expected date of payment. In conjunction with the adoption of the liquidation basis of accounting, the Plan changed from using a beginning of year to end of year benefit information date. The change in accounting principle was made in accordance with the liquidation basis of accounting.

6. Information Certified by the Plan's Custodian

No auditing procedures were performed by the independent auditor as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by Principal (the "custodian"), except for comparing such information with the information reported in the financial statements. Based on information provided and certified by the custodian, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of December 31, 2024 and 2023. Accordingly, the custodian of the Plan's assets has certified to the completeness and accuracy of:

- Investments at fair value reflected on the accompanying statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023, as well as the supplemental schedule of assets (held at end of year) as of December 31, 2024.
- Net depreciation in fair value of investments and other income reflected on the accompanying statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024.

7. Adjusted Funding Target Attainment Percentage ("AFTAP")

The Pension Protection Act (the "Act") included many provisions and numerous revisions to rules surrounding defined benefit plans, including rules that govern plan funding. The Act established minimum funding standards for defined benefit plans and limited benefit increases and accruals for underfunded plans. Pursuant to the Act, each year the actuaries are required to certify to the Plan's funded percentage. The Plan received such certification for the 2023 Plan year for the AFTAP, which is one way of measuring the funded status of a plan using actuarial assumptions mandated by the IRS, and the actuary determined that the 2023 AFTAP for the Plan is 104.77%. With the Plan termination date of December 31, 2023, the AFTAP in effect on the termination date continues to apply until assets are distributed.

8. Plan Termination

The Company approved a plan to terminate the Plan effective December 31, 2023. All benefits due to participants under the Plan were distributed to the participants by June 26, 2025.

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, the provisions of the Plan provide that the net assets of the Plan shall be allocated among the participants and their beneficiaries in the order provided for under ERISA, and, to the extent there are unfunded vested benefits other than benefits becoming vested by virtue of termination of the Plan, ERISA provides that such benefits are payable to participants by the Pension Benefit Guaranty Corporation ("PBGC") up to the specified limitations.

The PBGC is a government agency established under ERISA. Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations.

Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination up to statutory limits. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

With the Plan's intent to terminate, its net assets generally will not be available on a pro rata basis to provide participants' benefits. Whether a particular participant's accumulated plan benefits will be paid depends on the priority of those benefits, the Plan's net assets to provide for accumulated benefit obligations, the financial condition of the Plan sponsor, and the level of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then-existing assets and the PBGC guaranty while other benefits may not be provided for at all.

9. Tax Status

The Plan has received a favorable determination letter from the IRS dated December 7, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there has been no tax-related interest or penalties for periods presented in these financial statements.

10. Party-In-Interest Transactions

Certain Plan investments are managed by Principal. Principal is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

In addition, the Plan sponsor, AKM, and affiliated entities, KMM, KMFC, and KPM, are parties in interest. However, there are no transactions with the Plan sponsor other than the funding of contributions to the Plan and the payment of administrative expenses for the Plan.

11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits in liquidation. For the years ended December 31, 2024 and 2023, three investments represented a concentration of greater than 10% of the Plan's assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
