Notes to Financial Statements

Note 1: Plan Description

The following description of the Great Lakes Veneer, Inc. Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution plan covering all employees of Great Lakes Veneer, Inc. (the "Company") who have completed three months of continuous service and have reached the age of 21. Employees are allowed to enter the Plan on the first day of the month following meeting these eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Each year, participants are allowed to contribute to the Plan up to 50% of annual compensation, as defined in the plan document, on a pretax basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect to not participate in the Plan or make an alternate deferral election. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company's matching and profit sharing contributions are discretionary. The Company's discretionary matching formula is 50% of each participant contributions up to 8% of eligible compensation. Rollover contributions are not matched. Participants must be employed on the last day of the plan year in order to participate in the discretionary profit sharing contribution. There was no discretionary profit sharing contribution for 2024.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, and allocations of (a) the Company's discretionary profit sharing contribution and (b) plan earnings or losses and is reduced by withdrawals and an allocation of administrative expenses. Allocations are based on participant's earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Plan Description (Continued)

Vesting

Participants are 100% vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions is based on years of service. Participants vest at a rate of 20% each year beginning with the second year of credited service and become fully vested after six years of service. In addition, participants become fully vested upon death or disability.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one note outstanding at any given point in time. Note terms range from one to five years, except for notes used for the purchase of a primary residence. The notes are secured by the balance in the participant's account or other security if the note is for the purchase of a primary residence. The notes bear a fixed rate of interest determined by the plan administrator based on prevailing market conditions. Interest rates on existing notes ranged from 5.25% to 10.50% at December 31, 2024. Principal and interest are paid through payroll deductions.

Excess Contributions Payable

Contributions in excess of amounts allowed by the IRS during 2024, totaling \$8,798 are recorded as a liability on the statements of net assets available for benefits at December 31, 2024. This amount will be distributed to participants during 2025, and is recorded as a reduction to participant contributions on the statement of changes in net assets available for benefits, as it relates to excess participant contributions.

Contributions in excess of amounts allowed by the IRS during 2023, totaling \$14,887 are recorded as a liability on the statements of net assets available for benefits at December 31, 2023. This amount was distributed to participants during 2024.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability retirement, death, or termination of employment. Participants may elect to receive benefit payments in the form of a lump-sum distribution or in installments. Distributions are allowed in the event of a financial hardship if certain conditions are met. The Plan also allows for in-service distributions upon attaining age 62. In addition, participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching and profit sharing contributions. Forfeited nonvested accounts balance was \$5,703 at December 31, 2024. There were no forfeited nonvested accounts at December 31, 2023. The Company may decide in its discretion how to use forfeitures under the plan document. During 2024, forfeited accounts of \$19,120 were used to pay plan expenses and forfeited accounts of \$4,511 were used to reduce Company discretionary matching contributions.

SECURE ACT 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan. Other administrative expenses are paid by the Company and are excluded from these financial statements. Note and distribution fees are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing. All other administrative expenses are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trusts: Carried at the net asset value ("NAV") of the units of the collective trust, which is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The NAV's share price is quoted on a private market that is not active; however, the share price is based on underlying investments, which are traded on an active market. The funds can be redeemed daily with no redemption restrictions. There were no unfunded commitments as of December 31, 2024 or 2023.

Note 3: Fair Value Measurements (Continued)

Guaranteed interest accounts: The guaranteed interest accounts cannot be sold to a third party; thus, the only option to exit the guaranteed interest accounts is to withdraw or transfer the funds prior to maturity for an event other than death, disability, termination, or retirement. The fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed contract crediting rates. This value represents contributions allocated to the guaranteed interest accounts and held in a general account by Principal Life Insurance Company ("Principal"), plus interest at the contractually guaranteed rate, less funds used to pay benefits and administrative expenses. The guaranteed interest accounts are included in the accompanying financial statements at fair value as they are not fully benefit-responsive. The fair value of the guaranteed interest accounts is reflected in Level 3.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are considered Level 1 investments.

Pooled separate accounts (excluding real estate fund): Carried at NAV or its equivalent and valued as a practical expedient. The NAV is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares. The NAV's share price is quoted on a private market that is not active; however, the share price is based on underlying investments, which are traded on an active market. The funds can be redeemed daily with no redemption restrictions. There were no unfunded commitments as of December 31, 2024 and 2023.

Real estate pooled separate account (U.S. Property Fund): Carried at NAV or its equivalent and valued as a practical expedient. NAV is estimated using discounted cash flow valuation models that utilize public real estate market data, such as transaction prices, market rents, vacancy levels, leasing absorption, market cap rates, and discount rates. In addition, each property is appraised annually by an independent appraiser. The fund can be redeemed daily with no redemption restrictions. There were no unfunded commitments as of December 31, 2024 and 2023.

Note 4: Information Certified by the Plan Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal and Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company, the Custodians of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by Principal. Principal is a Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Principal by the Plan for administrative expenses totaled \$64,934 for the year ended December 31, 2024. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company's discretionary matching and profit sharing contributions.

Note 7: Tax Status

The Plan has adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
