Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sweet Rewards Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of the Sweet Rewards Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Pladis Global (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Fiduciary Committee is responsible for oversight of the Plan. The Plan's Fiduciary Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance.

Contributions

Each year, participants may contribute up to 75% of pre-tax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company makes a match of 100% of the first 5% of eligible compensation that a participant contributes to the Plan, and match 50% after 5% up to 8% of eligible compensation that a participant contributes to the Plan, as defined in the plan document.

The Company may also make an annual additional discretionary matching contribution for those that qualify according to the plan document. The Company did not make an additional discretionary matching contribution for the year ended December 31, 2024. The Company may also make a nonelective annual discretionary contribution for a plan year designated as an Employer Plus Contribution for those that qualify according to the plan document, in an amount equal to a scheduled percentage of eligible earnings and based on a participant's age plus years of service (as defined in the plan document) as of the last day of the plan year. The Company did not make an Employer Plus Contribution based on the 2024 plan year. Participants direct the investment of their accounts into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, allocations of the Company's additional discretionary matching contributions, allocations of Employer Plus Contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants' years of service prior to January 1, 2016, and accounts of employees of Star Brands North America, Inc., and DeMet's Candy Company, LLC, who were hired prior to January 1, 2018, are 100% vested after five years of credited service, with 20% vesting after each year of credited service. Vesting of Company contributions for years of service for employees hired on or after January 1, 2016, will be 20% after one year, 40% after two years, 60% after three years, 80% after four years and 100% after five years. A participant becomes immediately 100% vested in all contributions upon death or disability, regardless of years of service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (not including Employer Plus Contribution value). The loans are secured by the balance in the participant's account. The loan interest rate is commensurate with the interest rate charged by local commercial banks for similar loans, as determined monthly by the Plan's loan policy. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to ten years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's interest in his or her account as provided in the plan document. If a participant's balance exceeds \$7,000, the participant may choose a lump sum payment or an annuity, as permitted by the individual agreements; if the participant's balance is less than \$7,000, the participant must take a lump sum distribution. A participant may elect a hardship distribution if certain criteria is met, as defined in the plan document. Rollover distributions are permitted, as defined in the plan document. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$609,327 and \$420,264, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$39,022 and plan administrative expenses were reduced by \$12,298 from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Recent Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through October 2, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

Guaranteed interest contract: Massachusetts Mutual Life Insurance Company (MassMutual) Fixed Interest Fund Account (the Separate Account), is a commingled separate account created for the purpose of backing the MassMutual Diversified Bond Separate Account Guaranteed Interest Contracts (Diversified Bond SAGIC) issued in connection with deferred compensation, pension, profit sharing or other retirement plans established or maintained by or for a plan sponsor and is only available through a group annuity contract. The Separate Account consists primarily of assets attributable to contract holder deposits into Diversified Bond SAGIC.

The participants of the Diversified Bond SAGIC receive a book value account interest rate that is determined based on anticipated market returns in the Separate Account, in addition to any plan-specific contract charges. Diversified Bond SAGIC participates in the actual performance experience of the underlying securities through a book value account interest rate reset process. This process is structured to provide alignment between the Diversified Bond SAGIC's book value account balance and the actual return of the Separate Account's underlying investments, or the market value account balance. The book value account interest rate is reviewed periodically. Contract value represents contributions plus credited interest less participant withdrawals and fees. Fair value represents the number of units owned multiplied by the separate accounts unit value, which is based on underlying investments.

All bona fide participant-initiated withdrawals, including most benefit payments, loans and transfers to noncompeting investment options, are paid at book values. MassMutual may impose restrictions on frequent trading and values might be paid at fair value or payments may be delayed if the event that produced the withdrawal was employer or sponsor initiated (e.g. termination of contract, layoffs, etc.). Participant transactions are processed on a daily basis. To the extent timing differences exist between the receipt of payment of assets between MassMutual and the Separate Account, a payable or a receivable is established.

MassMutual has the right to fully or partially terminate the contract upon the occurrence of certain events specified in the investment agreement. The average yield and crediting interest rate on the contract at December 31, 2024 and 2023 was 3.55% and 4.18%, respectively.

Changes in Fair Value of Level 3 Assets

The Plan's Level 3 assets had \$262,379 of purchases and \$2,307,417 of sales for the year ended December 31, 2024.

4. Concentrations

As of December 31, 2024, and 2023, the Plan had investments of \$35,297,973 and \$43,142,214, respectively, that were concentrated in three funds in 2024 and four funds in 2023.

5. Information Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company (collectively, Empower or Custodians), has to have certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 and 2023, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

6. Related-Party and Party in Interest Transactions

Certain plan investments are managed by the Custodians, and therefore, these transactions qualify as party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Empower receives revenue from investment fund service providers for services the Empower provides to the funds. This revenue is used to offset certain amounts owed to the Empower for its administrative services to the Plan. If the revenue received by Empower from such investment fund service providers exceeds the amount owed for its services, Empower remits the excess to the Plan's trust on a quarterly basis. The Plan or Company may make a payment to Empower for administrative expenses not covered by revenue sharing.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

The Plan adopted a pre-approved plan offered by Empower. The pre-approved plan received an advisory letter dated November 14, 2022, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
