## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hawaiian Bros 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Hawaiian Bros 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Hawaiian Bros Inc. and HB Payroll LLC (together referred to as the Company). All employees of the Company, excluding union employees and nonresident aliens, are eligible to participate in the Plan provided they have one month of service and have attained age 21. Employees may enter the Plan on the first day of each month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Ascensus, LLC provides recordkeeping services to the Plan and is the custodian of the Plan's investments. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. Certain members of management serve as the Plan's trustees.

**Contributions**

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Also, participants are permitted to transfer the vested portion of their accounts to an in-plan Roth transfer account subject to the Plan's provisions.

The Plan provides a safe harbor matching contribution which is determined as a percentage of participant elected deferrals. The Company contributes 100% of deferrals up to 3% of eligible compensation and 50% of deferrals above 3% and up to 5% of eligible compensation.

The Company may also make discretionary additional matching contributions not to exceed 4% of eligible compensation. In addition, the Company may make a discretionary profit sharing contribution. Profit sharing contributions are allocated to each participant based upon a formula determined by the Company as each participant is in her or her own allocation group. Participants must be employed by the Company on the last day of the Plan year and have a minimum of 1,000 hours of service during that Plan year in order to receive a profit sharing contribution. No discretionary additional matching contributions or profit sharing contributions were made for 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and safe harbor matching contributions, as well as discretionary additional matching contributions and allocations of the Company's profit sharing contribution, and investment earnings (losses) based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Loans**

Participants may not borrow from their accounts.

**Vesting**

Participants are vested immediately in their contributions and safe harbor matching contributions. Vesting in the discretionary additional matching and profit sharing contributions portion of their accounts is based on years of service. After two years of service, a participant becomes 20% vested in employer contributions in the Plan; the vesting increases by 20% each year. A participant is 100% vested after six years of credited services, or upon reaching plan retirement age of sixty-five, death, or disability.

**Payment of Benefits**

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump-sum amount or in installments for participants or beneficiaries who may receive required minimum distributions. The account of a participant with a vested account balance less than \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from pre-tax and Roth accounts only and are subject to plan provisions as well as specific statutory and regulatory requirements.

In-service distributions are permitted from all vested accounts when a participant has attained age 59½ and are subject to plan provisions.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Contributions and Contributions Receivable**

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Plan expenses primarily consist of plan administration fees. Fees related to the administration of benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**Subsequent Events**

Subsequent events were evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — INFORMATION CERTIFIED BY THE CUSTODIAN**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as authorized representative of Ascensus Trust Company and Newport Trust Company, LLC.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

**NOTE 5 — TAX STATUS**

As this Plan is a pre-approved defined contribution plan, the IRS issued an opinion letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the IRS for the statutory period.

**NOTE 6 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

**NOTE 7 — PARTY-IN-INTEREST TRANSACTIONS**

The Newport Group, Inc. provides recordkeeping services to the Plan. Creative Planning is the investment advisor of the Plan. Total fees paid from the Plan to these entities for plan administration for the year ended December 31, 2024 were \$20,108. These transactions qualify as party-in-interest transactions.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 — DELINQUENT CONTRIBUTIONS**

During the year ended December 31, 2024, the Company failed to remit to the Plan's custodian within the period prescribed by the Department of Labor's regulations employee contributions totaling \$42,590. The Company intends to correct this prohibited transaction by restoring the affected participants' accounts for potential lost income.

**NOTE 9 — DELINQUENT CONTRIBUTIONS (Continued)**

During the year ended December 31, 2023, the Company failed to remit to the Plan’s custodian certain employee contributions totaling \$22,253. Although remitted in 2023, the Company failed to remit to the Plan’s custodian certain employee contributions totaling \$63,481 within the period prescribed by the Department of Labor’s regulations for a total of \$85,734 late remittances in 2023. The Company remitted \$22,182 and \$71 of the missed employee contributions in June 2024 and August 2025, respectively. The Company intends to fully correct these prohibited transactions by restoring the affected participants’ accounts for potential lost income.

During the year ended December 31, 2022, the Company failed to remit to the Plan’s custodian within the period prescribed by the Department of Labor’s regulations employee contributions totaling \$38,861. The Company intends to correct this prohibited transaction by restoring the affected participants’ accounts for potential lost income.

During the years ended December 31, 2022, 2021 and 2020, the Company identified certain operational errors related to the definition of compensation. The Company self-corrected the errors on January 6, 2025 by making corrective contributions to the affected participants' accounts for the missed deferrals and associated missed safe harbor match plus lost earnings. As a result, the employer has recorded an employer corrective contribution receivable on the statements of net assets available for benefits in the amount of \$119,567 and \$57,660 at December 31, 2024 and 2023.
