We have performed audits of the financial statements of AMMEGA 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

The following description of AMMEGA 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by AMMEGA US Inc. (“Company”) for the benefit of its employees age 18 or older with at least one month of service, except those who are covered by a collective bargaining agreement or leased employees.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Empower Trust Company, LLC serves as Plan trustee.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan has an automatic enrollment feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature increases by 1% each year on January 1, up to a maximum of 10%.

For the years ended December 31, 2024 and 2023, the Company contributed a safe harbor contribution equal to 100% of each participant’s elective deferrals not exceeding 1% of the participant’s compensation, plus 50% of each participant’s elective deferrals in excess of 1% but not in excess of 6% of the participant’s compensation.

Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available included various mutual funds and a common collective trust fund. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Effective November 1, 2023, the Plan was amended to provide for a self-directed brokerage account option for its participants.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant’s account. Interest on the loans is 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of their account. Following severance from employment, the Plan will make a mandatory distribution of any account with a vested balance less than \$5,000. Balances less than \$1,000 are paid direct to the participant. Balances between \$1,000 and \$5,000 are paid to an IRA in the participants' name. Partial distributions are allowed in accordance with the provisions of the Plan Document.

Vesting

Participants are immediately vested in their voluntary contributions, including Roth deferrals and catch-up contributions, as well as prior safe harbor contributions, plus earnings thereon. Participants vest in the employer's contribution portion of their accounts plus earnings thereon based on a two-year cliff vesting schedule with the following exceptions.

For employees of the former Megadyne America LLC 401(k) Profit Sharing Plan (merged into the AMMEGA 401(k) Plan effective January 1, 2021), prior nonelective contributions are subject to a six-year graded vesting schedule. Merging employer match balances in the Megadyne America LLC 401(k) Profit Sharing Plan made prior to January 1, 2021, will be 100% vested at all times.

For employees of the former Ammeraal/Chemprene 401(k) Plan (merged into the AMMEGA 401(k) Plan effective January 1, 2021), employer matching and nonelective contributions are subject to a three-year cliff vesting schedule. Prior employer matching and nonelective contributions for participants of the Ammeraal/Chemprene 401(k) Plan will be 100% vested at all times.

Any nonvested balance is forfeited upon termination of service. Forfeitures may be used to reduce Company contributions or pay Plan expenses.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$149,226 and \$19,198, respectively. These accounts will be used to pay administrative expenses or reduce employer contributions. Also, in 2024 and 2023, \$78,317 and \$74,591 of forfeited nonvested accounts were used towards administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Mutual funds and the self-directed brokerage accounts are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan also holds an interest in a common collective trust fund, which is valued daily utilizing the values of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits and related disclosures at December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying Schedule of Assets (Held at End of Year) at December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets

If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. There were no Level 2 or 3 investments identified.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons.

Certain Plan investments are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement Plan Document sponsored by Great-West Trust Company, LLC. This prototype Plan Document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.
