Note 1 - Plan Description

The following description of Orthopaedic & Spine Center of the Rockies, PC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on September 1, 1970 and was organized as a money purchase pension plan. Effective January 1, 2021, the money purchase plan was amended and restated as a 401(k) profit-sharing plan. The Plan is available to all employees age 21 years or older who have completed one hour of service per month during three consecutive months, excluding per diem employees. The entry date for eligible participants is the first day of each month after obtaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

Orthopaedic & Spine Center of the Rockies, PC (the "Company") administers the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) serves as trustee, manages plan assets, and maintains the Plan's records. Plan participants are offered a variety of investment options through various mutual funds, common collective trust funds, pooled separate accounts, and self-directed brokerage accounts. Individual accounts are invested in the various investment options at the direction of the participants.

The Plan offers participants the choice to self-direct their investment elections outside of the mutual funds, common collective trust funds, and pooled separate accounts offered under the Plan within the investment policies established by the plan investment committee. This alternative allows participants to invest their balances in any investment desired within specified limitations.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employee contributions to the Plan are made through regular payroll deductions. Employees are automatically enrolled in the Plan upon meeting eligibility requirements at a deferral rate equal to 3 percent of eligible compensation unless the employee opts out of participating or elects a different percentage.

The Company may make discretionary profit-sharing contributions and discretionary matching contributions on an annual basis. Employees are eligible to receive profit-sharing contributions if they are employed on the last day of the plan year and have completed six months or 1,000 hours of service during the plan year. Employees are eligible to receive matching contributions, not to exceed 6 percent of the participant's eligible compensation. The entry date for eligible participants is the first day of the year after obtaining eligibility. During 2024, the Company contributed \$2,866,164 of discretionary profit-sharing contributions. During 2024, the Company did not make any discretionary matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are 100 percent vested in their voluntary contributions and allocated earnings or losses thereon.

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 60 or, if later, the fifth anniversary date of the first day of the plan year during which the participant entered the Plan) while an employee, retirement due to disability, or termination of the Plan.

Participant Notes Receivable

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of one loan outstanding at any given time. The notes receivable are secured by the balances in the participants' accounts; bear interest at rates ranging from 5.25 to 10.50 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at loan origination; and mature at various dates through May 2030. Principal and interest are paid ratably through payroll deductions. Participant notes receivable are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Upon termination of a participant from employment, the participant's note receivable shall continue to be payable in accordance with the provisions of the participant's note receivable or be due in full.

Benefit Payments

Upon death, disability, or retirement, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a lump-sum payment in the amount equal to the participant's vested account balance. In the case of termination of service, a participant may also elect to receive a monthly, quarterly, or annual payment. In the event that the participant's balance is less than \$1,000, a distribution will automatically be made in cash. If the participant's balance is greater than \$1,000 but less than \$5,000, the vested account balance will be distributed to an individual retirement account established for the participant unless otherwise directed. Benefits are recorded when paid.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Participants who are granted a hardship withdrawal are not allowed to make contributions for the six months following such withdrawal. The Plan allows in-plan Roth conversions. The Internal Revenue Service (IRS) has required minimum distributions once a participant reaches age 70½ during the previous plan year and is no longer employed by the Company.

Forfeitures

If, at the time of termination of employment, the participant is not 100 percent vested, the nonvested portion (forfeitures) of the participant's account shall be placed in a separate account. Forfeitures can be used to reduce employer contributions and pay plan expenses.

Note 1 - Plan Description (Continued)

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Principal or its affiliates. Principal is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common/collective trust funds and pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Administrative Expenses

Various administrative costs are paid by the Company.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 26, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Principal holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and the supplemental schedule of assets held at end of year are based solely on information certified by Principal.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the IRS indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
