NOTE 1 - PLAN DESCRIPTION

Nature of the Plan

The following description of the Axient 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering all employees, as defined in the Plan, of Axient, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for oversight of the Plan.

The Plan was originally effective January 1, 1993 with an effective restatement date of November 1, 2022. Effective December 31, 2020, the Plan was amended to permit employees of Systems Engineering Group to participate in the Plan. Effective November 1, 2022, the Plan was restated and the Plan name was changed from Quantitech, Inc. 401(k) Retirement Plan to the Axient 401(k) Plan. Effective January 1, 2022, the Plan was amended to permit employees from Millennium Engineering and Integration, Co. and Dynamic Concepts, Inc. to participate in the Plan.

Eligibility

To be eligible to participate in the Plan, the participant must be considered an employee and have reached the age of 21 or older. Ineligible employees include any individual who is covered by a collective bargaining agreement, unless the agreement requires the employee be included under the Plan, leased employees, and nonresident aliens who do not receive any earned income from the Company which constitutes United States source income.

Contributions

Participant Salary Deferral - Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, up to maximum amounts established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participant Roth Deferral - Participants may designate some or all of the salary deferral as a Roth Deferral at the time the participant makes his or her deferral election. Once made, the election is irrevocable (that is, a Roth Deferral cannot later be re-characterized as a pretax salary reduction). The amount of the Roth Deferral is included in participants' income for tax purposes, and the income tax withholding amounts are deducted from the remainder of compensation, not from the Roth Deferral amount.

Contributions - Continued

Employer Discretionary Match - Each payroll period, the Company makes discretionary, matching contributions to participants. The discretionary employer match varies by defined groups. Employees in the General and Tech Groups, including the Weapons Systems Group and Systems Engineering employees, receive discretionary employer match in an amount equal to 100% of the first six percent of eligible compensation contributed to the Plan as deferral contributions. Employees in the Services and Technical Support Systems Groups receive discretionary, matching contributions in an amount equal to 50% of the first five percent of eligible compensation contributed to the Plan as deferral contributions. Additionally, each quarter, the Company makes a discretionary, matching contribution to eligible participants in the Tech Group in an amount equal to 100% of eligible compensation contributed to the Plan on deferral contributions six percent and greater, in one percent increments, up to ten percent. Dynamic Concepts, Inc. employees receive discretionary, matching contributions in an amount equal to 100% of the first five percent of eligible compensation contributed to the Plan as deferral contributions and an additional non-elective employer contribution of five percent of eligible compensation quarterly.

Employer Discretionary Profit Sharing - The employer may elect to make a discretionary, nonelective contribution in an amount to be determined by the Board of Directors for each Plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their individual accounts and in their portion of the employer match and profit sharing contributions.

Investment Options

Upon enrollment in the Plan, a participant may direct their account balance among a diversified mix of investment options available to the Plan. Participants may make changes in their investment elections at any time.

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate. For the year ended December 31, 2024, interest rates on outstanding loans ranged between 3.25% and 8.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Forfeitures

Forfeitures are retained in the Plan and may first be used to pay administrative expenses or to reduce future employer contributions. Forfeitures available for use at December 31, 2024 and 2023 totaled \$29,223 and \$34,973, respectively. \$31,313 in participant forfeitures were incurred related to withdrawals that were not fully vested relating to the Axient 401(k) Plan during 2024.

Hardship Withdrawals

Participants are allowed withdrawals in the event of hardship due to immediate and heavy financial need as permitted by the U.S. Treasury regulations.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation of fair value of investments. Administrative expenses recorded in the Plan represent loan fees and other recordkeeping fees paid directly from the Plan to the Plan's Trustee.

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentration of Market Risk

At December 31, 2024, approximately 12% of Plan's net assets were invested in one registered investment. The underlying value of the investments are dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the common collective trusts and their investment holdings in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought, sold, and held during the year. Realized gains and losses from security transactions are reported on the average cost method.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Fair Value

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 for financial assets and financial liabilities are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Payment of Benefits

Benefit payments to participants are recorded when paid. At December 31, 2024, distributions totaling \$32,056 have been requested by participants but have not been paid.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, Charles Schwab Trust Bank, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate.

- Investments at fair value and contract value and notes receivable from participants included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, interest on notes receivable from participants, and net appreciation in fair value of investments, included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, included in the supplemental information.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

NOTE 4 - FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 or 2023.

Money market funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Unit investment trusts: Valued at the daily closing price as reported by the trust. Unit investment trusts held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The unit investment trusts held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the net asset value per share/unit reported at the close of every business day.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

In 2017, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Company (Standard). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 totaled \$7,537,638 and \$8,509,889, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.00%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Standard. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include: (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - RELATED PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were held in shares of mutual funds which were managed by Charles Schwab Bank during the year ended December 31, 2024. Charles Schwab Trust Bank was the Trustee as defined by the Plan for the year ended December 31, 2024, therefore, these transactions qualify as permitted party-in-interest transactions. Fees paid by the Plan to Charles Schwab Trust Bank totaled \$277,414 for the year ended December 31, 2024.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. As participants are fully vested in all contributions, there would be no effect on the Plan vesting schedule.

NOTE 9 - TAX STATUS

The IRS has determined and informed the Plan sponsor, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related Trust is tax-exempt.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained upon examination by the tax authorities.

The Company has concluded that as of December 31, 2024 and 2023, the Plan had no significant uncertain tax positions or material amounts of unrecognized tax benefits that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.

NOTE 10 - CONTINGENCY

On July 15, 2024, the Plan received a notice from the Department of Labor stating an investigation would be conducted to determine compliance with Title I of the Employee Retirement Income Security Act (ERISA). As of the date the financial statements were available to be issued, the outcome of the Department of Labor investigation is unknown.

NOTE 11 - SUBSEQUENT EVENT

Effective June 3, 2025, the Plan transferred substantially all of their assets to Fidelity Management Trust Company.
