Independent Auditors' Report

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the BombBomb, Inc. 401(k) PS Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Years Ended December 31, 2024 and 2023

1. Plan Description

The following description of BombBomb, Inc. 401(k) PS Plan & Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement and related union agreements, if applicable, for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 2013. The Plan covers all employees of BombBomb, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

Trustee, recordkeeping, and investment management services are performed by Ascensus, LLC, an affiliate of Ascensus Trust Company (“Trustee”).

The Plan is administered by the Administration Committee, The Administration Committee may retain independent advisors and consultants, and is responsible for administration and for managing the Plan’s activities. The Company appoints members of the Investment Committee and the Investment Committee reviews and selects the investment fund options offered under the Plan.

Eligibility

Eligible employees, which exclude collectively bargained employees and non-resident aliens, as defined by the Plan Document, may become a participant in the Plan on the first day of the month following the attainment of age 21 and one consecutive month of service, as defined in the Plan document.

Contributions

The Plan automatically enrolls eligible employees at a 3% deferral rate. Participants may contribute up to 100% of their annual compensation during the Plan year or the maximum allowed by the IRC, \$23,000 and \$22,500 for the Plan years ended December 31, 2024 and 2023, respectively. In addition, eligible employees age 50 and over may contribute “catch-up” contributions of \$7,500 in 2024 and 2023. The Plan provides for discretionary Company matching contributions of participants’ elective deferral contributions.

The Plan allows for the Company to make additional contributions to the Plan in the form of a non-elective profit-sharing contribution. For the Plan year ended December 31, 2024, there were no profit-sharing contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contribution, and (b) Plan earnings. All participants may direct the trustee as to the investment of their individual account balances. Allocations are based on participant earning or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to 50% of the vested value of the participant’s account, provided the total of all loans outstanding at any one time does not exceed \$50,000 reduced by the highest loan balance during the one-year period preceding the application for this loan. Participants may only have one loan outstanding at any one time. The loans are secured by the balances in the participant’s account. The loans bear interest at rates commensurate with local prevailing rates at the date of issuance, as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. The interest rates were 8-8.5% for loans outstanding as of December 31, 2024.

1. Plan Description (continued)

Vesting

Participants become vested in participant deferrals and all Company contributions upon enrollment in the Plan.

Benefit Payments

A participant's vested interest in the Plan's assets is distributable generally upon termination, disability, retirement or death. Participants may withdraw from their individual accounts pursuant to the specific guidelines as set forth in the plan document.

Investment Options

As of December 31, 2024, the Plan's assets are invested in cash and twenty five registered investment companies which individually invest in common stocks, bonds and mortgages, international stocks, government securities and small company stocks. Participant contributions, which are voluntary, and employer contributions may be invested in any of the investment options at the employees' discretion.

2. Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and in accordance with generally accepted accounting principles. The financial statements present the net assets available for benefits and changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.

Years Ended December 31, 2024 and 2023

2. Significant Accounting Policies (continued)

Investment Valuation

The Plan's investments are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the plan at year end. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses include recordkeeping fees, Trustee fees, audit fees, account maintenance fees and legal fees. Participant loan origination fees are included in administrative and other expenses in the Statements of Changes in Net Assets Available for Benefits and deducted from participant's accounts as they are paid directly by the participants to the Trustee.

3. Certified Investment Information

In accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Plan administrator has received a certification from Ascensus Trust Company as to the accuracy and completeness of certain financial information of the Plan.

- Investments as shown in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023;
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Schedule of Assets (Held at End of Year) – December 31, 2024, as shown on the Supplemental Schedule.

4. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination, participants may elect to receive a lump-sum amount equal to the vested value of his or her account. Terminated employees' contributions, as well as vested employer contributions, are available for distribution as soon as is administratively possible after receipt of the distribution request.

5. Tax Status

The trust established under the Plan to hold the Plan's assets is intended to be qualified pursuant to the appropriate section of the Internal Revenue Code. The current amended and restated Plan was adopted January 1, 2018. The Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

6. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Related parties and parties-in-interest include the Plan Sponsor, employees of the Plan Sponsor who are owners, directors, executives or members of the investment committee, the third-party administrator, the asset custodian, the investment advisor and the independent auditor. Certain Plan investments are managed by The Vanguard Group, the Plan's investment manager. Therefore, these transactions qualify as party-in-interest transactions. In addition, fees paid to The Vanguard Group are considered party-in-interest transactions. Management has determined that none of the transactions with these parties noted above were prohibited transactions.

8. Subsequent Events

The Company has evaluated events subsequent to December 31, 2024 through September 22, 2025, which is the date the financial statements were available to be issued. There have been no material events noted in this period which would impact the results reflected in this report, the Plan's results going forward or require additional disclosure.
