Opinion

Note 1 - Description of Plan

The following description of the Ramaker & Associates, Inc. Employee Stock Ownership Plan (“Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

Ramaker & Associates, Inc. (“Company”) established the Plan effective January 1, 2007. The Plan operates as an Employee Stock Ownership Plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended.

The Plan covers all employees of the Company who have completed the eligibility requirements including the completion of 1,000 hours of credited service, and attainment of age 18. An eligible employee will begin participation on the first day of the Plan month following the completion of the eligibility requirements.

The Plan is designed to invest primarily in securities issued by the Company and is authorized to borrow money for such investments. Company stock purchased with the proceeds of a loan will be held in a suspense account pending release and reallocation to Company stock accounts as the loan is paid. As of December 31, 2024 and 2023, the Plan had no outstanding loans used to acquire Company stock. All stock held by the Plan is allocated to Plan participants.

Contributions

The Company may contribute to the Plan annually in amounts as determined by the board of directors of the Company. Contributions may be in the form of whole shares of stock or cash. Contributions for each year are never less than the amount required to enable the Plan to discharge its current obligations, without regard to whether some or all of such contribution may fail to qualify for an income tax deduction by the Company. In order to receive an allocation of Company contributions, a participant must be an eligible plan participant and be employed on the last day of the Plan year unless termination is due to death, disability, or normal retirement. Contributions by Plan participants are not permitted by the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

The Plan is a defined-contribution plan under which separate individual accounts are established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released into the Plan, repurchases from participants, forfeitures of terminated participants' nonvested accounts and plan earnings. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation as limited by the applicable regulations under the IRC.

Forfeited Accounts

Forfeitures of terminated nonvested account balances allocated to remaining participants at December 31, 2024 and 2023 consisted of 564 and 747 shares of Company common stock with an estimated fair value of \$5,491 and \$11,226, respectively. Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year.

Put Option

Under federal income tax regulations, the common stock of the Company that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Plan, or the Company by transfer, buy any shares of Company stock distributed to participants for which there is no market. The put price is representative of the estimated fair market value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

Payment of Benefits

In the event of normal retirement, death, or permanent disability, a participant is entitled to receive the entire amount credited to the participant's account. If employment is terminated for any other reason, a participant is entitled to the vested portion of the account.

Vesting

Vesting of participant's accounts is based on years of credited service with the Company. A participant's account becomes fully vested after six years of credited service with the Company, under a graduated vesting schedule. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in common stock of the Company into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation service in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage increases to 50 percent.

Voting Rights

Each participant is entitled to direct the Plan trustee as to the manner in which voting rights of the shares of the Company's stock which are allocated to the participant's account are to be exercised with respect to any corporate matter which involves the voting of the Company's stock with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business or such similar transaction. The board of directors of the Company will direct the Plan trustee with respect to the voting of the Company's stock in all other matters.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP"). The financial statements and supplemental schedules have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investment Valuation and Income Recognition

The shares of the Company's common stock are valued at estimated fair value. See Note 4 for discussion of fair value measurements. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividend income is accrued on the ex-dividend date.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefits Paid to Participants

Benefits are recorded when paid to participants.

Administrative Expenses

Usual and reasonable expenses of the Plan are paid in whole or in part by the Company. Any expenses not paid by the Company may be paid by the Plan. Expenses paid out of the Plan can be allocated to individual participant accounts in accordance with nondiscriminatory rules established by the board of directors of the Company. No administrative expenses have been paid by the Plan for the year ended December 31, 2024.

Note 3 - Investments

The Plan's investment in Company securities consists of shares of the outstanding common stock of the Company. The shares were acquired on various dates at an average price of \$18.04 per share at December 31, 2024 and 2023, which was the estimated fair market value, as determined by independent appraisals, as of the period purchased. The estimated fair market value, as determined by independent appraisal as of December 31, 2024 and 2023 was \$9.73 and \$15.03 per share, respectively.

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

Level 1 - which refers to securities valued using unadjusted quoted prices from active markets for identical assets;

Level 2 - which refers to securities not traded on an active market but for which observable market inputs are readily available; or

Level 3 - which refers to securities valued based on significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value:

Common stock of the Company – shares valued at fair value based on an independent third-party appraisal. This appraisal is based upon a combination of income, market and asset valuation techniques. The appraiser took into account historical and projected cash flow and net income, return on assets, comparable company stocks and estimated fair value of Company’s assets and liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Party-In-Interest Transactions

The Plan's assets, which consist primarily of common stock of the Company, are held by Acumen Advisory Services, LLC ("Acumen"), the Plan trustee. Company contributions are managed by Principal Trust Company ("Principal"), the Plan custodian, who invests cash received, dividends and other income, and makes distributions to participants.

The Plan invests in the Company's common stock, which is considered a party-in-interest transaction. As the Company is the Plan sponsor, transactions involving the Company's common stock qualify as party-in-interest transactions. The board of directors of the Company authorized discretionary Company contributions of cash totaling \$344,633 and \$415,000 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6 - Risks and Uncertainties

The Plan invests in investment securities, including the common stock of the Company. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, and uncertainties inherent in the estimations and assumption process of the common stock of the Company, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Note 7 - Tax Status

The IRS has determined and informed the Company in a letter dated May 11, 2017, that the Plan and related trust are designed in accordance with the applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

Note 8 - Subsequent Events

Management has evaluated subsequent events through September 2, 2025, which is the date the financial statements were available to be issued.
