## Notes to Financial Statements

---

### Note 1: Plan Description

The following description of Asphalt Specialties Co. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of Asphalt Specialties Co. (the "Company") who have completed two months of service and are not a non-resident alien or a resident of Puerto Rico. An employee must have completed one year of service and be employed on the last day of the plan year in order to receive the Company's discretionary matching and nonelective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company is the plan administrator and is responsible for oversight of the Plan. An executive officer of the Company serves as the trustee and Standard Insurance Company ("Standard") serves as the custodian and recordkeeper. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance. USI Advisors, Inc. serves as investment advisors to the Plan.

#### Contributions

Each year, participants may contribute pretax compensation or roth contributions up to the annual maximum allowed by the Internal Revenue Service (IRS) (\$23,000 in 2024). The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, with a 1% increase annually beginning in 2025, until 5% is reached. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company may, at its discretion, make matching and nonelective contributions in an amount to be determined each plan year, and allocated according to the Plan. For the year ended December 31, 2024, the Company made matching contributions of \$331,120, equal to 2.5% of an employee's eligible compensation, which is recorded as a receivable from the Company as of December 31, 2024. The Company did not make any discretionary nonelective contributions during the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions, and allocations of plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Note 1: Plan Description (Continued)**

#### **Vesting**

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings (losses) thereon is based on years of continuous service. A year of service is credited for which 1,000 hours or more are worked in a plan year. A participant vests at 20 percent per year and is 100 percent vested after five years of credited service.

#### **Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. Those participants who are auto-enrolled are invested in the default option. The Plan currently offers various mutual funds held in pooled separate accounts and a guaranteed investment contract as investment options for participants. Participants may change their investment options at any time.

#### **Payment of Benefits**

Upon termination of service due to death, disability, retirement, or other reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals.

Hardship withdrawals are available if the participant meets certain criteria. In addition, in-service distributions are allowed if age 59 1/2, subject to plan provisions.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, the balance of the forfeited accounts totaled \$1,831 and \$-0-, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan. During the year ended December 31, 2024, plan administrative expenses were reduced by \$4,793 from forfeited nonvested accounts.

#### **The Secure 2.0 Act**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments in mutual funds held in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. See Note 4 for discussion of fair value measurements.

The Standard Stable Asset A account is fully benefit-responsive investment contract and is stated at contract value, which is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### **Excess Participants' Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024 and 2023, Excess Participants' Contributions Payable were \$24,422 and \$35,337, respectively. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

#### **Subsequent Events**

Subsequent events have been evaluated through September 17, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Information Prepared and Certified by the Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard, the custodian of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments held, as reported in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income from guaranteed investment contract as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- All investment information included in the Supplemental Schedule – Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Accordingly, at the request of the plan administrator, this information has not been audited by the Plan's independent auditors, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **Note 4: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets in active markets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

**Pooled Separate Accounts:** Fair value of pooled separate accounts are based on quoted net asset values of the underlying mutual fund investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds in the pooled separate accounts are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5: Fully Benefit-Responsive Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract (FBRIC) with Standard. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024 and 2023, the FBRIC's contract value was \$705,377 and \$479,037, respectively.

The investment contract held by the Plan is a traditional guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate, that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting.

### **Note 5: Fully Benefit-Responsive Investment Contract with Insurance Company** (Continued)

The Plan's ability to receive amounts due in accordance with the FBRIC is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events, such as the premature termination of the contract by the Plan, partial or total termination of the Plan, divestitures, layoffs, and the liberalization of plan withdrawal or transfer rules may limit the Plan's ability to transact at contract value with Standard.

Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, and plan disqualification.

No events are probable of occurring that would limit the Plan's ability to transact at contract value with the Plan participants or issuers.

### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Standard, the custodian of the Plan investments and third party administrator, provided custodial and recordkeeping services, and USI Advisors, Inc. provided investment advisory services to the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment. For the year ended December 31, 2024, the Plan made direct payments of \$37,979 to these parties which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 8: Tax Status**

The Company adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
