INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Baird Holm LLP Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Baird Holm LLP Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE A - DESCRIPTION OF PLAN

The following description of the Baird Holm LLP Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan has been amended as of February 15, 2018.

General. The Plan is a defined contribution plan and is administered by Baird Holm LLP (Firm). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan contains both profit sharing and 401(k) components with different eligibility requirements. Under terms of the Profit Sharing Plan, employees, owners or partners of the Firm who have completed at least one (1) year of service with 1,000 hours, received compensation for services as a salary or wage or as earned income, and are at least twenty-one (21) years of age, are eligible to participate in this Plan on the entry date following completion of the eligibility requirements. The entry dates for the profit-sharing component are January 1, April 1, July 1, and October 1. Under terms of the 401(k) Plan, employees, owners or partners of the Firm who have completed one (1) month of service, received compensation for services as a salary or wages or as earned income, and are at least twenty-one (21) years of age, are eligible to participate in the Plan's Section 401(k) arrangement on the first day of the month following one (1) month of service.

Any individual included in a unit of employees covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith bargaining shall not be entitled to participate in this Plan.

The Plan's fiscal year end is December 31. The Plan was established July 1, 1970.

Participant Accounts. Each participant's investment account is credited with the participant's voluntary contribution, employer's contribution and an allocation of Plan earnings. Allocations of earnings for each fund type are pro rata based on the participant's account balance invested in each fund type. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Employee Contributions. Subject to Internal Revenue Service limitations, participants may reduce compensation by any percentage or dollar amount not exceeding one hundred percent (100%) of compensation, as reduced by applicable employment taxes required to be withheld from the participant's compensation. All participants who are eligible to make salary reduction contributions under this Plan and who have attained age 50 before the close of the Plan Year shall be eligible to make catch-up salary reduction contributions in accordance with, and subject to the limitations of the Code.

Employer Contributions. For the plan year ended December 31, 2024, the Firm contributed an amount equal to the greater of (a) 3% of annual wages for employees who became eligible during the Plan year, or (b) 5.1% of each participant's eligible compensation, subject to an annual compensation limit of \$345,000, plus (c) an additional 5% for participants whose income exceeded \$134,881.

The Plan was amended, effective January 1, 1987 to allow participants to make salary reduction contributions to the plan pursuant to Section 401(K) of the Code. The Plan was amended, effective February 15, 2018 to allow participants to defer salary amounts after 30 days of employment beginning with the next monthly entrance date. Most recently, the Plan was amended, effective January 1, 2022 to allow partners to contribute based on the New Comparability Formula method. This method allows partners over the age of 40 to contribute up to 13.182% of their earnings and partners under the age of 40 to contribute up to 8% of their earnings. There was no change for any of the employee eligible participants.

Vesting. Participants are immediately vested in their rollover or transfer, voluntary contributions plus or minus any earnings or losses thereon. The vested right of a participant to amounts allocated from the employer's contribution or forfeitures, adjusted by subsequent income, losses, appreciation and depreciation thereof, is as follows:

Forfeitures. Forfeitures of non-vested Firm contributions are used to reduce future Firm contributions. During the Plan year ended December 31, 2024, \$45,772 of forfeited participant accounts were used to reduce the Firm's 2024 contributions. At December 31, 2024, \$32 of forfeited amounts were available to offset future employer contributions. The forfeiture amounts reducing employer contributions are as follows:

Administrative Expenses. Costs relating to administrative expense are paid by the Plan as incurred. Some separate costs associated with the Plan audit and certain administrative tasks are paid by the Firm outside of the Plan.

Investment Options. Upon enrollment in the Plan, a participant may direct the investments within their own individual accounts. Investments are required to be made in publicly traded securities. Participants may change their investment options in self-directed accounts at any time.

Notes Receivable from Participants. Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest, which is commensurate with local prevailing rates for loans made under similar circumstances. Principal and interest are payable bi-weekly or monthly. The interest rates charged range from 4.25% to 9.50% and maturity dates range between January 2025 to December 2029.

Payment of Benefits. Upon termination of service, a participant may elect to receive either a lump sum amount equal to the vested portion of the participant's account or various forms of annuity payments. Upon normal retirement (the day on which the participant attains age 65) or disability, a participant is entitled to their pension benefit as of the first day of the Plan year coinciding with or next following the date of normal retirement or disability. The participant's pension benefit is determined by the vested portion of the participant's account, retirement option selected, and annuity rates in effect at the time.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements of the Plan for the employees of the sponsor have been prepared on the accrual basis of accounting and present the net assets available for plan benefits and changes in those net assets in accordance with generally accepted accounting principles.

Use of Estimates. The preparation of the financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value as determined by the Fidelity Management Trust Company at the last reported sales price on the last business day of the Plan year. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurement.

Purchases or sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit loss has been recorded at December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Contributions. Contributions from employees are recorded as they are withheld from the participant's wages.

Payment of Benefits. Benefits are recorded when paid.

Expenses of the Plan. Administrative fees and expenses of the Plan may be paid out of the Plan assets unless paid by the Company. Certain administrative fees are paid by the Company.

Date of Management Review. The Plan considered events occurring through September 24, 2025, for recognition or disclosure in the financial statements as subsequent events. That date is the date the financial statements were available to be issued.

NOTE C – INFORMATION PREPARED AND CERTIFIED BY FIDELITY MANAGEMENT TRUST COMPANY

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified, except for comparing such information certified by the Trust Company to information included in the Plan's financial statements and supplemental schedule.

The following information was certified as complete and accurate by the Custodian:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- The related investment activity related to fair value of investments and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on Schedule H, Line 4i – Schedule of Assets (Held at End of Year).

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to written notification of all parties concerned and subject to the provisions of ERISA. In the event of Plan termination, participants' account balances will become 100% vested and non-forfeitable.

NOTE E - TAX STATUS

Effective June 1, 2015, the Plan adopted a non-standardized prototype plan sponsored by Fidelity Management & Research Co. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan's opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Management has evaluated the Plan's tax positions and concluded the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE F – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Fair Value Measurements – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Cash, interest bearing:* Cost approximate fair value due to the short term nature.
- *Individual securities:* Valued at the closing price quoted in the active market in which such security is traded.
- *Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Corporate bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.
- *Exchange traded funds:* Valued at the closing price quoted in the active market in which the fund is traded.
- *Stable Value:* The Contracts and securities purchased for the fund are backed solely by the financial resources of the issuers of such Contracts and securities. The stable value fund is valued at fair value by the sum of the market value of the fund's investments.

NOTE F – FAIR VALUE MEASUREMENTS (continued)

- *Annuities:* Annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had cash balances in excess of FDIC insurance limits in the amount of \$9,121,616 and \$9,844,728, respectively.

NOTE H – PARTY-IN-INTEREST TRANSACTION

Certain Plan investments are shares of money market and mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rule. Fees paid by the Plan for services provided by Fidelity Management Trust Company amounted to \$19,287 for the year ended December 31, 2024.

NOTE I – INCOME TAXES

Certain exempt organizations are required by Department of Labor regulations to file 990-T tax returns when unrelated business income (UBIT) exceeds \$1,000. Fidelity performed a complete review of all benefit plans related to UBIT during the year and determined that there was no income liability for 2024 and 2023.
