Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Methodist Health System 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for the year ended December 31, 2024 and for the period from July 1, 2023 (inception) to December 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 and for the period from July 1, 2023 (inception) to December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agree to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplementary Information Required by ERISA

The supplementary information as of and for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplementary information, other than the information in the supplementary information that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplementary information related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Plan Description

The following brief description of the Methodist Health System 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective July 1, 2023 to provide retirement benefits for the employees of Nebraska Methodist Health System, Inc. and employees of participating affiliates including Nebraska Methodist Hospital, Physicians Resource, Inc., Physicians Clinic, Inc., Nebraska Methodist Hospital Foundation, Jennie Edmundson Memorial Hospital, Shared Service Systems, Inc., and Methodist Fremont Health (collectively, the Health System).

On March 16, 2023, the Board of Directors of the Health System voted to merge the Shared Services Systems Defined Contribution Retirement Plan (the Shared Services Plan) into the Plan. Plan assets totaling \$6,131,146 were transferred from the Shared Services Plan into the Plan in July 2023. If employed July 1, 2023, years of service within the Shared Services Plan will be credited as eligible service for this Plan. Participants began making payroll contributions to this Plan in July 2023.

The Nebraska Methodist Health System Retirement Account Plan (the Pension Plan) terminated March 31, 2021. In 2022, all Pension Plan benefits were paid to participants as either a lump sum benefit, if elected by the participant or transferred to the selected insurance company through an annuity purchase for the benefit of the participant. In July and August 2023, assets remaining in the Pension Plan trust, totaling \$24,354,656 after the payment of all plan benefits, were transferred to this Plan which is considered a qualified replacement plan (See Note 8).

In July 2023, as part of the creation of this Plan, participants of the terminated Nebraska Methodist Health System Defined Contribution Retirement Plan (the 403(b) Plan) had the option to rollover their vested account balance to the Plan as elected by the participant. Rollover into the Plan was the default option for active employees in the 403(b) Plan. If employed July 1, 2023, years of service within the 403(b) Plan will be credited as eligible service for the Plan. For the period from July 1, 2023 (inception) to December 31, 2023, approximately \$496,500,000 was contributed to this Plan as directed by participants. These amounts are included in the 2023 financial statements as "Rollovers".

Health System employees become participants and are immediately eligible to make salary deferral contributions and receive employer safe harbor matching contributions upon their hire date. The participants will make salary deferral contributions according to the Plan's automatic enrollment provisions or affirmative election. The participants are also eligible to receive employer base contributions after attaining age 21, completing one year of service with 1,000 or more hours, and are employed on the last day of the Plan year.

Contributions

Participants may make pre-tax or Roth after-tax salary deferral contributions up to 100% of their eligible compensation as defined by the Plan, as reduced by required withholding, and up to the maximum dollar amounts allowable by law. Participants are automatically enrolled with an initial 3% salary deferral contribution (increasing 1% beginning with the first payroll period on or after May 1 following the Plan year in which the auto-enrollment was effective, up to 10%). At any time, a participant can elect not to contribute or may increase or decrease his or her deferral rate to any rate allowed under Plan provisions.

Participants are eligible for employer safe harbor matching contributions which are up to 100% of the participant's elective deferral on the first 6% of the participant's eligible compensation for the Plan year.

Employees who are at least 21 years of age and have been credited with 1,000 hours of service for the Plan year and are employed on the last day of the Plan Year or are at least 55 years old and terminated in the Plan year are eligible for employer base contributions which are made at various amounts ranging from 1% to 3% of the employee's eligible compensation based on years of service as of Plan year-end and other Plan requirements.

Employees who have met the requirements for the employer base contribution and completed at least 21 years of service as of December 31, 2023, are also eligible for the employer grandfathered base contribution through December 31, 2032. The grandfathered base contribution is equal to 1% of the employee's eligible compensation for the Plan year.

In addition to the employer base contribution, certain participants who were credited with 1,000 hours of service in the calendar year ended December 31, 2023 or had attained age 55, and completed at least 20 years of service and was a participant at July 1, 2023 in the either the 403(b) Plan or the Shared Services Plan, received an employer special base contribution for the period from July 1, 2023 (inception) to December 31, 2023. The employer special base contributions were made at various amounts ranging from 4% to 8% of the employee's eligible compensation based on years of service as of Plan year end and other Plan requirements. The employer special base contribution does not apply to the year ended December 31, 2024 and thereafter.

All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contribution, employer safe harbor matching contributions, employer base contributions (including the special base contributions and the grandfathered base contributions), and an allocation of Plan earnings or losses. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. The employer safe harbor matching contribution is allocated among participants based upon each participant's elected salary deferral. The employer base contributions

(including the special base contributions and the grandfathered base contributions) are allocated among participants based upon the eligible compensation of each participant and years of service. Investments are maintained in individual member accounts managed by Fidelity Management Trust Company (Fidelity).

Vesting

Participants are vested immediately in their voluntary salary deferral contributions plus actual earnings thereon. Vesting in the employer safe harbor matching contributions and the base contributions (including the special base contributions and grandfathered base contributions) are based on years of continuous service. Participants are 100% vested after two years (at least 1,000 hours per year) of credited service. If a participant terminates employment prior to completing two years of service, their accounts will become fully vested if termination was due to death, disability, or upon termination on or after normal retirement.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump-sum, partial, or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution of payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement plan designated by the plan administrator in the event the participant does not elect a payout option. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan allows for in-service distributions for participants who have reached the age of 59 ½. Participants may also receive hardship distributions, as defined by the Plan document. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their employer contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce expenses or to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$138,734 and \$42,441, respectively. During the years ended December 31, 2024 and 2023, \$0 and \$24,000 of forfeited amounts were used to reduce administrative expenses and employer contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America (GAAP).

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting - Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Health System determines the Plan's valuation policies utilizing information provided by the investments advisors and custodian. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Expenses

Certain expenses of the Plan are paid directly by the Health System and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Record-keeping and other administrative expenses are paid by the Plan and are included in administrative expenses.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 19, 2025. See Note 8 for a description of a subsequent event.

3. Information Certified by Fidelity

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, except for comparing such information certified by the trustee to information included in the Plan’s financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their Net Asset Value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Pooled Investments in Real Estate: The fair value of investments in real estate funds is based on the funds' NAV, or its equivalent, as supplied by the fund administrator and these valuations are used by management, as a practical expedient to fair value. FASB ASC 820, *Fair Value Measurements and Disclosures*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is in the Plan's assessment that the fund meets those requirements.

Common Collective Trust: Valued at the NAV based on the market value of its underlying investments. The fund contains investment contracts comprised of both underlying investment and contractual components which have observable level 1 or level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. FASB ASC 820, *Fair Value Measurements and Disclosures*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is in the Plan's assessment that the fund meets those requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986.

The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Health System has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

7. Related Party Transactions

Certain assets of the Plan are held and managed by Fidelity. Fidelity is the trustee, custodian, and record-keeper of the Plan, therefore, these transactions qualify as party-in interest.

8. Qualified Replacement Plan Provision

Effective July 1, 2023, the Plan was amended to allow for transfers into the Plan from the Pension Plan. The assets received from the Pension Plan, plus or minus any net appreciation or depreciation in fair value of the assets received, will be used to reduce future employer base contributions. During 2023, the Plan received a transfer of assets of \$24,354,656 from the Pension Plan.

As of December 31, 2024 and 2023, the Plan had a balance of \$14,317,648 and 24,273,477, respectively, available to reduce future employer contributions.

Subsequent to December 31, 2024 and 2023, the Plan used approximately \$2,500,000 and approximately \$10,000,000, respectively, of the aforementioned investments to reduce the 2024 and 2023 employer base contributions (including the special base contributions and the grandfathered base contributions).
