Independent Auditor's Report

To the Administrative Committee of

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Calvetti Ferguson 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Calvetti Ferguson 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

**Note 1 - Description of the Plan**

The following brief description of the Calvetti Ferguson 401(k) Profit Sharing Plan (the “Plan”) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established as of January 1, 2005. The Plan is a defined contribution 401(k) Plan structured under the provisions of Section 401(k) of the Internal Revenue Code (the “Code”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The basic Plan document has been amended and restated to be in compliance with changes required under ERISA. Calvetti Ferguson, LLC (the “Company”), acts as Plan administrator and controls and manages the operation and administration of the Plan. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Collectively “Empower”) are the Plan’s recordkeeper, custodian and third-party administrator. Global Retirement Partners and Empower Advisory Group act as the Plan’s investment advisors. The Plan is a “prototype plan” sponsored by the Company.

Eligibility

All employees of the Company and those of the participating affiliated employers, except for leased employees, non-resident aliens with no earned income from sources within the United States, reclassified employees, and interns, become eligible for participation in the Plan on the date of hire and upon attaining age 21.

Contributions

Eligible employees may elect to make both pretax and post-tax (Roth) contributions to the Plan, up to 90% of their eligible annual compensation, subject to certain limits determined by law and the Plan document. Participants who turn age 50 or older in the current calendar year may elect to make an additional pretax contribution, or catch-up contribution, to the Plan, not to exceed the amount allowable under current income tax regulations. Participants may also contribute amounts representing distributions from other qualified benefit Plans. Such amounts are included in the Statements of Changes in Net Assets Available for Benefits as rollover contributions.

Company Contributions

The Plan allows for an employer safe harbor matching contribution equal to 100% of participants’ contributions, up to the first 3% of participants’ eligible compensation, plus 50% of the next 2% of participants’ eligible compensation, with the Company’s total safe harbor matching contribution not exceeding 4% of participants’ eligible compensation. The Plan also allows for discretionary non-elective contribution of up to 4% of a participant’s eligible compensation in a Plan Year. The Company may also make discretionary profit-sharing contributions for participants who are employed on the last day of the Plan Year and have completed at least 1,000 service hours during the Plan Year. For the plan year ended December 31, 2024, the Company did not make discretionary matching contributions and discretionary profit-sharing contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts. The loans are secured by the balance in the participants’ account and bear interest as determined reasonable by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans, which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions. The participant can borrow up to 50% of the vested Account Balance to a maximum of \$50,000. Loan terms

range from one to five years; however, terms may exceed five years for the purchase of a primary residence.

Vesting

Participants are immediately vested in their elective contributions and in the Company's safe harbor contributions, plus actual earnings thereon. Vesting in the company's discretionary non-elective contributions and discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of continuous service. A participant begins vesting based on the schedule as shown below. Participants may also become fully vested in their account balances from the Company's discretionary non-elective and discretionary profit-sharing contributions if they are employed on or after their early or normal retirement age, as defined by the Plan, or at the time of death or disability.

Payment of Benefits

Participants may withdraw amounts equal to the total value of their pretax contribution or vested company contribution accounts after the age of 59 ½ or in the event of financial hardship or need. Upon termination after vesting, attainment of age 65 (normal retirement date), death or permanent disability, distributions may be made as described in the Plan document.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, allocations of applicable Company's contributions and Plan earnings and is charged with an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies (mutual funds) and a stable value fund offered through a group annuity investment contract through Empower Annuity Insurance Company.

Forfeited Accounts

Participants who terminate prior to full vesting forfeit the non-vested portions of their company contribution accounts. Forfeitures by terminated members can be applied to reduce employer contributions or Plan expenses. At December 31, 2024 and 2023, forfeiture non-vested accounts totaled \$152 and \$150, respectively. During 2024, there were no forfeited amounts used to reduce the company's employer contributions to the Plan.

**Note 2 - Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements are prepared under the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, revenue and related assets are recognized when received rather than when earned and expenses are recognized when paid rather than when obligations are incurred. Accordingly, the financial statements are not intended to present the net assets and changes in net assets of the Plan in conformity with accounting principles generally accepted in the United States of America.

Year End

The Plan utilizes a December 31 calendar year end.

Use of Estimates

The preparation of the Plan's financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except those investments that are fully benefit responsive which are stated at contract value. Fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Shares of registered investment companies (i.e. mutual funds) are valued based on quoted market prices, which represent the net asset value of shares held at year-end. See Note 6 for further discussion and disclosures related to fair value measurements.

Employer Key Guaranteed Portfolio Fund is reported at contract value which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. See Note 7 for further discussion.

Investment earnings are composed of interest, dividends and realized and unrealized gains and losses on investments. Interest income and dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade date basis. Interest income and dividends are recorded when received.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid. Amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid were not material at December 31, 2024 and 2023, respectively.

Subsequent Events

For the year-ended December 31, 2024, the Company evaluated subsequent events for potential recognition and disclosure through September 30, 2025, the date of the financial statement issuance.

Administration of Plan Assets

The trustee of the Plan, Empower Trust Company, LLC/Empower Annuity Insurance Company of America (“Empower”), holds the Plan’s assets. Empower serves as the record keeper and custodian. Contributions are held and managed by the trustee of the Plan, which invests cash received, interest and dividend income and makes distributions to participants. Officers or employees of the sponsor perform certain administrative functions. No such officer or employee receives compensation from the Plan. Administrative expenses are paid by either the Plan or the company, as provided by the Plan document. In addition, the company also provides certain administrative services to the Plan at no cost to the Plan.

**Note 3 - Information Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Empower Annuity Insurance Company and Empower Trust Company LLC have supplied the Plan’s administrator with a certification as to the completeness and accuracy of all information regarding investment assets, notes receivable from participants, investment transactions and investment income (loss) presented in the accompanying Statement of Net Assets Available for Benefits (modified cash basis) as of December 31, 2024 and 2023, the Statement of Changes in Net Assets Available for Benefits (modified cash basis) for the year ended December 31, 2024, and the Supplemental Schedule of Assets Held at End of Year (modified cash basis) as of December 31, 2024.

**Note 4 – Related-Party and Party in Interest Transactions**

The Plan invests in mutual funds and a group annuity contract managed by Empower. Therefore, transactions in these investments constitute related party-in-interest transactions. Direct fees incurred for these services paid by the Plan to Empower Advisory Group, LLC totaled \$4,253 for the year ending December 31, 2024. The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. Therefore, all transactions with these entities qualify as party-in-interest transactions. Direct fees incurred for these services paid by the Plan to Empower Annuity Insurance Company for recordkeeping services totaled \$25,488 for the year ending December 31, 2024. Direct fees incurred for these services paid by the Plan to Global Retirement Partners LLC for investment advisory services totaled \$17,500 for the year ending December 31, 2024. Other fees incurred by the Plan for the investment related expense may be included in net appreciation/depreciation in fair value of investments. The Plan sponsor pays directly any other fees related to the Plan’s operation.

**Note 5 – Plan Termination**

While the Company has not expressed any intent to terminate the Plan, it has the right to do so, subject to the restrictions set forth in ERISA. In the event such discontinuance results in the termination of the Plan, participants will become fully vested in their accounts and such accounts will be distributed in accordance with the Plan document.

**Note 6 – Fair Value Measurements**

FASB ASC 820, Fair Value Measurement Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three-tier fair value hierarchy under FASB ASC 820 is described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2: Inputs to the valuation methodology include:
- o Quoted prices for similar assets or liabilities in active markets;
  - o Quoted prices for identical or similar assets or liabilities in inactive markets;
  - o Inputs other than quoted prices that are observable for the asset or liability;
  - o Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observed for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and, as a result, are classified as a Level 1 investment.

Management evaluates the significance of various inputs to assess the appropriate classification of the Plan’s investments within the fair value hierarchy. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances,

the transfer is reported at the end of the reporting period. Management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024, and 2023, there were no significant transfers in or out of Level 1, 2 or 3.

**Note 7 Group Annuity Contract-Empower Key Guaranteed Portfolio Fund**

The Plan participates in the Employer Key Guaranteed Portfolio Fund (KGPF). The Employer Key Guaranteed Portfolio Fund is a fully benefit-responsive investment and is reported at contract value in the Statements of Net Assets Available for Benefits (modified cash basis). The Statement of Changes in Net Assets Available for Benefits (modified cash basis) is also prepared on a contract value basis. Benefit responsiveness is defined as the extent to which a contract's terms and the Plan permit or require participant-initiated withdrawals at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

KGPF is a fixed account investment option that is part of the general account of Empower. KGPF is offered through a Group Fixed Deferred Annuity Contract (the "Contract") issued by Empower. Assets in KGPF are measured at contract value and this is the price a participant can buy and sell his share of KGPF's account value. Empower is contractually obligated to repay the principal amounts invested in KGPF and a specified interest that is guaranteed to the Plan. The interest crediting rate applied to investments in KGPF is recalculated quarterly and is based on the earnings of the underlying assets in KGPF and the prevailing market conditions at the time of calculation. The minimum interest crediting rate specified in the Contract is 0.05% per annum. KGPF invests in fixed-income asset classes of financial institutions, private and public companies and state and local governmental units and municipalities that are neither insured by the Federal Deposit Insurance Corporation (FDIC) nor otherwise insured by any other government agency. The ability of the issuers of these asset classes to meet their financial obligations to KGPF, and by extension to the Plan, may be affected by prevailing and future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and includes such factors as the investment-year method experience of the underlying contract or pool, projected levels of cash flows within the current interest rate environment, and the projected maturity of the underlying investments. Such interest rates are reviewed on a semiannual basis for resetting. The average earnings yield and average credit rate for 2024 was 1.41%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Sponsor or other Sponsor event (e.g., divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. In addition, certain events allow the Contract issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the Contract, (3) a material misrepresentation, (4) a material amendment to the Plan agreement without the consent of the Contract issuer. Also, Empower may not process transactions in a timely manner and at contract value due to closure or disruptions of financial markets or exchanges.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9- Tax Status of the Plan**

The IRS has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes is included in the Plan's financial statements.

The modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
