# Bourns, Inc. Profit Sharing and Retirement Savings Plan

## Notes to Financial Statements

---

### Note 1 – Description of Plan

The following description of the Bourns, Inc. Profit Sharing and Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

**General** – The Plan is a defined contribution profit sharing and 401(k) plan established by Bourns, Inc., on January 1, 1993, at which time the assets from four previously-existing plans were transferred into the Plan. The Plan covers all United States employees of Bourns, Inc.; its subsidiary, CAI Barrington, Inc.; and employees of certain foreign affiliates as elected by Bourns, Inc. (collectively, referred to as the Company).

Vanguard Fiduciary Trust Company serves as trustee of the trust assets. The trustee accounts for all assets of the trust, independently determines the value of trust investments, and is required to regularly provide an accounting of all receipts, disbursements, and transactions made on behalf of the trust.

Under the terms of the Plan, the Investment Review Committee, consisting of members appointed for indefinite terms by the Board of Directors of the Company, has primary oversight authority for matters related to plan investments and plan investment choices. The Audit Committee of Bourns, Inc., has primary oversight authority for matters related to the financial statements of the Plan. The Executive Compensation Committee of Bourns, Inc., has primary oversight authority for matters related to plan design and plan benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and is in conformity with all subsequent applicable tax law changes.

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon reaching the age of 21 and completing three months of service. New employees who have met the eligibility requirements are automatically enrolled in the Plan at a contribution rate of 5 percent for the first year, increasing automatically by 1 percent each year to a maximum of 10 percent. Employees are eligible for the Company's profit sharing contribution after reaching the age of 21 and completing one year of service. Participants must complete at least 1,000 hours of service during the plan year, and be employed as of the last day of the plan year, to be eligible to receive any employer paid profit sharing contributions. Participation in the 401(k) plan is voluntary and employees have the option to opt out of the Plan and also to opt out of the automatic 1 percent increase.

### Contributions

*Participant contributions* – Each year, participants may contribute up to 50% of pretax annual compensation, as defined by the Plan. Participants may also elect to make after-tax contributions. Both company and participant contributions are allocated to various investment funds based on the elections made by the participant. Contributions of participants automatically enrolled are allocated by default to a target date retirement fund based on age. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

*Employer profit sharing contributions* – The Company may elect to make discretionary profit sharing contributions to the Plan in an amount determined at the sole discretion of the Company’s Board of Directors. Company profit sharing contributions are allocated among eligible participants in the ratio that each eligible participant’s number of credits bears to the total number of credits of all eligible participants. Each eligible participant receives one credit for each \$100 of eligible compensation, subject to maximum compensation limitations, and one credit for each year of service. For the year ended December 31, 2024, the Company made a \$1,250,000 profit sharing contribution to the Plan in 2025.

*Employer safe harbor* – The Company also makes safe harbor contributions equal to 100% of each participant’s contribution up to 3% of eligible compensation and 50 percent of each participant’s contribution above 3% up to a maximum of 5% of eligible compensation. The safe harbor contribution for the year ended December 31, 2024, was \$2,574,472.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant’s account is credited with the participant’s contributions and safe harbor employer contributions as well as allocations of the Company’s profit sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses. These administrative expenses are paid by the Plan for active employees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** – Participants are vested immediately in their contributions, the safe harbor employer contributions, and any earnings thereon. Participants vest in the Company’s profit sharing contributions based on the following schedule.

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

In the event of permanent disability or death, participants are 100 percent vested in the Company profit sharing contributions regardless of the number of years of service.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. Under the terms of the Plan Agreement, plan loans will bear a reasonable rate of interest determined by the plan administrator. Principal and interest is paid ratably through biweekly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25 to 9.50% with various maturities through December 2029.

**Payment of benefits** – Upon death or termination of employment with the Company, or any time thereafter, a participant (or if the participant is deceased, the beneficiary) may request a distribution of vested benefits. If no request for distribution is made, a participant's vested benefit will remain in the Plan until the participant is required to begin distributions in accordance with Internal Revenue Code (IRC) section 401(a)(9)(c). A participant eligible for a distribution may elect one (or a combination) of the following methods of distribution: (1) one-time partial distribution; (2) lump-sum distribution; or (3) installment payments. If the participant's vested account balance does not exceed \$1,000, the participant's account will be distributed in a lump sum upon death or termination of employment with the Company. In addition, in accordance with IRC section 401(k)–1(d)(3)(i), hardship withdrawals are allowed to satisfy an immediate and heavy financial need.

**Forfeitures** – In the event a participant terminates employment prior to becoming fully vested, the participant is entitled to receive a distribution of the vested portion of his or her account balance and the non-vested portion of the participant's account balance becomes a forfeiture. Forfeitures are maintained in a separate account and may, at the Company's discretion, be applied to the payment of the Plan's administrative expenses, to restore participants' individual accounts or to reduce company contributions. Forfeitures in the amount of \$20,430 were allocated to participants in March 2025. On December 31, 2024 and 2023, forfeited non-vested accounts totaled \$45,434 and \$23,434, respectively.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's trustee, Vanguard Fiduciary Trust Company, certifies the fair value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are paid by the Plan and are included in administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds and money market funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Self-directed brokerage accounts* – Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Collective trusts* – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding. This NAV practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments and redemption restrictions on December 31, 2024 and 2023.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 4 – Tax Status

The Plan Document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

#### **Note 6 – Information Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of the following:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

#### **Note 7 – Party-in-Interest Transactions**

Certain plan investments are managed by Vanguard Investment Group. Vanguard Fiduciary Trust Company, an affiliate of Vanguard Investment Group, is the trustee as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions.

#### **Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested and all assets remaining in the Plan shall be converted into cash, and the net amount realized after the payment of fees and expenses associated with the conversion shall be distributed to the participants in proportion to the participants' relative account balances as of the date of such termination.
