We have performed audits of the financial statements of Servicon Systems, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of Plan

The following description of Servicon Systems, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution retirement plan covering eligible employees, as defined by the Plan, of Servicon Systems, Inc. (the Company or Plan Administrator) who attain the age of 21 and have completed 90 days of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Merger – Effective January 1, 2023, assets in the amount of \$1,920,516 were merged from the Preferred Property Maintenance 401(k) Profit Sharing Plan into the Plan, including a loan with a balance of \$12,840 at December 31, 2023.

Contributions – Eligible participants may elect to make pre-tax or Roth contributions. The Company makes safe-harbor contributions by matching 100% of the first 3% and 50% of the next 2% of employee contributions. Eligible participants may contribute to the Plan each payroll period up to the maximum amount allowable under the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts – Each participant's account is credited (charged) with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings (losses), and (c) participant-directed administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in all contributions plus actual earnings thereon.

Note receivable from participants – Loans are not permitted under this Plan, however, a loan was transferred into the Plan during the year ended December 31, 2023, as part of a plan merger and will be reported as a note receivable from participant on the Plan financial statements until it is paid off by the participant. As of December 31, 2024, the rate of interest on the outstanding loan was 5.25% with a maturity date of December 2026.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either (a) lump-sum amount equal to the value of the participant's vested interest in his or her account or (b) equal installments payable monthly, quarterly, semi-annually, or annually over a period not exceeding his or her life expectancy, and the vested account balance should exceed \$5,000. A participant or beneficiary with a vested account balance greater than \$1,000 may leave all or part of the vested account balance in the Plan and defer receipt of benefit. In accordance with the IRC, hardship withdrawals are allowed to satisfy an immediate and heavy financial need. Benefits under the Plan are paid in cash.

Forfeited accounts – Forfeited accounts are used to reduce future Company contributions and administration fees. No forfeitures were used during the year ended December 31, 2024, and forfeiture account balances at December 31, 2024 and 2023, were not significant to the Plan.

Note 2 – Summary of Significant Accounting Policies

Basis of presentation – The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact purchases and sales at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All the Plan's investments at fair value, amounting to \$10,283,105 and \$8,104,733 as of December 31, 2024 and 2023, respectively, are classified as Level 1.

Note 4 – Investments at Contract Value

The Plan has an annuity contract with Mutual of America Life Insurance Company (Mutual of America) which is considered a fully benefit-responsive contract. Amounts placed in the annuity contract are credited with interest at a rate determined by Mutual of America. Mutual of America reserved the right to change the interest rates applicable to the amounts held in the annuity contract at its discretion. The annuity contract is reported at contract value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals.

The annuity contract is supported by Mutual of America's general account assets which are primarily invested in cash and investment grade fixed income securities. As of December 31, 2024 and 2023, the contract value of the Plan's annuity contract was \$908,511 and \$765,680, respectively.

Servicon Systems, Inc. 401(k) Plan Notes to Financial Statements

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution:

- Investments and note receivable from participants, as reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest, dividends, and interest income on note receivable from participants as reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments, as reflected in Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note 6 – Income Tax Status

The Plan Administrator adopted a Volume Submitter plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust were designed in accordance with the applicable requirements of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Participants are 100% vested in their accounts.

Note 8 – Related-Party Transactions and Party in Interest

The Plan's investments are mutual funds and annuity contracts either managed or issued through Mutual of America, third-party administrator of the Plan; therefore, these transactions qualify as party in interest. Fees paid by the Plan to the third-party administrator were not significant to the Plan during the year ended December 31, 2024.

Note 9 – Risks and Uncertainties

The Plan invests in various mutual funds. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Subsequent Events

The Plan has evaluated events subsequent to December 31, 2024, to assess the need for potential recognition or disclosure in the financial statements. Such events were evaluated through October 1, 2025, the date the financial statements were available to be issued. Based upon this evaluation, it was determined that no subsequent events occurred that require recognition or additional disclosure in the financial statements.
