Management's assessment of the fair value of the Plan's investments. Their assessment is based on information provided by Voya Retirement Insurance and Annuity Company and management's understanding of the Plan's investment contract with Voya Retirement Insurance and Annuity Company. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the unaudited information summarized in Note 4, ("Unaudited Information").

C. Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.
