**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the NPI/NRCA Employees Savings and Investment Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**A. General**

The Plan is a defined contribution plan established in 1989 to provide benefits to eligible employees of Nikon Precision Inc. and Nikon Research Corporation of America (collectively, the “Company”). The plan administrator believes that the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**B. Eligibility**

The Plan excludes employees who are residents of Puerto Rico, employees covered by a collective bargaining agreement, leased employees or employees on the payroll of any third party leasing company, nonresident aliens with no income from a U.S. source, independent contractors, and employees who waive rights to Company benefits or whose terms of employment provide for exclusion from Company benefits. Employees who participate in the Nikon Inc. Pension Plan are not eligible to receive an allocation of employer contributions to the Plan. There is no age or service requirement and Plan entry is immediate upon meeting eligibility requirements.

**C. Participant Contributions**

Eligible participants may enter the Plan immediately upon their date of hire and can elect to have the Company contribute up to 60% of their eligible pre-tax compensation and/or elect to make Roth after tax contributions, as defined in the Plan, up to the maximum amount allowable under applicable Code regulations. Newly eligible participants who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan 30 days after their date of hire at a pre-tax deferral rate of 6% of compensation.

Participants age 50 and older may elect to make additional catch-up contributions as allowed under Code regulations. Participants who elect to have the Company contribute a portion of their pre-tax compensation to the Plan, agree to accept an equivalent reduction in taxable compensation. Participants are also permitted to make rollover contributions of eligible amounts received from other tax-qualified retirement plans. Such contributions are invested in accordance with participant directions and Plan provisions.

Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified employer sponsored retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction.

**D. Employer Contributions**

Each Plan year the Company contributes for each eligible participant an amount equal to 3% of such participants’ eligible compensation. Company contributions are subject to annual limits based upon applicable provisions of the Code.

**E. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Company contributions, and Plan earnings or losses. Plan investments are based on participant directions. The contributions of participants who decline to make an investment election are invested in the Fidelity Freedom Fund appropriate for the individual's age and projected date of retirement.

Participants may elect to establish a brokerage account that permits them to invest in any investment security approved by the plan administrator in addition to the Plan's core investment fund menu.

**F. Vesting and Forfeitures**

Participants are immediately 100% vested in their contributions, rollovers and related earnings. Participants vest in Company contributions and related earnings allocated to their accounts at the rate of 34% after year one, 67% after two years, and 100% after three years of service. Forfeitures of terminated participants' non-vested accounts may be used to pay Plan administrative expenses or to reduce Company contributions. As of December 31, 2024 and 2023, Plan investments included a forfeiture reserve of approximately \$4,400 and \$44,000, respectively.

**G. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by the participant's vested account balance, bears interest at a rate comparable to rates charged by commercial lenders under similar circumstances, and must be repaid to the Plan within a five-year period, unless the loan is used for the purchase of a principal residence, in which case the maximum loan term is ten years. Principal and interest are paid ratably through payroll deductions. The plan administrator approves the specific terms and conditions of each loan. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with maturities through January 2030.

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**H. Payment of Benefits**

The normal retirement date under the Plan is the date that a participant reaches the age of 65. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may maintain his or her account balance in the Plan or elect to receive vested benefits in a lump sum. Hardship withdrawals from participants' elective deferral accounts are permitted under limited circumstances, as defined in the Plan.

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Plan investments are stated at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Expenses**

Fidelity Management Trust Company ("Fidelity") is third-party administrator and directed trustee of the Plan. Fidelity charges record keeping and administrative fees based on a percentage of the average value of total plan investments equal to four basis points under provisions of the Retirement Plan Services Agreement between the Company and Fidelity. These charges are offset by credits Fidelity provides to the Plan for investments in Fidelity funds and fees Fidelity receives from Plan investments outside the Fidelity family of funds.

**E. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 - INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by letter dated October 24, 2016, that the Plan is designed in accordance with applicable sections of the Code. The plan administrator believes the Plan is designed and operated in compliance with requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity. Purchases and sales of shares of Fidelity funds and payment of fees to Plan service from Plan assets are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are based on quoted prices for identical securities in an active market. Level 2 inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at fair value based on closing market prices. Self-directed brokerage accounts consist primarily of cash, common stock, mutuals funds, and exchange traded funds, which are valued at fair value based on closing market prices. **NOTE 9 - MANAGED INCOME PORTFOLIO**

The Fidelity Managed Income Portfolio is a common/collective trust that seeks to offer a level of investment income that is consistent with principal preservation and invests primarily in guaranteed investment contracts issued by insurance companies and other financial institutions. The yield earned by the Plan was 2.72% and 2.13% for 2024 and 2023, respectively. Units of investment are redeemable at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses. There are no funding commitments or limits on participants' ability to redeem units at contract value, except for a provision that prohibits participants from making a direct exchange from this fund to a competing fund. Redemption restrictions and/or market value adjustments may apply to Plan level redemptions. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the NPI/NRCA Employees Savings and Investment Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**A. General**

The Plan is a defined contribution plan established in 1989 to provide benefits to eligible employees of Nikon Precision Inc. and Nikon Research Corporation of America (collectively, the “Company”). The plan administrator believes that the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**B. Eligibility**

The Plan excludes employees who are residents of Puerto Rico, employees covered by a collective bargaining agreement, leased employees or employees on the payroll of any third party leasing company, nonresident aliens with no income from a U.S. source, independent contractors, and employees who waive rights to Company benefits or whose terms of employment provide for exclusion from Company benefits. Employees who participate in the Nikon Inc. Pension Plan are not eligible to receive an allocation of employer contributions to the Plan. There is no age or service requirement and Plan entry is immediate upon meeting eligibility requirements.

**C. Participant Contributions**

Eligible participants may enter the Plan immediately upon their date of hire and can elect to have the Company contribute up to 60% of their eligible pre-tax compensation and/or elect to make Roth after tax contributions, as defined in the Plan, up to the maximum amount allowable under applicable Code regulations. Newly eligible participants who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan 30 days after their date of hire at a pre-tax deferral rate of 6% of compensation.

Participants age 50 and older may elect to make additional catch-up contributions as allowed under Code regulations. Participants who elect to have the Company contribute a portion of their pre-tax compensation to the Plan, agree to accept an equivalent reduction in taxable compensation. Participants are also permitted to make rollover contributions of eligible amounts received from other tax-qualified retirement plans. Such contributions are invested in accordance with participant directions and Plan provisions.

Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified employer sponsored retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction.

**D. Employer Contributions**

Each Plan year the Company contributes for each eligible participant an amount equal to 3% of such participants’ eligible compensation. Company contributions are subject to annual limits based upon applicable provisions of the Code.

**E. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Company contributions, and Plan earnings or losses. Plan investments are based on participant directions. The contributions of participants who decline to make an investment election are invested in the Fidelity Freedom Fund appropriate for the individual's age and projected date of retirement.

Participants may elect to establish a brokerage account that permits them to invest in any investment security approved by the plan administrator in addition to the Plan's core investment fund menu.

**F. Vesting and Forfeitures**

Participants are immediately 100% vested in their contributions, rollovers and related earnings. Participants vest in Company contributions and related earnings allocated to their accounts at the rate of 34% after year one, 67% after two years, and 100% after three years of service. Forfeitures of terminated participants' non-vested accounts may be used to pay Plan administrative expenses or to reduce Company contributions. As of December 31, 2024 and 2023, Plan investments included a forfeiture reserve of approximately \$4,400 and \$44,000, respectively.

**G. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by the participant's vested account balance, bears interest at a rate comparable to rates charged by commercial lenders under similar circumstances, and must be repaid to the Plan within a five-year period, unless the loan is used for the purchase of a principal residence, in which case the maximum loan term is ten years. Principal and interest are paid ratably through payroll deductions. The plan administrator approves the specific terms and conditions of each loan. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with maturities through January 2030.

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**H. Payment of Benefits**

The normal retirement date under the Plan is the date that a participant reaches the age of 65. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may maintain his or her account balance in the Plan or elect to receive vested benefits in a lump sum. Hardship withdrawals from participants' elective deferral accounts are permitted under limited circumstances, as defined in the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Plan investments are stated at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Expenses**

Fidelity Management Trust Company ("Fidelity") is third-party administrator and directed trustee of the Plan. Fidelity charges record keeping and administrative fees based on a percentage of the average value of total plan investments equal to four basis points under provisions of the Retirement Plan Services Agreement between the Company and Fidelity. These charges are offset by credits Fidelity provides to the Plan for investments in Fidelity funds and fees Fidelity receives from Plan investments outside the Fidelity family of funds.

**E. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 - INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by letter dated October 24, 2016, that the Plan is designed in accordance with applicable sections of the Code. The plan administrator believes the Plan is designed and operated in compliance with requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity. Purchases and sales of shares of Fidelity funds and payment of fees to Plan service from Plan assets are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are based on quoted prices for identical securities in an active market. Level 2 inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at fair value based on closing market prices. Self-directed brokerage accounts consist primarily of cash, common stock, mutuals funds, and exchange traded funds, which are valued at fair value based on closing market prices. **NOTE 9 - MANAGED INCOME PORTFOLIO**

The Fidelity Managed Income Portfolio is a common/collective trust that seeks to offer a level of investment income that is consistent with principal preservation and invests primarily in guaranteed investment contracts issued by insurance companies and other financial institutions. The yield earned by the Plan was 2.72% and 2.13% for 2024 and 2023, respectively. Units of investment are redeemable at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses. There are no funding commitments or limits on participants' ability to redeem units at contract value, except for a provision that prohibits participants from making a direct exchange from this fund to a competing fund. Redemption restrictions and/or market value adjustments may apply to Plan level redemptions. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.
