To the Management of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Vitality Management Company, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule, schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The Vitality Management Company, LLC 401(k) Plan (the “Plan”) was established on August 1, 1999. The following description provides only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan sponsored by Vitality Management Company, LLC and its subsidiaries (collectively, the “Employer”) covering all of its employees who are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (collectively “Principal” or the “Custodian”) serve as the investment custodian and record keeper of the Plan and are qualified institutions pursuant to ERISA.

Contributions and Vesting. Participants may elect to make pre-tax and after-tax contributions on their behalf pursuant to salary reduction arrangements up to a maximum of 100% of annual compensation, subject to Internal Revenue Service (“IRS”) deferral limitations. The Employer matches 100% on the first 3% of participants’ compensation and matches 50% on the next 2% of participants’ compensation. Salary reductions in excess of 5% of the participant’s annual compensation are not matched. Participants are immediately fully vested in Employer matching contributions. Participants over 50 years of age may make catch-up contributions to the Plan. Annual compensation is defined as salaries and wages, including overtime, bonuses, commissions, and other compensation paid by the Employer.

The Employer may make discretionary contributions for all participants who are employed at the end of the year, which is funded subsequent to year end. Any Employer discretionary contributions are based upon participants’ annual compensation subject to IRS deferral limitations. Participants vest in any Employer discretionary contributions equally over a four-year period (25% per year) starting with the participants’ date of hire. There were no Employer discretionary contributions elected for the year ended December 31, 2024.

Participant Accounts. Each participant is provided a salary deferral account, an Employer match account, an Employer discretionary contribution account, and other accounts as necessary. Each account is credited with their respective contributions. Investment earnings and losses are allocated to participant accounts based on participants’ account balances, as defined in the Plan agreement, and are made on a daily basis to all active fund participants as of the date of the allocation. Participant accounts are charged with any benefit payment made on behalf of the participant and allocation of Plan expenses. The benefit to which a participant is entitled is the vested balance of the participant’s accounts.

Forfeitures. As of December 31, 2024 and 2023, there were no forfeited non-vested account balances. Forfeited non-vested discretionary contribution account balances are utilized to reduce Employer contributions to the Plan and/or the Plan’s administrative expenses; however, no expenses or Employer contributions were reduced from forfeited non-vested accounts for the year ended December 31, 2024.

Investment Options. Each participant directs the investment of their account balances into any combination of the various investment options offered by the Plan. All investments are maintained with Principal. As of December 31, 2024, investment options consist of a stable value fund account (common/collective trust) and mutual fund accounts (registered investment funds).

Notes Receivable from Participants. Each participant may borrow from the Plan against their account balance. Loan amounts are restricted to 50% of the participant’s vested account balances subject to a maximum loan of \$50,000. Loans are secured by the participants’ account balances, and the minimum loan amount is \$1,000. Interest rates on loans are determined by Principal at the time of loan application. The interest rates on participant loans outstanding as of December 31, 2024 ranged between 5.25% and 10.50%. Permitted loan repayment periods range from one to five years.

Payment of Benefits. On termination of service, a participant may elect to receive either a lump-sum amount equal to the vested balance of their accounts or other optional forms of distribution available under the Plan. Terminated participants with a total balance of less than \$1,000 must take a lump-sum cash distribution. For terminated participants with a balance between \$1,000 and \$7,000, their balances will be automatically rolled over to an individual retirement account with Principal if no distribution election is made by the participant. Benefit payments are generally made immediately following the participant's request for benefit distribution.

Recent Legislation. The SECURE Act 2.0 was signed into law on December 23, 2022. The SECURE Act 2.0 allows more part-time workers to participate, increases the age for required minimum distributions and reduces the penalty for missed minimum distributions, permits plan participants to elect to receive vested employer contributions on an after-tax basis, and allows penalty free withdrawal for terminal illness, effective January 1, 2023. Additionally, it will allow for higher catch-up contributions, allow for matching contributions on student loan payments, permit plan sponsors to add an emergency savings account to their retirement plans, increase the availability of penalty-free withdrawals, and add automatic enrollment error relief provisions, effective January 1, 2024. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates. The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from these estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

Concentration of Credit Risk. Substantially all the Plan's assets were held by the Custodian. The Custodian is qualified institution pursuant to ERISA.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits. Benefits are recorded when paid.

Administrative Expenses. The Plan's administrative expenses are deducted from participant accounts. However, forfeitures from non-vested participants' accounts may be used to pay the Plan's administrative expenses in accordance with the Plan document.

NOTE 3 – INFORMATION CERTIFIED BY CUSTODIAN

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule, which was prepared by Principal and furnished to the Plan's administrator ("Plan Administrator"). The Plan Administrator has obtained certifications from Principal that such information is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023. Notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Note 4: All investment balances.
- The schedule of assets held at end of year as of December 31, 2024, as shown on Form 5500, Schedule H, Part IV, Line 4i.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB *Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual Funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – FAIR VALUE MEASUREMENTS (Concluded)

Common/Collective Trusts. Valued at the net asset value of units held (“NAV”). The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested in their accounts.

During 2024, the Company terminated significant number of participants due to business restructuring. As a result, the Plan experienced a partial termination during 2024. All affected participants were fully vested in their Employer matching contributions as a result of the partial termination.

NOTE 6 – INCOME TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (“IRC”) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan’s tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

NOTE 7 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual fund accounts and a common collective trust account managed by Principal. Principal is the Custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

NOTE 8 – SUBSEQUENT EVENTS

The Plan’s management has evaluated all known subsequent events from December 31, 2024 through September 16, 2025, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that have not been disclosed in the notes to the financial statements.
