## REPORT OF INDEPENDENT AUDITORS

To the Investment Policy Committee of the  
DFB Pharmaceuticals, LLC Employee Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the DFB Pharmaceuticals, LLC Employee Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### A. Description of the Plan

#### General

The following brief description of the DFB Pharmaceuticals, LLC Employee Retirement Plan (the “Plan”) is provided for general information purposes only. The Plan is sponsored by DFB Pharmaceuticals, LLC (the “Company”). Participants should refer to the Plan document for more complete information. The Company’s corporate offices are located in Fort Worth, Texas.

The Plan was effective January 1, 1991, amended most recently effective January 1, 2024, and is a defined contribution plan available to substantially all employees of the Company and its affiliates (collectively, the “Companies”) who have attained the age of 18 and have completed 30 days of service. Certain employees of the Companies are members of unions that provide retirement benefits. These employees are not eligible to participate in the Plan. Certain employees of the Companies are employed by foreign affiliates and are not eligible to participate in the Plan. Participants are automatically enrolled in the Plan on the first day of the month once they are eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan is to encourage the Companies’ employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

#### Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. In addition, participants may contribute designated Roth (after tax) contributions. All contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan document. Eligible participants may make a rollover contribution to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the year may make catch-up contributions in accordance with, and subject to the limitations imposed by the Code.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

#### A. Description of the Plan – continued

##### Contributions – continued

The Companies may make discretionary matching contributions to the Plan as determined annually by the Companies' management, limited to 5% of the participant's annual compensation, as defined by the Plan. Participants must be age 18 or older, employed on the last day of the Plan year, and must complete one month of service during the Plan year to receive the discretionary matching contribution. In 2024 and 2023, the Companies made discretionary matching contributions of 50% of the participant's contribution up to 5% of the participant's annual compensation, as defined by the Plan. For the years ended December 31, 2024 and 2023, the Companies made matching contributions of approximately \$130,000 and \$112,000, respectively.

Additionally, the Companies make a top-heavy contribution, limited to 3% of the participant's annual compensation for employees that receive no discretionary matching contributions, as defined by the Plan. For participants who receive a discretionary matching contribution, the top-heavy contribution is 3% of the participant's annual compensation less their discretionary matching contribution. Participants eligible to receive top-heavy contributions must be employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Companies made top-heavy contributions of approximately \$4,000 and \$5,000, respectively.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) the Companies' contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### Vesting

Participants are immediately vested in their voluntary contributions, rollovers, and earnings thereon. Vesting in the Companies' contribution portion of accounts, plus earnings thereon, is as follows:

A participant's interest in the matching contributions the Companies make to the Plan and the earnings thereon becomes 100% vested upon attaining the Plan's normal retirement age or upon termination of employment due to death or disability.

#### A. Description of the Plan – continued

##### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range from one to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. As of December 31, 2024 and 2023, interest rates ranged from 5.50% to 10.25%. Principal and interest are paid ratably through payroll deductions. Participant loans are classified as notes receivable from participants in the Plan's financial statements.

##### Benefit Payments

On separation of service due to death, disability, or retirement, a participant whose vested balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic payments, as defined by the Plan. For termination of service due to other reasons or for a participant whose vested balance is less than \$5,000, the participant will receive the value of the vested interest in his or her account as a lump-sum distribution. If a withdrawing participant is not entitled to his or her entire account balance, the amounts not received are forfeited.

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of his or her vested account balance while employed after reaching age 59 ½. A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, his or her spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence for the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from his or her principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) for the payment of funeral or burial expenses for the participant, his or her spouse, or dependents; or (6) for the repair of damage to the participant's principal residence that would qualify for a casualty loss deduction under the Code.

##### Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to offset expenses and employer matching contributions for the year. If there are no expenses or matching contributions for which the Companies can use the forfeitures, the forfeitures are allocated to the Plan's participants per the Plan provisions. Approximately \$1 of forfeitures were allocated to reduce matching contributions during the year ended December 31, 2023. No forfeitures were allocated to reduce matching contributions during the year ended December 31, 2024. Unallocated forfeitures outstanding as of December 31, 2024 and 2023, were de minimis.

##### Investment Options

Upon enrollment in the Plan, a participant may direct his or her salary deferrals in 1% increments into any of the Plan's investment options.

#### **A. Description of the Plan – continued**

##### **Plan Expenses**

Employees of the Company perform certain administrative functions with no compensation from the Plan. In accordance with Plan provisions, substantially all costs relating to asset charges and recordkeeping are paid by the Plan. Expenses related to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses are paid by the Companies and are not reflected in the accompanying financial statements.

#### **B. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

##### **Use of Estimates**

The preparation of the financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

##### **Contributions**

Contributions from the Companies and participants are accrued as they become obligations of the Companies, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

##### **Investment Valuation and Income**

The investments of the Plan are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value) as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year-end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **B. Summary of Significant Accounting Policies – continued**

##### **Notes Receivable from Participants**

Notes receivable from participants are recorded at the unpaid principal balance plus accrued but unpaid interest.

##### **Payment of Benefits**

Benefits are recorded when paid.

#### **C. Fair Value Measurements**

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- The value of the pooled separate account is principally derived from the market value of the underlying mutual funds in which it invests. The fair value is based on the net asset value per share. This investment is classified within Level 2 of the valuation hierarchy.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following table details the Plan's investments at fair value by level, within the fair value hierarchy, as of December 31, 2024 and 2023. The Plan has no assets classified within Level 1 or Level 3 of the valuation hierarchy.

These items are classified in their entirety based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets and liabilities within the levels of the fair value hierarchy.

**D. Fully Benefit-Responsive Investment Contract**

The Plan holds a traditional guaranteed investment contract (the Guaranteed Interest Fund) through a group fixed unallocated annuity contract supported by the general assets of Standard Insurance Company (“Standard”). This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The interest rate credited to participants was 3.03% for the years ended December 31, 2024 and 2023.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also limit the ability of the Plan to transact at contract value with the participants.

#### **E. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net realized and unrealized gains on investments, interest and dividends, and interest income from notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard (the custodian of the Plan).

#### **F. Tax Status**

Effective January 1, 2022, the Plan was amended and restated by the adoption of the Standard Retirement Services Inc Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan which has a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020. This opinion letter states that the form of the prototype plan is acceptable under Section 401 of the Code. The Companies may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **G. Plan Termination**

Although they have not expressed any intention to do so, the Companies have the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participants’ accounts will become 100% vested.

#### **H. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The investments of the Plan are managed by Standard. Standard is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. All of these transactions, as well as participant loans, are exempt from the prohibited transactions rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA which are exempt from the prohibited transaction rules.

#### **I. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **J. Subsequent Events**

In preparing the accompanying financial statements, management has evaluated all subsequent events and transactions for potential recognition or disclosure through October 1, 2025, the date the financial statements were available for issuance.
