Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Sun World International, LLC 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE A - DESCRIPTION OF THE PLAN

The following brief description of the Sun World International, LLC 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

1. General

Effective January 1, 1996, the Plan was established for the benefit of employees of Sun World International, LLC (the "Company"). The Plan is intended to meet the requirements of Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Eligibility

An employee is eligible to make elective contributions to the Plan and to receive employer safe harbor matching contributions on the first day of the month following the completion of two months of service and attainment of age 18. An employee is eligible for discretionary nonelective employer contributions after one year of service and must have at least 1,000 hours of service during the plan year and be employed on the last day of the year. Employees who are covered under a collective bargaining agreement, leased employees and non-resident aliens are not eligible to participate in the Plan.

Effective December 17, 2024, the Plan's eligibility requirements were amended to permit participation after one month of service for all types of contributions. In addition, for discretionary nonelective employer contributions, the prior eligibility requirements of one year of service, 1,000 hours of service, and last-day-of-year employment were eliminated; however, the one-month of service requirement remains.

3. Contributions

Participants may elect to contribute pre-tax and or Roth contributions, up to 60% of their compensation, not to exceed the maximum deferral limit per Section 402(g)(1) of the IRC. Additional "catch-up" contributions can be made beginning in the plan year in which a participant will be at least age 50 by the end of the plan year.

The Company makes safe harbor matching contributions equal to 100% of deferrals up to the first 3% of compensation and 50% of deferrals up to the next 2% of compensation, subject to a maximum of 4% of employee's compensation. In addition, the Company may elect to make discretionary nonelective employer contributions in an amount to be determined by the Board of Directors of the Company at each plan year end. The Company did not make a discretionary nonelective employer contribution during 2024.

4. Participant Accounts

Each participant's account is credited with the participant's contributions, employer matching contributions, and allocations of employer discretionary nonelective contributions, if any, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Investment Options

A participant may direct employee contributions and Company contributions, as desired, in any of a variety of investment options held by Fidelity Management Trust Company ("Fidelity"), the trustee, as selected by the Company. Participants may change their investment options daily.

6. Benefit Payments

Upon termination of service, retirement, attainment of age 59½, death or disability, a participant or a participant's beneficiary is entitled to receive a lump-sum, installments, partial withdrawals or annuities equal to the value of the participant's account. Hardship distributions are permitted if certain criteria are met.

7. Forfeitures

Forfeitures or excess matching contributions are retained in the Plan and may be used to reduce future Company contributions or to pay plan expenses. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions. Outstanding forfeitures at December 31, 2024 and 2023 were not material.

8. Vesting

Participants are immediately 100% vested in all employee pre-tax contributions, rollover contributions, safe harbor matching contributions, discretionary non-elective employer contributions and any earnings thereon.

9. Notes Receivable from Participants

Participants have the ability to borrow against their vested account balance, up to the lesser of \$50,000 (reduced by the highest outstanding balance of all loans during the preceding twelve-month period) or 50% of their vested balance, with a minimum borrowing of \$1,000. Loans bear interest at local prevailing rates as determined by the plan administrator. Repayment of principal and interest is provided by uniform payroll deductions over a period of up to five years for all loans unless used to purchase a principal residence. Loans used to purchase a primary residence must be repaid within 10 years.

10. Plan Termination

The Company has established the Plan with a bona fide intention and expectation to continue the Plan indefinitely, but reserves the right to terminate it at any time, subject to the provisions of ERISA. In the event of a termination of the Plan, the assets of the Plan will be distributed to participants in accordance with the provisions of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

2. Plan Administration

Sun World International, LLC is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of assets. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

4. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note D for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits, changes in net assets available for benefits and disclosures during the reporting period. Accordingly, actual results may differ from those estimates.

6. Payment of Benefits

Benefits are recorded when paid.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

8. Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity (the trustee of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year end. These funds are required to publish their daily NAV and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

Collective trust and stable value funds: NAV for the common/collective trusts (CCT) are determined by the trustee of the CCT. The fair value of the Plan's interest in the CCTs are based on the underlying unit value reported by the CCT as of the close of business on each valuation date. The NAV per unit is computed by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding. Investment income earned is reinvested in the fund and included in the determination of unit values. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held by Fidelity. Fidelity is the trustee and record-keeper for the Plan and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants and related interest income are also considered party-in-interest transactions.

NOTE G - TAX STATUS

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan (“Non-Standardized Plan”), which received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Non-Standardized Plan is qualified and the trust established thereunder is tax-exempt under the appropriate sections of the IRC. The Plan has been amended since receiving its most recent opinion letter. However, the plan administrator and the Plan’s advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to allow automatic enrollment.

Plan management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued and has determined that there were no other events to be disclosed in the accompanying financial statements.
