1. Description of the Plan

The following description of CAN Capital, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, effective January 1, 2005, is a defined contribution plan covering all employees of CAN Capital, Inc. and participating affiliates (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Trustee and Administration of the Plan

The trustee of the Plan is Reliance Trust Company (the Trustee). The recordkeeper of the Plan is Automatic Data Processing (ADP). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The 401(k) Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees of the Company are eligible to participate in the Plan after attainment of age 21 and completing three months of service, as defined.

Contributions

Participants may contribute either pre-tax or after-tax Roth deferrals up to 75% of eligible compensation, subject to certain Internal Revenue Code (IRC) limitations. Upon becoming eligible to make salary deferrals under the Plan, a participant will be deemed to have entered into an automatic salary deferral election of 2% of Plan compensation, as defined, unless the participant makes a contrary salary deferral election. Effective February 1, 2024, the Plan was amended to increase the automatic salary deferral election to 3% of Plan compensation. Additionally, the Plan added an automatic escalation feature, whereby automatic deferral contributions will be increased by 1% each year subsequent to enrollment up to 10%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides for a matching contribution on behalf of each eligible participant equal to 50% up to 6% of the eligible participant's compensation up to a limit of \$3,000 contribution annually. The Company may also provide a discretionary nonelective employer contribution on behalf of eligible participants. No discretionary nonelective contributions were made during 2024.

Participant Accounts

Each participant's account is credited with participant contributions, the Company contributions, and allocations of the Plan earnings, and charged with benefit payments, allocations of Plan losses, and certain administration expenses. Plan earnings and losses are allocated based on account

balances while contributions are credited based upon elective deferrals and compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective deferral contributions and rollover contributions, plus actual earnings thereon. A participant will also be 100% vested upon death or disability or attainment of normal retirement age, as defined. Company matching and nonelective contributions plus earnings thereon are determined under the following schedule:

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of a participant's account balance. Participants may have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in *The Wall Street Journal* plus 2%. The period for loan repayment cannot exceed five years from the date of the loan unless it was used to purchase a principal residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive the value of their vested account in a lump-sum amount, installments, or defer receiving payments until ages 70 ½ through 75 depending on date of birth. If the vested amount at termination or retirement is \$5,000 or less, the Plan will automatically roll the vested account to an IRA in a direct rollover if the vested account is more than \$1,000. A participant may withdraw vested portions of the contributions made to the Plan on his or her behalf prior to the termination of his or her employment with the Company upon attainment of age 59½. Hardship withdrawals may be requested and are paid in one lump sum upon approval.

Forfeitures

Forfeitures of non-vested accounts may be used to pay for Plan expenses or reduce future employer contributions. During the year ended December 31, 2024, \$20,995 of forfeited amounts were used to reduce employer contributions. At December 31, 2024 and 2023, the balance in the forfeiture account was \$37,526 and \$677, respectively.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Nonelective contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued unpaid interest as repayments of principal and interest are received primarily through payroll deductions and the notes are collateralized by the participants' account balances. Defaulted notes from participants are deemed distributed and are recorded as deemed distributions to participants in the statement of changes in net assets available for benefits. Deemed loans continue to accrue interest until repayment or until they are offset through distributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest

priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust (CCT) - The CCT is valued at the NAV of units held. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The CCT is a direct filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by Reliance Trust Company

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

6. Related Party and Party-in-Interest Transactions

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to the Plan's recordkeeper. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Income Tax Status

The Plan adopted a pre-approved plan document sponsored by ADP, LLC, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020. The opinion letter stated that the pre-approved plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events from the date of the statements of net assets available for benefits through September 29, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan Trustee changed to ADP Retirement Trust Services, LLC.
