Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Leadership for Educational Equity 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1—DESCRIPTION OF PLAN

The following description of Leadership for Educational Equity 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering substantially all employees of Leadership for Educational Equity and Leadership for Educational Equity Foundation (the Company) who have three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrators are responsible for oversight of the Plan. The Investment Advisor determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Administrators.

Contributions. Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Company contributes a safe harbor matching contributions of 100% of the first 5% of compensation that a participant contributes to the Plan. The safe harbor matching contributions are made each payroll period.

Participant accounts. Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contributions and Plan earnings, and charged with withdrawals, transaction fees and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested immediately in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes receivable are secured by the balance in the participant's account. Loans are required to bear a reasonable interest rate, determined at the time the loan is made. Principal and interest is paid ratably through payroll deductions.

All loans are amortized over a period agreed upon by the borrower and the Plan administrator in terms of whole years, but in no event shall exceed five years in duration unless the loan is for the purchase of a home for the borrower, in which case the term may be up to 30 years. Repayments of the amount of such loan shall be credited directly to such borrower's account in a manner consistent with the borrower's current investment elections.

Payment of Benefits. On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account. Participants having any immediate and heavy financial hardship without any other source of funds may request a hardship withdrawal from their salary deferral account. A lump-sum distribution may be made if the participant's vested interest in his or her account is \$5,000 or less.

Forfeited Accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10 for each year. These accounts will first be used to reduce future employer contributions. There were no forfeitures used during 2024.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions Receivable

The Plan uses the ERISA definition of plan assets to determine whether an accrual should be made for employee or the related employer contributions receivable based on when amounts have been withheld from employee compensation. A defined contribution plan can elect to recognize the employee and the related employer matching contribution either (1) in the period related to the participant's service or compensation (even if not yet withheld), or (2) in the period the employee contribution is withheld if the policy is applied on a consistent basis.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrators determine the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the delinquent participant loan is still recorded as notes receivable based on the terms of the Plan document until the participant distributes their account balance.

Payment of Benefits

Benefits payments to participants or beneficiaries are recognized when paid. There were no requested distributions that were not paid out by December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, payment of benefits and investment adviser fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Base administrative recordkeeping fees and participant recordkeeping fees are paid by the plan sponsor.

Date of Management's Review

Management has evaluated subsequent events through September 29, 2025, the date which the financial statements were available to be issued.

NOTE 3—INCOME TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated October 6, 2020 stating that the form of pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 4—FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

Level 1 Fair Value Measurements

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Fair Value Measurements

Collective trust fund: The fair value of the collective trust fund is valued at the net asset value (NAV) per unit as determined by the issuer which is readily determinable.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 at the end of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers between Level 1 and Level 2.

NOTE 5—PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee for the Plan and, therefore, these transactions qualify as party in interest transactions. Participant loans are also considered party-in-interest transactions. However, those are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Effective July 21, 2011, ADP, Inc. provides certain administrative services to the Plan pursuant to an Administrative Service Agreement between the Company and ADP, Inc. ADP, Inc. receives revenue from mutual fund service providers for services ADP Inc. provides to the funds. Revenue sharing in the amount of \$29,232 was received in the year ended December 31, 2024, and was used to pay investment advisor fees.

NOTE 6—CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

NOTE 7—TERMINATION OF PLAN

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 10—SUBSEQUENT EVENTS

The Plan has implemented an optional provision of the SECURE 2.0 Act in 2025 in regard to updating the dollar amount for catch up contributions for those ages 60-63.
