Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Stark Truss Company, Inc. Employee 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Stark Truss Company, Inc. Employee 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stark Truss Company, Inc. Employee 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of the Plan

The following description of the Stark Truss Company, Inc. Employee 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Stark Truss Company, Inc. Employee 401(k) Plan is a defined contribution plan covering all employees of Stark Truss Company, Inc. and subsidiaries who have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Stark Truss Company, Inc. (the Company) is the Plan's administrator and has appointed Reliance Trust as the trustee of the Plan.

Contributions

Employees are permitted to make pre-tax or post-tax (Roth) elective deferrals of up to 90% of their annual pre-tax compensation. Participants who are at least 50 years of age can elect to defer additional "catch-up" contributions. All contributions are limited to the maximum allowed as a deduction under the Internal Revenue Code (IRC).

Effective January 1, 2024, the Plan was amended to provide for an automatic enrollment deferral percentage of 4% for all participants, unless a participant makes an affirmative election for a different amount. There is no automatic escalation feature.

The Company made discretionary employer matching contributions in an amount equal to 40% of employee elective deferrals up to the first 4% of eligible compensation, which resulted in discretionary matching contributions of \$386,095 for the year ended December 31, 2024. The employer match is made based on employee elective deferrals within each biweekly payroll cycle. Effective January 1, 2024, the Plan was amended to change the eligibility service requirement for discretionary employer matching contributions from six months to three months.

Vesting

Participants are immediately vested in all contributions plus earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Company's contribution, plan earnings, and administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are fully participant directed.

Notes Receivable from Participants

Participants are permitted to borrow from their vested interest of their individual account a minimum of \$500 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the participant's vested account balance and are treated as participant directed investments and bear interest at a rate commensurate with local prevailing rates, ranging from 4.25% to 9.50% at December 31, 2024. These notes are generally payable in equal installments of principal and interest through payroll deductions according to the terms of each promissory note.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum distribution or a direct rollover distribution equal to the value of the participant's vested interest in his or her account. The Company has the right to cash out participants who leave the Company if the participants' account balance is \$5,000 or less. A participant having a balance between \$1,000 and \$5,000 may elect to receive either a lump-sum distribution or a direct rollover distribution. A participant having less than a \$1,000 balance must take a lump-sum distribution. Non-terminated employees may make withdrawals from their vested interest as a hardship withdrawal. Hardship withdrawals are subject to additional rules and conditions as outlined in the Plan agreement. Mandatory payouts are typically required to commence no later than April 1 of the calendar year following the calendar year in which a participant attains the age of 70-1/2, unless waived in accordance with the Coronavirus Aid, Relief, and Economic Security Act during 2020.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates that affect reported amounts and accompanying notes. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make note repayments and the plan administrator considers the participant note to be in default, the note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Certain investment management fees, brokerage commissions, and other fees are paid directly by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Company has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

3. Information Provided by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income (loss), net appreciation (depreciation) in fair value of investments, interest and dividends, other income, and benefits paid to participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

4. Fair Value Measurements

The authoritative accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative accounting guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs include quoted prices for similar assets or liabilities in active markets or for identical or similar assets or liabilities in inactive markets. Inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Common/collective trusts: Valued at the daily NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Board of Directors of Stark Truss Company, Inc. would direct the trustee to (a) continue to administer the trust account in accordance with the provisions of the Plan or (b) distribute the assets remaining in the trust account after the payment of all Plan expenses.

6. Income Tax Status

The plan has adopted a non-standardized, prototype plan document sponsored by ADP, Inc. The prototype plan obtained a determination letter dated October 6, 2020, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter, however the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions with Parties In Interest

Reliance Trust Company is the trustee of the Plan and holds all of the Plan's investments. Reliance Trust Company is a party in interest of the Plan as defined by ERISA Section 3(14), and accordingly investment transactions in the funds are parties in interest transactions. Certain legal and accounting fees and certain administrative expenses relating to the maintenance of participant eligibility records are absorbed by the Company.

8. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
