### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Midlands Carrier Transicold 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ### 1. Plan Description

---

The following brief description of the Midlands Carrier Transicold 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on February 1, 2018 to provide retirement benefits for the employees of Reefer Systems, Inc. dba Midlands Carrier Transicold and related employer Carrier Transicold Mid Atlantic (collectively, the Company).

Employees are eligible to make pre-tax and designated after-tax Roth salary deferral contributions and receive safe harbor matching contributions, discretionary matching contributions, and discretionary profit-sharing contributions upon attaining age 18 and completing six months of service. Eligible employees may become participants on the first day of the month coinciding with or next following the date requirements are satisfied. To receive discretionary profit-sharing contributions, participants must be employed on the last day of the Plan year and complete 1,000 hours of service during the Plan year.

#### *Contributions*

Participants may make voluntary pre-tax and designated after-tax Roth salary deferral contributions up to 90% of their annual eligible compensation, as defined by the Plan, up to the maximum dollar limits allowable by law. Employees are automatically enrolled in the Plan with an initial pre-tax salary deferral rate of 5%, which is increased by one percentage point at the beginning of each Plan year, until it reaches a total of 12% of their eligible compensation. At any time, a participant may elect not to contribute or may increase or decrease their deferral rate as allowed under Plan provisions. Participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain limitations.

The Plan is a "Safe Harbor 401(k) Plan" whereby the Company is required to make safe harbor matching contributions equal to 100% of each participant's elective deferral, up to 3% of eligible compensation, plus 50% of the next 2% of eligible compensation. The Company may also make discretionary matching contributions and discretionary profit-sharing contributions (none in 2024 and 2023).

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and an allocation of a) the Company's safe harbor matching contributions, b) the Company's discretionary matching contributions, c) the Company's discretionary profit-sharing contributions and d) Plan earnings and losses. The Company's safe harbor matching contributions and discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Reliance Trust Company (Reliance).

### ***Vesting***

Participants are immediately vested in their contributions, Company safe harbor matching contributions, and earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary profit-sharing contributions plus earnings thereon is based on years of continuous service. Participants are 20% vested after two years of credited service and vesting increases 20% per year until the participant is 100% vested after six years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have up to two outstanding loans at any given time. The notes are secured by the balance in the participant's account and bear interest at 1% over the prime rate at the time the note is issued. Principal and interest are paid ratably through payroll reductions.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to be paid either lump-sum, partial, or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution of payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement plan designated by the plan administrator in the event the participant does not elect a payout option. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan allows for in-service distributions for participants who have reached the age of 59 ½. Participants may also receive hardship distributions as defined by the Plan document. Benefits are recorded when paid.

### *Forfeitures*

Upon termination of employment before normal retirement, disability, or death, the portion of their Company's contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to pay administrative expenses or to reduce the Company's contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$76 and \$74, respectively. During 2024, forfeitures of \$1,566 and \$0 were used to reduce Company contributions and to pay administrative expenses, respectively. During 2023, no forfeitures were used to reduce Company contributions or to pay administrative expenses.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### *Presentation of Participant-Directed Funds*

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for further discussion of fair value measurements.

Purchase and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other fees specifically incurred by or attributable to individual participants are paid from the applicable participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 24, 2025. See Note 7 for a description of a subsequent event.

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance, except for comparing such information certified by the trustee and custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual and Money Market Funds:* Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their Net Asset Value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

*Collective Trusts:* Valued at the NAV of their underlying investments. FASB ASC 820, *Fair Value Measurement and Disclosures*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meet those requirements. Participants can redeem the trust at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participants and distributed as soon as practicable after the termination date.

### 7. Plan Merger

---

Effective August 1, 2025, the Company approved the Plan to be merged into a new plan called the ExcelWise Pooled Employer Plan (ExcelWise Plan). Transamerica Trust Company (Transamerica) is the trustee of the ExcelWise Plan. The merger into the ExcelWise Plan initiated a “black out” period that began July 25, 2025 and continued through August 28, 2025. Funds were not applied to the employee selected funds or withdrawn from the Plan or the ExcelWise Plan until Transamerica had time to accurately complete the merger conversion. All of the Plan’s assets were transferred in August 2025 to the ExcelWise Plan by the conclusion of the black out, and the participants were able to make payroll contributions to the ExcelWise Plan effective on August 1, 2025 and will continue thereafter.
