Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the R S Andrews Services Inc 401(K) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE A--DESCRIPTION OF PLAN

The following description of the R S Andrews Services Inc 401(K) Profit Sharing Plan & Trust ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions:

General: The Plan is a defined contribution plan covering substantially all employees of R.S. Andrews Services, Inc. ("the Plan Administrator" and "the Employer") and R.S. Andrews Services of South Carolina, LLC. All employees who have obtained twenty-one years of age are eligible to participate after completing six months of service following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: Plan participants are allowed to make contributions from their pre-tax compensation as well as employee elective after-tax contributions, which are deducted from participant's after-tax earnings. Total pre-tax and elective after-tax contributions may not exceed 90% of the participants' plan compensation. The Plan document allows for discretionary matching and non-elective Employer contributions. No contributions were made by the Employer during the year ended December 31, 2024.

The Plan includes an automatic deferral feature for all newly hired eligible employees. The employer automatically withholds 3% of the employee's compensation as an employee elective contribution. Employees that have been automatically enrolled may request no deferral of compensation or may select an alternative deferral percentage.

Participant Accounts: Each participant's account is credited with his or her contributions, earnings or losses, less an allocation of Trustee fees and other expenses, and any Employer matching contributions or allocations of Employer non-elective contributions. Allocation of Employer non-elective contributions are based on participants' compensation, as defined in the Plan. All investments are participant directed. Participants may change their investment options on a daily basis.

Vesting: Participants are immediately vested in their voluntary contributions and allocated earnings thereon. Employer contributions and earnings thereon vest on a vesting schedule of 0% for less than 2 years of service, and 20% per year for two to six years of service. A participant becomes fully vested after six years of credited service, or in the event of participant death or disability, or normal retirement.

Forfeitures: Forfeited amounts can be used to pay administrative expenses of the Plan and to reduce future Employer contributions to the Plan.

Notes Receivable from Participants: Participants may borrow from their vested accounts a minimum of \$500, up to a maximum of \$50,000, or 50 percent of their vested account balances, whichever is less. Participants may only have one loan outstanding at any given time. Loans are repaid through payroll deductions over periods of up to five years, unless the loan is for the purchase of a participant's primary residence, in which case, repayment may not extend beyond 30 years. The loans are secured by the balance in the participant's vested accounts and bear interest at the prime rate plus 2% as determined at the inception of the loan.

Payment of Benefits: In the case of termination of service due to death, normal retirement (age 65), retirement due to permanent disability, or termination of employment, participants may elect to receive the value of their accumulated Plan benefits, in accordance with the provisions of the Plan, in lump-sum distributions or installment payments. Application may be made for withdrawal of funds from employee elective contribution accounts while the participant is an employee in the case of a financial hardship, as defined in the Plan, or when the participant reaches age 59 ½ from all vested accounts.

Administration: The Plan is administered by the Employer. All funds in the Plan are held in trust by Reliance Trust Company (the "Trustee"). The Trustee invests participants' account balances as directed by the participants.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan follows the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative guidance.

The financial statements of the Plan are prepared utilizing the modified cash basis method of accounting, which differs from generally accepted accounting principles, which uses the accrual method.

The Plan's investments are stated at fair value, as further described in Note C. Investment securities, in general, are exposed to various risks, including credit, interest and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in values of investment securities will occur and that such changes could materially affect the amount reported in the statements of net assets available for benefits--modified cash basis.

Purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Realized gains and losses on the sale of investments are calculated based on the difference between the selling price and cost on an average

cost basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as the change in unrealized gains/losses for securities held at the end of the year.

Notes receivable from participants are reported separately from Plan investments and measured at their unpaid principal balance.

Contributions are recorded on the modified cash basis, which recognizes participants' contributions and any related Employer matching contributions or Employer discretionary non-elective contributions, at the time such contributions are received in cash by the Plan.

Benefits paid to participants are recorded when paid.

The Employer may pay some of the administrative expenses of the Plan.

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the accounting guidance are described below:

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

Mutual funds: Valued at the quoted market price, which represents the net asset value of shares held by the Plan at year end.

Collective investment trust: Valued based on the market value of its underlying investments. The collective investment trust does not have a finite life, significant restrictions on redemptions, and the Plan has no unfunded commitment related to this investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D--TRANSACTIONS WITH PARTIES IN INTEREST

The Plan has an agreement with the Trustee to maintain the investments of the Plan and to provide administrative and participant recordkeeping services for the Plan. For the year ended December 31, 2024, contributions to the Plan of \$418,847 were deposited with the Trustee for investment, and participants of the Plan received distributions of \$211,349 from funds held by the Trustee. At December 31, 2024 and 2023, the Plan had \$2,082,239 and \$1,657,968, respectively, of assets under the Trustee's custody.

NOTE E--TAX STATUS

The Plan is intended to satisfy the tax qualification requirements under Section 401(a) of the Internal Revenue Code; therefore, the trust funds of the Plan are intended to be exempt from federal income taxes. The amended Plan has not requested a favorable determination letter from the IRS since the prototype on which the Plan is based has been determined to be qualified under Section 401(a) of the Internal Revenue Code.

NOTE G--PLAN TERMINATION

The Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

NOTE H--SUMMARY OF INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The total value of the Plan's assets was \$2,082,239 and \$1,657,968 at December 31, 2024 and 2023. The Plan's Trustee (a qualified institution) has supplied the Plan Administrator with a certification as to the completeness and accuracy of all information presented in the accompanying statements of net assets available for benefits--modified cash basis as of December 31, 2024 and 2023, and in the statement of changes in net assets available for benefits--modified cash basis for the year ended December 31, 2024, in regards to investment activity.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.
