In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.


Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

to or is derived from the certified investment information, we compared such information to the related certified information.

Note 1 – Plan Description

The following description of the B-Squared Medical 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees (defined as employees expected to work 1,000 or more hours during a year) of B-Squared Medical, LLC and affiliates (the “Company”). Employees are immediately eligible to participate in the Plan upon starting employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute any percentage or amount up to 90% of pretax annual compensation, as defined in the Plan, up to the maximum allowed by the *Internal Revenue Code (IRC)*. Effective June 1, 2024, the Plan was amended to allow Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions to the participants’ accounts each payroll period. The Company matches participant contributions at a rate of 100% of the first 4% of the participant’s deferrals. Contributions are subject to certain limitations. Additional amounts may be contributed at the discretion of the Company. There was no discretionary employer contribution made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and an allocation of Plan earnings (losses), and is charged with benefit payments, transaction fees related to notes receivable from participants and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and the Company’s safe harbor matching contributions plus earnings thereon. Vesting in the Company’s discretionary contributions, if any, plus earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants also become fully vested upon death or disability or normal retirement age.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes are secured by the balance in the participant’s account and bear interest at the Prime Rate plus 1%. At December 31, 2024, interest on loans ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon attainment of normal retirement at age 65, termination of employment, or in the case of death or disability, a participant or their beneficiary may elect a single lump-sum, partial payments, or installment payment in the amount equal to the participant's vested account balance. In-service withdrawals at age 59 ½ are permitted, subject to provisions described in the Plan document. Effective June 1, 2024, the Plan was amended to allow hardship withdrawals. The Plan allows for terminated participant vested account balances of \$7,000 or less to be automatically distributed without the participant's consent.

Administrative Expenses

Plan fees and administrative expenses are paid by the Company or the Plan on a discretionary basis.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10. These accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, forfeited account balances totaling \$-0- were used to reduce employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through September 30, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or 2 inputs are not available.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the Invesco Stable Asset common collective trust fund is based on the market value of underlying investments. This fund invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

While the underlying asset values are quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The Great Gray Trust Company Large Cap Value common collective trust fund is valued on a per unit basis using the NAV provided by the issuer of the collective investment trust fund, which reflects the fair value of the underlying investments comprising the separate pooled funds. The NAV is based on the value of the underlying assets owned by the fund, minus

its liabilities, and then divided by the number of shares outstanding. The NAV per share is used as a practical expedient which is exempt from the fair value hierarchy.

Note 4 – Investment Contract

The Plan holds an investment in the Invesco Stable Asset Trust. Included in this collective investment trust fund are indirect investments in synthetic guaranteed investment contracts and short-term investment funds. These contracts are considered to be benefit-responsive and since these contracts are purchased in the open market, are required to be stated at fair value. The objective of the fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The average yield for this fund is as follows:

Note 5 – Related-Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Investments are held and managed by the Plan's Trustee. Therefore, these transactions qualify as related-party transactions. However, these transactions are not considered prohibited transactions. Fees paid by the plan for administrative services amounted to \$26,909 for the year ended December 31, 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by ADP, LLC and has not requested a determination letter but rather has relied upon the *Internal Revenue Service* opinion letter dated October 6, 2020, issued on the pre-approved plan stating the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the *Internal Revenue Service*. The Plan Administrator has analyzed the tax positions taken by the plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
