INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor, Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Orthopaedic Associates, P.A. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan of Orthopaedic Associates, P.A. (Company) and was established on January 1, 1987. The Plan is subject to the provisions of ERISA.

The plan document was amended effective January 1, 2024. Significant changes to eligibility plan provisions are discussed below.

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0 Act) was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed in these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: The Plan covers substantially all employees. Employees who are nonresident aliens, or who are covered by a collective bargaining agreement, are not eligible to participate in the Plan. Employees are eligible to participate once they are age twenty-one or older and have attained 12 months of service with no hours requirement. Employees may enter the Plan on the first day of the month coincident with or following the attainment of these requirements.

Prior to January 1, 2024, employees were eligible to participate once they had attained one year of service, with 1,000 hours of service during such period, and were age twenty-one or older. Employees could enter the Plan on the first day of the first and seventh months of the plan year coincident with or following the attainment of these requirements.

Contributions: Each year, participants may elect to contribute up to 90% of their eligible compensation (as defined), up to the maximum allowable contribution under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company provides for the following contributions on behalf of participants:

A safe harbor nonelective contribution equal to 3% of each eligible employee's compensation, as defined by the Plan. For 2024, the Company's safe harbor nonelective contribution totaled \$156,618, net of forfeitures. This amount was remitted in 2025 and is recorded as a receivable on the Statement of Net Assets Available for Benefits as of December 31, 2024.

A discretionary profit sharing contribution as determined by the Board of Directors. Profit sharing contributions are to be allocated according to the grouping method, as defined, to any eligible employee regardless of service completed during the year or employment status at the end of the plan year. For 2024, the Company's discretionary profit sharing contribution totaled \$54,518. This amount was remitted in 2025 and is recorded as a receivable on the Statement of Net Assets Available for Benefits as of December 31, 2024.

Qualified Nonelective Contributions (QNECs) as defined in the Plan. No QNECs were made for 2024.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Participant Accounts: Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and Company contributions into various registered investment companies (mutual funds) offered by the Plan. For those participants who do not make an investment selection, their contributions and the Company contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions, QNECs and the Company's safe harbor nonelective contribution, plus earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service. Regardless of the vesting schedule, participants will become fully vested upon death, total and permanent disability or upon reaching the normal retirement age of 65 or early retirement age of 55 and five years of service, while still employed.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at a rate based on the prime rate plus 1% at the time of loan origination and can only exceed a repayment period of five years for the purchase of a principal residence. Three notes may be outstanding at a time; however, only one of the three notes may be outstanding for the purchase of a principal residence. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums, substantially equal installments and partial withdrawals and are payable upon termination of employment, death, normal retirement, early retirement or disability. The Plan shall make automatic distributions of vested account balances that are less than \$7,000 (as updated by the SECURE 2.0 Act) in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59 ½ are also permitted, subject to a minimum amount of \$500 and provisions defined in the plan document.

Forfeitures: Forfeitures of the Company's discretionary profit sharing contribution portion of a participant's account (due to participants' termination prior to full vesting) may first be used to pay any administrative expenses then used to reduce any employer contribution on an annual basis. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$122,175 and \$2,473, respectively. During 2024, forfeitures of \$2,725 were used to reduce the 2023 discretionary profit sharing contribution.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions: Contributions from plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation or in which participant compensation is earned.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment. Investment advisor fees and an annual recordkeeping fee are charged to each participant's account based on the ratio of the participant's account balance to the total of all participants' account balances and are included in administrative expenses. Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, a qualified institution and trustee of the Plan.

NOTE 5 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed ADP, LLC, by a letter dated October 6, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

ADPRS provides certain administrative services to the Plan pursuant to the Administrative Services Agreement (the Agreement) between the Company and ADPRS. Pursuant to the Agreement, participants pay to ADPRS an annual recordkeeping fee and transactional fees relative to notes and distributions. In addition, ADPRS receives, as additional compensation, certain fees from one or more of the Plan's investment funds, or from affiliates or agents of such investment funds, for services provided by ADPRS with respect to such investment funds. These fees reduce the amount of expenses that would otherwise be payable pursuant to the Agreement. Further, ADPRS receives compensation in the form of interest or similar income (float) on contributions, plan loan repayments and withdrawals in process from the Plan. Fees paid by the Plan to ADPRS amounted to \$24,808 for 2024.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their Company discretionary profit sharing contributions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 24% and 21%, respectively, of net assets available for benefits is invested in the American Funds Target Date Retirement Funds; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.

As of December 31, 2024 and 2023, 37% and 35%, respectively, of net assets available for benefits is invested in the Vanguard LifeStrategy Growth Portfolio. As such this is considered to be a concentration of credit risk.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, ADP Retirement Trust Services, LLC was appointed as the Plan's trustee upon the resignation of Reliance Trust Company on December 31, 2024.
