## **Independent Auditor's Report**

To the Plan Administrator

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements***

We have performed an audit of the financial statements of **Newrest IAH 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## 1. DESCRIPTION OF THE PLAN

The following description of the **Newrest IAH 401(k) Plan** (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### General

The Plan is a 401(k) Profit Sharing Plan covering all full-time employees of Newrest IAH, LLC (the “Company” or the “Employer”) and participating affiliates who have completed three months of service and are twenty-one years of age or older. Eligible employees begin participating in the Plan on the first day of the month coinciding with, or next following, the date the employee meets the eligibility requirements. The Plan is designed to qualify under sections 401(a) and 401(k) of the Internal Revenue Code (the “Code”) as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan Administrator is responsible for oversight of the Plan. The board determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

The Plan has arranged for Reliance Trust Company (“Reliance” or “Trustee”) to serve as trustee, and ADP Retirement Services (“ADP”) to provide record keeping services for the Plan.

### Contributions

Each year, participants may contribute from 1% to 90% of eligible earnings, as defined in the Plan, subject to the maximum amount allowable by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a matching contribution of 25% of eligible deferrals up to 4% of eligible earnings. Effective September 1, 2024 the matching contribution was increased to 50% of eligible deferrals up to 4% of eligible earnings. The Company may also decide to make a nonelective contribution to the Plan, although it is not required to do so. The nonelective contribution will be allocated to all employees eligible to participate in the plan in proportion to each employees’ eligible earnings compared to the eligible earnings of other employees who share in the contribution. If made, the nonelective contribution will be allocated as of the end of each Plan year.

### Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and (b) the Plan’s earnings or losses. Allocations are based on participant earnings or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Vesting

Participants are vested immediately in employee contributions, rollover contributions, and actual earnings thereon. Vesting in the Company's employer matching and nonelective contributions is based on years of continuous service as follows:

### Investment Options

Upon enrollment in the Plan, a participant may direct their contributions in any of the investments listed in the accompanying supplemental schedule of assets. Unless limited by restrictions imposed by individual investment options and subject to redemption fees, participants may change their investment options on a daily basis.

### Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Participant loans are secured by the participant's vested balance and bear a reasonable interest rate. The interest rates on outstanding notes receivable as of December 31, 2024 and 2023 ranged from **4.25%** to **9.5%** and from 4.25% to 9.5%, respectively. Maturities on notes receivable from participants as of December 31, 2024 and 2023 ranged from **2025** to **2029** and 2024 to 2028, respectively.

### Benefit Payments

Participants may receive the vested portion of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Under certain circumstances, including financial hardship, participants may withdraw the vested portion of their Plan account. The plan administrator determines financial hardship. Benefit payments are made in a lump sum distribution or rollover contributions to another plan.

### Forfeitures

As of December 31, 2024 and 2023, the values of forfeited non-vested accounts were **\$16,099** and \$9,219, respectively. These accounts can be used to reduce future employer contributions or pay Plan expenses. For the years ended December 31, 2024 and 2023, **\$6,886** and \$9,209 of forfeited balances were used to offset employer contributions, respectively.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") using the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Revenue Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to determine the fair value of shares of registered investment companies. The investment in common collective trusts are stated at unit value, which is based on the current fair values of the underlying assets of the fund. There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded on the accrual basis and dividend income is accrued on the ex-dividend date. Net appreciation/ (depreciation) for each year includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

### Unit Values

Individual participant accounts for common collective trust accounts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

### Contributions Receivable and Allowance for Credit Losses

Employee contributions which are withheld through payroll deductions and have not been credited to the participant accounts as of the end of the fiscal year are recorded as contributions receivable. An allowance for credit losses is deemed unnecessary and is not provided as of December 31, 2024 and 2023.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account as administrative expenses and are expensed when they are incurred. If a participant ceases to make repayments and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded. Principal and interest are paid to the Plan through payroll deductions. Notes receivable from participants are exempt party-in-interest transactions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Benefit Payments**

Benefit payments to participants are recorded upon distribution.

### **Administrative Expenses**

Expenses related to investment advisory services, management fees, and maintenance of participant accounts are paid by the Plan. Expenses related to Plan administration are paid directly by the Company and are excluded from these financial statements.

## 3. **TAX STATUS**

The Plan obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan's form 5500 remains open to examination for 3 years from the date filed.

#### 4. **INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

#### 5. **FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value methods used by the Plan may produce a fair value calculation not indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 7. PARTY-IN-INTEREST TRANSACTIONS

Company contributions and investments are held and managed by Reliance Trust Company, the Plan's Trustee, which invests cash received, interest and dividend income, and makes distributions to participants. Therefore, these transactions are considered exempt party-in-interest transactions. The Trustee also administers the payment of interest and principal on the notes receivable from participants, which is reimbursed to the Trustee through contributions as determined by the Company. Notes receivable from participants are also considered to be party-in-interest transactions.

The Company has contracted with ADP to provide recordkeeping services. Any payments made for these services are considered to exempt party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain advisory, distribution, and loan servicing fees are paid by plan participants. All other administrative expenses, including audit fees, were paid by the Company, a party-in-interest, for the year ended December 31, 2024.

## 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
