**Scope and Nature of the ERISA Section 103(a) (3) (C) Audit**

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**1. Description of the Plan**

The following description of the Vision Precision Holdings 401(k) Plan (D/B/A Now Optics 401(k) Plan) (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

Vision Precision Holdings ("Company/Employer") adopted the Plan effective January 1, 2016. The Plan is a defined contribution plan covering substantially all employees of the Company who have completed at least two (2) months of employment and are age twenty one (21) or older. Additionally, an affiliated entity is a participating employer of the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Plan is administered by the Employer. Automatic Data Processing, LLC ("ADP") is the third party administrator of the Plan assets. The Plan Trustee is Reliance Trust Company.

Contributions

Subject to certain limitations, participants could elect to contribute to the Plan from a minimum of 1% up to 90% of their pre-tax annual compensation as defined by the Plan. Participants may also make Roth deferrals to the Plan. Participants are automatically enrolled to contribute 4% of eligible pretax compensation, unless they make alternative election. Contributions are automatically increased each year by 1% up to max of 15% unless participant makes alternative election. Participants direct the investment of their contribution into various investment options offered by the Plan. The Plan does not provide for matching or any other contribution made by the Company to the Plan. Contributions are subject to certain limitations.

Participant Accounts

A separate account is established for each participant upon enrollment in the Plan. Participants determine the percentage in which contributions are to be invested in each fund. Each participant's account is credited with the participant's contributions, the employer's contributions, and an allocation of the Employer's contribution and Plan's earnings as defined and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. At December 31, 2024, there were 1,438 participants of which 1,124 are active and 314 are retired or separated and entitled to receive benefits. At that date, 1,257 participants have account balances. Participant loans were permitted.

Eligibility

Employees are eligible to participate in the salary deferral portion of the Plan upon hire. To participate in the employer contribution portion of the Plan, employees must have completed at least one (1) year of service with the Company, as defined in the Plan, and be at least 21 years old. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options offered by the Plan.

Participant Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's matching and discretionary contribution portion of their account plus actual earnings is immediate if participating in the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts from \$500 up to the lesser of \$50,000 or 50 percent (50%) of their vested account balance. Loan terms are not to exceed 5 years, except for purchasing a primary residence, for which a 30 year term is permitted, and bear interest at the prime rate as published by the Wall Street Journal on 14<sup>th</sup> day of month in which loan originates, plus 2%. Notes receivable are considered a directed investment of participant's accounts under the Plan. Principal and interest is paid ratably through payroll deductions and are credited to the participant's account. Failure to make payments under terms of note are considered an event of default. Under certain circumstances, after having taken all reasonable action to secure collection, a defaulted note may be considered a distribution. Participants may only have one loan outstanding at a time.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into various investment options. Participants may change their investment options, at times designated by the Plan.

Forfeitures

Forfeitures of terminated participants' non-vested accounts may be used to reduce the employer's matching contribution for the year in which the forfeiture occurs or to pay the Plan's administrative expenses.

Hardship Withdrawals

Hardship withdrawals are permitted by the Plan for medical expenses, costs to purchase residence or prevent eviction and payment of college tuition. The participant can only withdraw his elective deferral.

Vesting/Payment of Benefits

Upon retirement, a participant may elect to receive payment for the value of their account through a lump-sum payment or may receive installments payable over a specified period of time, as defined. Participants are 100% vested in their contributions.

Withholding Taxes

The Plan is required to withhold 20% of distributions not directly transferred to another qualified plan or IRA account. These funds are then remitted to the Internal Revenue Service.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan agreement. The Plan provides for distributions at age 59 ½ while the participant is still currently employed. The total vested portion of a participant's account balance is distributed in the form of a lump sum payment, installments or an annuity. Participants experiencing financial hardships may withdraw a portion of their account balances as defined in the Plan.

Upon termination of service, an employee receives payment for the vested value of their account.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting. Participant and employer contributions are recorded in the period in which contributions are withheld from salaries and wages by the employer.

Estimates

The preparation of financial statements could require the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures of assets at the date of financial statements and the reported amounts of addition and deductions in assets available during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are presented at fair value. Investments are valued by the Trustee based upon the fair value of investment held by the Fund and the number of shares outstanding. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in unrealized appreciation (depreciation) for the period are reflected in the statements of changes in net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes are reclassified as distributions based upon terms of the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administration of the Plan

Certain administrative expenses of the Plan may be paid by the Company. The Plan is not required to reimburse the Company for any administrative expenses paid by the Company. Expenses not paid the Company are paid by the Plan.

Date of Management's Review

Subsequent events have been evaluated for potential recognition or disclosure through July 28, 2025 which is the date the financial statements were available to be issued.

**3. Notes Receivable from Participants**

At December 31, 2024, there were one hundred and eighteen (118) participant loans amounting to \$300,162 with interest rates between 5.25% and 10.5%. Loan balances ranged from approximately \$200 to \$45,000. During 2024, the Plan provided new loans totaling \$272,657. During 2024, total principal repaid on all loans amounted to \$145,829 and loans deemed distributions amounted to \$38,310. Interest income for 2024 on participant loans was \$13,008. No allowance for credit losses has been recorded. If a loan is in default, the participant loan is reduced and a benefit payment is recorded. No loans are in default at December 31, 2024.

**4. Tax Status**

The Plan was determined by the Internal Revenue Service to be "qualified" plan under Section 401(a) of the Internal Revenue Code of 1986, and, accordingly, the Plan is exempt from federal income taxes. In the opinion of the Plan Administrator, the Plan is currently being operated in accordance with Plan agreement and in conformity with applicable IRC provisions and has no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements and therefore exempt from federal income tax. No provision for taxes has been included in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax periods for 2021, 2022 and 2023 are open to audit.

**5. Investments (Unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure Under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the custodians of the Plan (Transamerica Life Insurance Company) except for comparing such information to the information included in the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value and contract value of investments and interest and dividends as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

The Plan invests in unallocated stable value core option contracts with Reliance Trust Company ("RTC"). RTC maintains the contributions in the RTC General Account. RTC groups the premium dollars it receives over defined time periods for the purpose of determining the crediting rate to participant's accounts. The crediting rate is determined, in part, by the net investment earnings rate of the RTC assets, minus a charge for administrative expenses and an amount set aside for contingency reserves. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and determined semiannually. The interest rate credited to participants for the Plan was 1.80% for the year ending December 31, 2024.

Certain events limit the Plan's ability to transact at contract value with RTC. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

**6. Financial Information Certified by Plan Trustee**

Under the Department of Labor's regulations, certain assets and related information held by a bank, trust company or similar institution, or an insurance company, that is regulated and subject to periodic examination by a state or federal agency does not have to be audited, provided the plan administrator exercises this option and the institution holding the assets certifies the required information. Reliance Trust Company has provided certification as to the completeness and accuracy. Investment assets, net appreciation (depreciation) in fair value of investments, and interest, dividend and other income contained in the statement of net assets available for benefits, statement of changes in net assets available for benefits, and supplemental schedules as of and for the year then ended December 31, 2024 have been certified as accurate and complete by the Plan trustee, in accordance with 29CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**7. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under GAAP are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in active markets; quoted market prices in markets that are not active; or model-derived valuations or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Registered Investment Company Accounts*: Valued at fair value established by the Custodian on the last business day of the Plan year, which is composed primarily of the value at the daily closing price as reported by the underlying mutual fund.

*Common collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024 and 2023, the reported value and the fair value of the Plan's investments are equivalent. All Plan assets are considered Level 1. See Note 5 for investment details.
