### **1. Description of Plan**

The following description of The Moran Group, Inc. 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all full-time employees of The Moran Group, Inc. and Moran Cadillac-GMC, Inc. (Company), who have completed one month of service and are age twenty-one or older. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Trust**

A trust has been established under the Plan to hold the Plan's assets. The Company has appointed a third party as trustee.

#### **Contributions**

Each year, participants may contribute up to the maximum dollar limit of annual compensation not to exceed Internal Revenue Code (IRC) limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan provides for discretionary matching Company contributions to the Plan. The Company has not made any discretionary matching contributions to the Plan for 2024 or 2023. Participant contributions of certain highly compensated participants may also be limited based on contribution non-discrimination tests described in IRC Sections 401(k) and 401(m).

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of Company discretionary matching contributions, and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested in their account balances immediately upon their entry date.

#### **Investment Options**

A participant may direct contributions in any of the investment options offered by the Plan.

### **1. Description of Plan (continued)**

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, participants will receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than the participant's life expectancy determined at the time of distribution, or election of a joint, survivor, or life annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined by the Plan document.

#### **Forfeited Accounts**

Forfeited nonvested accounts are used to reduce Plan administrative expenses and Company cash contributions, if any. There were \$12,600 of forfeitures used during the year ended December 31, 2024 to pay Plan administrative expenses (no forfeitures were used during the year ended December 31, 2023). There were \$162,759 of forfeited account balances as of December 31, 2024, and \$170,405 as of December 31, 2023.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except the stable value fund which is valued at contract value. See Note 4 for more information on the stable value fund. See Note 5 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **2. Summary of Significant Accounting Policies (continued)**

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a market rate. Principal and interest are paid ratably through payroll deductions.

Participant loans are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan agreement.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan is required to distribute the excess contributions to the applicable participants prior to March 15 of the following year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. In determining fair value, the Plan uses various methods including market, income, and cost approaches. Based on these approaches, the Plan often utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about risk and/or the risks inherent in the inputs to the valuation technique. These inputs can be readily-observable, market-corroborated, or generally unobservable inputs. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide the following information according to the fair value hierarchy.

#### **Fair Value Measurements (continued)**

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect an entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3. As of December 31, 2024 and 2023, the Plan had no investments classified as Level 3.

For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Plan Administrative Expenses**

The administrative expenses of the Plan, if not paid by the Company, are paid first from the forfeitures, if any, and then from the Plan. All such costs and expenses paid from the Plan shall, unless allocable to the accounts of particular participants, be charged to the accounts of all participants as provided in the Plan agreement.

#### **Subsequent Events**

Management has evaluated subsequent events through September 18, 2025, which is the date the financial statements were available to be issued.

Accordingly, the investment balances, participant notes receivable, investment income, and interest income on participant notes receivable included in the accompanying financial statements and supplementary information was obtained from data that has been prepared and certified as complete and accurate by the trustee, Reliance Trust Company. This certified information has not been audited by independent auditors.

### **4. Fully Benefit-Responsive Investment Contracts**

During 2024 and 2023, the Plan held investment contracts that comprise traditional investment contracts that meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. With traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

Management has assessed the probability of events occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants as minimal.

### 4. Fully Benefit-Responsive Investment Contracts (continued)

MetLife Reliance Stable Value Fund is an investment in the general account of MetLife and its value is not guaranteed by Reliance Trust Company as a going concern. Events and circumstances may occur that permit MetLife to terminate the contract or settle at amounts different than contract value if contract value is less than market value.

Although participants generally may withdraw from the MetLife Reliance Stable Value Fund without restriction, Reliance Trust Company may impose a hold period at the contract level in the event of full or partial contract discontinuance.

### 5. Fair Value Measurements

Mutual funds are stated at fair value, which has been determined by quoted market prices of the underlying securities as reported by the custodian of the Plan and are determined in active markets.

### **6. Income Tax Status**

The IRS has determined and informed the Company by a letter dated October 6, 2020 that the Plan is a qualified plan under Section 401 of the IRC. Although the Plan has been amended since the date of the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is tax exempt.

Generally, tax years 2021 through the current year remain open to examination. Plan management does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, the respective participant interest, net of any termination fees, will be distributed to the participants according to their respective account balances.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Parties-in-Interest**

ADP Retirement Services is the record keeper and third-party administrator. SageView Advisory Group is the investment advisor. Reliance Trust Company is the trustee. Pentegra Retirement Services assists the Company with Plan responsibilities and is the plan administrator. Andrews Hooper Pavlik PLC is the Plan's auditor. These entities qualify as parties-in-interest. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Certain administrative expenses of the Plan related to the fiduciary/plan administrator and custodial/trustee services have been paid by the Company during the years ended December 31, 2024 and 2023. The Company does not expect reimbursement from the Plan for these expenses; therefore, such expenses have been excluded from these financial statements.

Notes receivable from participants are also considered party-in-interest transactions.

### **11. Subsequent Events**

Starting January 1, 2025, ADP Retirement Services replaced Reliance Trust Company as the Plan's trustee and custodian. Effective January 1, 2025, the Plan was amended to add automatic deferral provisions and automatic deferral increases. Participants will be automatically enrolled at 3%. The automatic deferral percentage will increase by 1% up to a maximum of 10% as soon as administratively feasible beginning on or after each succeeding anniversary date following that date that the eligible employee's automatic deferrals first were implemented.
