Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at year end) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of Greater Midland Community Centers, Inc. Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to qualifying employees of Greater Midland Community Centers, Inc. (Organization). To be eligible to participate in the Plan, an employee must have attained the age of twenty-one, have completed at least one year of service, and be a full-time or part-time employee who has worked at least 1,000 hours during such plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's match, an allocation of earnings on investments, and charged with administration charges, as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants have the option of determining the nature of individual investments in their accounts. The accounts may be invested in such separate investment programs as the Plan may make available for this purpose. The Plan currently offers several investments in registered investment companies (mutual funds), common collective trusts, and cash equivalent funds. Organization contributions are automatically invested and subject to the same allocation percentages as the participant contributions.

Contributions

Participants may contribute up to 90% of their annual compensation, not to exceed relevant Internal Revenue Code section limitations. Participants can elect to make Pre-tax deferrals and Roth deferrals. Subject to certain limitations, the Plan sponsor makes a safe harbor matching contribution of 100% of the first 6% of compensation a participant elects to contribute to the Plan, up to 6% of participant compensation. The participant's contribution and safe harbor match is invested in various investment options as directed by the participant.

1. Description of Plan (continued)

Vesting

The Plan is a safe harbor plan. Therefore, all participant and matching contributions are immediately vested.

Forfeited Accounts

The balance of forfeited nonvested accounts was \$0 as of December 31, 2024 and 2023. Forfeited nonvested accounts from prior years were used to reduce employer contributions by \$259 in 2023, there were no forfeited nonvested accounts used to reduce employer contributions in 2024.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account or installment payments under various annuity options beginning on the participants' normal retirement date.

Notes Receivable From Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested benefit under the Plan. Loan terms range from one to five years or up to 30 years for the purchase of a principal residence. The loans are secured by up to 50% of the participants' vested interest in the Plan and bear interest at a rate comparable to rates being charged by lending institutions in the local area as determined by the Plan Administrator. The loan principal and interest is repaid ratably through bi-weekly payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. No allowance for credit losses have been recorded as of December 31, 2024 or 2023.

Administrative Expenses

The Plan's administrative expenses represent certain fees charged directly to participant accounts related directly to transactions or events associated with individual accounts. These include participant loan fees, surrender charges, plan asset conversions to new investment providers, and asset management fees.

Other expenses of administering the Plan are paid directly by the Organization and include salaries, accounting, and legal costs and qualify as party-in-interest transactions that are exempt from prohibited transaction rules.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments

The Plan's mutual fund investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the investment date. Mutual funds are stated at quoted market prices of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

The Plan's common collective trust is stated at net asset value as a practical expedient to estimate fair value.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The change in aggregate fair value and the cost of investments purchased, sold, and held is reflected in the statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued.

3. Financial Data Certified by the Trustee - Unaudited

The Plan's financial information and data was certified by ADP Retirement Services for the period February 1, 2024 through December 31, 2024, and Newport Trust Company, LLC for the period January 1, 2023 through February 1, 2024 in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the investment balances, interest and dividends, and net appreciation (depreciation) in fair value of investments included in the financial statements and supplemental schedule were obtained from data that has been prepared and certified as complete and accurate by the trustees. ADP Retirement Services became the Plan trustee effective February 1, 2024. This certified information has not been audited by independent auditors.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (continued)

Following describes the valuation methodologies used for Plan assets measured at fair value.

Mutual funds: Stated at fair value, based on quoted market prices in active markets, of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Plan is a non-standardized prototype plan. The prototype plan obtained a notification letter dated March 31, 2008, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since then; however, the Plan Administrator believes that the Greater Midland Community Centers, Inc. Retirement Savings Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Generally, tax years from 2021 through the current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and non-forfeitable.

7. Transactions with Parties-in-Interest

The Plan's investments were managed by Newport Trust Company, LLC (Newport) through February 1, 2024, and the year ended December 31, 2023, and ADP Retirement Services (ADP) managed the investments during the period of February 1, 2024 through December 31, 2024. Newport was the Plan trustee during the period of January 1, 2024 through February 1, 2024, and for the year ended December 31, 2023. ADP and its affiliates are the Plan trustee and record keeper for the period starting February 1, 2024 through December 31, 2024, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Newport and ADP for investment management services were \$24,932 for the year ended December 31, 2024, and the fees paid to Newport were \$46,183 for the year ended December 31, 2023. The auditor is also considered a party-in-interest for audit services provided to the Plan.

8. Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
