**INDEPENDENT AUDITOR'S REPORT**

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Hilltoppers, Inc., 401K Profit Sharing Plan and Trust, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 (ERISA)*, as permitted by ERISA Section 103(a)(3)(C). **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Hilltoppers, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan covering all employees who are age 21 or older; however, union employees; nonresident aliens; leased employees are excluded. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Reliance Trust Company serves as the Plan’s custodian and Tammie Hyder acts as the Plan Administrator.

**Participation** – Employees who have attained 21 years of age are eligible to participate in the Plan. After completing one (1) year of service, the employees are eligible to enter the plan. However, union employees; nonresident aliens; and leased employees are excluded.

**Contributions** – Each year, participants may contribute up to 90% of pretax annual compensation as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as options for participants. After one year of service, the Participants are eligible to enter the Plan and have Employer Company match up to 100% of elective deferrals for qualifying contributing participants which does not exceed 6% of compensation.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

**Investments** – Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investments options offered by the Plan.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the employer matching contributions after six years of service. Forfeitures are applied to reduce employer contributions in the same plan year in which they occur.

**Forfeited Accounts** – At December 31, 2024 and 2023, there were forfeiture balances of (\$7,626.84) and \$193.20 respectively. According to the plan document, any forfeitures are to be used to pay appropriate Plan expenses, to reduce Employer Contributions (other than Elective Deferrals), or as an Employer Profit Sharing contribution allocation in the ratio that each Participant’s compensation for the plan year bears to the total compensation of all participants for such plan year (or any combination of the foregoing).

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to 50% of their nonforfeitable account balance. Under no event will the loan amount exceed \$50,000. The notes are secured by the balance in the participant’s account and bear interest at prime rate plus 1%. Principal and interest is paid ratably through bi-weekly payroll deductions.

**NOTE 1 – DESCRIPTION OF PLAN (continued)**

***Payment of Benefits*** – On termination of service due to retirement, death, or disability, a participant may elect to receive either a lump-sum amount, partial payments, installment payments, or annuity contracts equal to the value of the participant’s vested interest in his or her account. Certain in-service benefit withdrawals are also permitted.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan’s valuation policies. See Note 4 for discussion of Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

The Plan’s Administrative Expenses are paid by the Plan.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The Fair Value Measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

**Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U. S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Level 2 Fair Value Measurements**

The fair value of common collective trusts (CCT) are based on the new asset value of their underlying investments. Common collective trusts, while individual securities held by the CCT might be traded on active markets, the CCT itself is not actively traded.

**NOTE 5 – TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed ADP, Inc., trustee, by letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code* (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Company believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements for the years ended December 31, 2024 and 2023. The following years remain subject to examination by the IRS: 2022, 2023, and 2024.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend or discontinue the Plan at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. **NOTE 9 – PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan, and therefore, the investment transactions qualify as party-in-interest transactions. The Plan's investment fees paid to Reliance Trust Company are netted against investment returns through each individual employee account.

**NOTE 10 – SUBSEQUENT EVENTS**

For the year ended December 31, 2024 subsequent events were evaluated through September 17, 2025, which is the date the financial statements were available to be issued. Hilltoppers, Inc. changed payroll/retirement companies. The change went into effect on January 1, 2024. Hilltoppers went from using Paychex to ADP. The Secure Act 2.0 has several provisions that will go into effect during the 2024 audit year.
