**Note 1: Description of the Plan**

The following description of Foxconn Assembly 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the *Plan Document* and *Summary Plan Description* for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering the employees of Foxconn Assembly LLC (the Company) who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”).

***Plan Administration***

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Reliance Trust Company (“Reliance” or the “Trustee”) is the trustee of the Plan.

***Contributions***

The Plan allows participants to defer a percentage of their eligible compensation as contributions to the Plan. Eligible participants may elect to make pre-tax or Roth contributions. Contributions are subject to certain limitations. The Company matches 100 percent of the participant's salary deferral up to 4 percent of the employee's eligible compensation. Additional contributions can be made at the discretion of the Company's Board of Directors.

Participants are also allowed to make rollover contributions of amounts received from other eligible tax-qualified retirement plans (including rollover contributions of Roth contributions). Such contributions are deposited in the appropriate investment funds in accordance with the participants' directions and the Plan's provision. An aggregate of \$21,028 was rolled into the Plan during the year ended December 31, 2024 and is included in rollovers on the statement of changes in the net assets available for benefits.

***Participant Investment Account Options***

Investment account options include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation at any time.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's matching contribution, profit-sharing contributions, if any, an allocation of the plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participant contributions, employer matching contributions, employer profit sharing contributions (if any), and rollovers, as well as all earnings on these contributions, are fully vested when made or earned.

***Forfeitures***

Forfeitures that occur during a Plan year will be used to reduce Plan administration fees or to reduce future employer contributions. The unallocated forfeiture account balances were \$832 and \$678 as of December 31, 2024 and 2023, respectively.

***Payment of Benefits***

Upon retirement or termination of service, a participant may elect to receive a distribution of their vested account balance in a lump-sum payment, or installments over a period of not more than assumed life expectancy, or partial withdrawals if the value of the participant's vested interest in the account is greater than \$5,000. If the vested interest is less than \$5,000, the account balance may only be distributed in a lump-sum payment. In-service or hardship withdrawals are also permitted as outlined in the *Plan Document*.

***Participant Notes Receivable***

The *Plan Document* includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$500. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are repayable over a period not to exceed five years (except loans for the purchase of a principal residence, which is repayable over a period not to exceed thirty years). Interest on the loans is based on the prime rate as specified in the Wall Street Journal plus 1 percent. The interest rate on participant notes receivable for the year ended December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid in equal installments through payroll deductions.

*Plan Termination*

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. The Company has not expressed such intention as of these financial statements date.

**Note 2: Summary of Significant Accounting Policies**

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

*Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, foreign exchange and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 2: Summary of Significant Accounting Policies, continued**

*Valuation of Investments and Income Recognition*

The Plan's assets are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on the accrual basis, while dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

The Plan has an investment option, the MetLife Reliance Stable Value Fund Series 25053 - Class 0, a fully-benefit responsive investment account. That investment is reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan that is attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

*Payment of Benefits*

Benefit payments to participants are recorded upon distribution. In the year 2024, there was distribution of \$2.64 million, including termination distributions of \$1.85 million accounted for approximately 70% of the total payment of benefits.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distribution and recordkeeping fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. The Company paid the majority of all necessary and proper expenses incurred in the administration of the Plan. Such expenses were primarily comprised of fees and expenses related to the maintenance of the Plan's records.

**Note 3: Related Party and Party-in-interest Transactions**

The Company, the plan sponsor, provides certain administrative services at no cost to the Plan. In addition, certain Plan investment options are sponsored by the Trustee of the Plan. Therefore, any transaction executed with the Trustee qualifies as a party-in-interest transaction. Any purchases and sales of these funds are performed in the open market at fair value.

**Note 4: Plan Tax Status**

The Plan has received a copy of the opinion letter, dated October 6, 2020 and addressed to the Plan’s service provider, Automatic Data Processing, Inc. (ADP), from the Internal Revenue Service (IRS) for the acceptability of the form of its prototype plan. The IRS letter indicates that the form of the Plan is acceptable under Internal Revenue Code. It further states that an employer who adopts this plan will be considered to have a plan qualified under Code Section 401.

Although the Plan may have been amended, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan and related trust were qualified as tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 6: Fair Value Measurements-Unaudited**

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1:** Quoted prices in active markets for identical assets or liabilities.

**Level 2:** Observable inputs other than Level 1 quoted prices for identical assets, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

**Level 3:** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy.

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include money market funds and equity securities. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Level 2 securities include pool separate accounts, corporate bonds and municipal securities. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan did not have any Level 2 and Level 3 measurements as of December 31, 2024 and 2023.

*Mutual funds* are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

*Money market fund* is valued at \$1 per share which represents the net asset value (“NAV”) per share held by the Plan at year end. As of December 31, 2024, Money Market Fund consisted of Vanguard Federal Money Market Fund - Investor Class, and the Plan investments in this trust are classified within Level 1 of the fair value hierarchy.

*Self-directed brokerage accounts* allow participants directed investments in a Self-directed brokerage investment option which is maintained by TD Ameritrade Inc. The investments restrict to Mutual Funds and Exchange Traded Funds (“ETFs”) only. All of which are valued at the closing price reported in the active market in which the securities are traded. The mutual funds are valued at the daily closing net asset value (“NAV”) per share. ETF shares are traded throughout the day on national stock exchanges and at market prices that may or may not be the same as the NAV of the shares.

*Common/collective trust funds (“CCT”)* are valued using Net Asset Value (NAV) based on the value of the fund’s underlying assets (minus applicable costs and liabilities), divided by the number of shares outstanding. The underlying investments are valued by the issuer using either quoted market prices on active markets or observable inputs or quotations from inactive markets. The common/collective trust fund solely includes MetLife Reliance Stable Value Fund Series 25053 - Class 0.

The preceding method described for valuation of the fund may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
