Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the P&A Industrial Fabrications, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Notes to Financial Statements

December 31, 2024 and 2023

1. Summary of Significant Plan Provisions

The following description of the P&A Industrial Fabrications, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of P&A Industrial Fabrications, LLC, LaFrance Fabrics, LLC, P&A Group, LLC, PAG ASB, LLC, and PAG Carolina Crate & Pallett, LLC (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Each employee, who is not an intern, part-time, temporary, or seasonal employee, shall be eligible to participate in the Plan upon hire. Entry dates are the first day of each month.
- c. **Contributions** – Participants may contribute through payroll deductions and rollover contributions. Contributions made through payroll deductions can be made in an amount up to the maximum amount allowed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Employer may, at its discretion, make a matching contribution. The Employer made no such matching contribution for the year ended December 31, 2024. In addition, the Employer may, at its discretion, make a profit sharing contribution to be determined each year. The Employer elected to make a profit sharing contribution of 2% of a participant’s annual eligible compensation for the year ended December 31, 2024. The IRC imposes limits as to the maximum annual amount of additions that can be made to a participant’s account.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting rights** – A participant’s benefit shall be fully vested and nonforfeitable if their employment is terminated as a result of death, disability, or reaching normal retirement age. If a participant terminates employment for any reason other than those mentioned above, they are entitled to the total value of their own contributions plus earnings thereon and a vested percentage of the discretionary matching and profit sharing contributions made by the Employer plus earnings thereon. The vesting percentage for Employer contributions is as follows:

- f. **Investment options** – Upon enrollment in the Plan, participants may direct their contributions into any of the investment options offered under the Plan. Participants may change their investment selections at any time.
- g. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$500 up to a maximum of the lesser of \$50,000, as reduced in accordance with the Plan agreement, or one-half of the participant’s vested account. Note terms are for a period of up to five years or for an extended period of time if for the purchase of a primary residence. The notes are secured by the participant’s account and bear interest at a rate of Prime plus 1%. Principal and interest are paid at least quarterly through payroll deductions. Participants are allowed to have a maximum of one loan outstanding from the Plan at any one time.
- h. **Forfeitures** – The portion of a participant’s account to which they are not entitled upon termination of participation is deemed a forfeiture. Forfeitures can be used to pay Plan expenses or to reduce Employer contributions. Forfeitures of approximately \$30,800 were used to pay Plan expenses during the year ended December 31, 2024. There were approximately \$22,000 and \$22,900 in forfeitures available for future use as of December 31, 2024 and 2023, respectively.
- i. **Payment of benefits** – Upon termination of service with the Employer, a participant, or their beneficiary, may elect to receive a lump sum amount equal to the value of the participant’s vested account balance. If a terminated participant’s account balance is equal to or less than \$7,000, the account will be automatically distributed. Any distribution greater than \$1,000 that is made to a participant without the participant’s consent before the participant’s normal retirement age will be rolled over to an individual retirement account designated by the Plan administrator. In-service withdrawals are available to participants who attain age 59½ or meet certain hardship requirements.
- j. **Termination of the Plan** – Although it has not expressed any intention to do so, the Employer reserves the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant will have a 100% nonforfeitable interest in his individual account.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for discussion on fair value measurements.

Notes to Financial Statements**December 31, 2024 and 2023****2. Summary of Significant Accounting Policies (cont.)**

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Fees related to loans and distributions are charged directly to the participants' accounts. Administrative expenses charged to the Plan are allocated to participants' accounts. Administrative expenses paid by the Employer are excluded from these financial statements.

3. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by John Hancock Life Insurance Company ("John Hancock"), the custodian of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedules:

The Plan provides for investments in various securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

4. Fair Value Measurements

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

Pooled separate accounts: These investments are valued based on the net asset value (“NAV”) of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments, adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated the Plan Document is designed in accordance with the applicable sections of the IRC. As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

Notes to Financial Statements**December 31, 2024 and 2023****6. Parties-in-Interest Transactions**

John Hancock provides custodial services to the Plan, and the Plan pays it for its services. The Plan is invested in John Hancock pooled separate accounts. Inasmuch as John Hancock serves as custodian, it is by definition a party-in-interest. Dixon Hughes Goodman Wealth Advisors (“DHGWA”) and Forvis Wealth Advisors, LLC (“Forvis”) serve as investment advisors to the Plan, and the Plan pays them for their services. Inasmuch as DHGWA and Forvis serve as investment advisors, they are by definition parties-in-interest. The Plan also holds notes receivable from participants. As a result, these notes receivable and related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

7. Delinquent Participant Contributions

The Plan sponsor determined that during the 2024, 2023, and 2022 Plan years, certain participant contributions and loan repayments were not remitted within the required time frame specified by the DOL’s regulations, which have been reported on the accompanying Schedule H, line 4a – Schedule of Delinquent Participant Contributions in the amount of \$758, \$13,808, and \$4,953, respectively. The Plan sponsor calculated lost earnings for certain pay dates and funded them to the Plan on April 16, 2024. The Plan sponsor is in the process of calculating lost earnings for the remaining pay dates.

8. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through September 19, 2025, which is the financial statement issuance date.
