We have performed an audit of the financial statements of PEI Down East Toyota 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution, or insurance carrier, that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of the PEI Down East Toyota 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including vesting and benefit provisions.

General

The Plan is a tax-exempt defined contribution plan covering substantially all employees of PEI (the Company). The Internal Revenue Service has determined and informed the third party administrator, by a prototype letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the prototype letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may voluntarily contribute up to the maximum percentage compensation and dollar amount permissible under the IRC. The Company may make discretionary matching contributions equal to a uniform percentage of each tier of participant elective deferrals. Contributions are subject to certain limitations.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive general account product which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan documents.

Administrative Expenses

Certain administrative expenses for the Plan are paid by the Company. Administrative expenses paid by the Plan to the Plan custodian, investment advisor, and auditor totaled \$28,018.

Payment of Benefits

Benefits paid to participants are recorded when amounts are distributed.

Subsequent Events

Management has considered transactions or events occurring through September 26, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. General Account Product

The Plan has a fully benefit-responsive general account product. The crediting interest rate is calculated based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum crediting interest rate, as stated in the contract, and prevailing market conditions. The general account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. The general account is included in the financial statements at contract value (which represents contributions made under the general account, plus earnings, less withdrawals and administrative expenses) because it is fully benefit-responsive. The average yield was approximately 1.41% for 2024 and 1.23% for 2023. The guaranteed minimum crediting interest rate is reset quarterly, and will not be less than 0%.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination, or merger with another plan), (b) changes to the Plan's prohibition in competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

4. Information Certified by Custodian

Information included in the financial statements and supplemental schedule relating to investments, notes receivable from participants, net appreciation in fair value of investments, and investment and notes receivable from participants income was obtained by management and agreed to, or derived from, information certified to be complete and accurate by the custodian. This information is included in the following:

- Schedule H, Line 4i – Schedule of Assets (Held at End of Year)

5. Related Party Transactions

Plan investments are managed by Empower Trust Company, LLC (Empower), the custodian. Empower provides custodial and plan administration services and, therefore, these transactions qualify as related party transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Mutual funds: Valued at the quoted net asset value (NAV) of units held by the Plan at year-end.

Collective trust funds: Valued using the market approach based on the NAV of the units held by the Plan at year-end. The NAV is provided by the custodian of the Trust and is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

1. Description of Plan

The following description of the PEI Down East Toyota 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including vesting and benefit provisions.

General

The Plan is a tax-exempt defined contribution plan covering substantially all employees of PEI (the Company). The Internal Revenue Service has determined and informed the third party administrator, by a prototype letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the prototype letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may voluntarily contribute up to the maximum percentage compensation and dollar amount permissible under the IRC. The Company may make discretionary matching contributions equal to a uniform percentage of each tier of participant elective deferrals. Contributions are subject to certain limitations.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive general account product which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan documents.

Administrative Expenses

Certain administrative expenses for the Plan are paid by the Company. Administrative expenses paid by the Plan to the Plan custodian, investment advisor, and auditor totaled \$28,018.

Payment of Benefits

Benefits paid to participants are recorded when amounts are distributed.

Subsequent Events

Management has considered transactions or events occurring through September 26, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. General Account Product

The Plan has a fully benefit-responsive general account product. The crediting interest rate is calculated based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum crediting interest rate, as stated in the contract, and prevailing market conditions. The general account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. The general account is included in the financial statements at contract value (which represents contributions made under the general account, plus earnings, less withdrawals and administrative expenses) because it is fully benefit-responsive. The average yield was approximately 1.41% for 2024 and 1.23% for 2023. The guaranteed minimum crediting interest rate is reset quarterly, and will not be less than 0%.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination, or merger with another plan), (b) changes to the Plan's prohibition in competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

4. Information Certified by Custodian

Information included in the financial statements and supplemental schedule relating to investments, notes receivable from participants, net appreciation in fair value of investments, and investment and notes receivable from participants income was obtained by management and agreed to, or derived from, information certified to be complete and accurate by the custodian. This information is included in the following:

5. Related Party Transactions

Plan investments are managed by Empower Trust Company, LLC (Empower), the custodian. Empower provides custodial and plan administration services and, therefore, these transactions qualify as related party transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
