**NOTE 1 - DESCRIPTION OF THE PLAN**

General: The following description of the SFSL Affiliates 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan Sponsor is East Ridge Retirement Village, Inc. (the “Organization”). Effective October 4, 2013, Bonita Springs Retirement Village, Inc. became an Adopting Employer of the Plan.

Effective October 31, 2024, Bonita Springs Retirement Village, Inc. was acquired by ACTS Retirement Life Communities. As a result of this transaction, an employer-initiated severance of at least 20% of the Plan’s participants occurred causing a partial plan termination. The affected participant account balances in the Plan were immediately 100% vested provided that: 1) The participants were actively employed by Bonita Springs Retirement Village, Inc. on October 31, 2024 or were terminated after December 31, 2023, and 2) maintained a balance in the Plan as of October 31, 2024.

The Plan is a defined contribution plan covering employees of the Organization and Adopting Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute their pretax or post-tax annual compensation, as defined in the Plan, up to the statutory maximum. Participants are eligible to contribute to the Plan immediately following their date of hire, and those who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Organization provides a discretionary matching contribution equal to 50% of the first 6% of eligible compensation, as defined, that a participant contributes to the Plan. To be eligible for the matching contribution, participants must be at least of age 21 and must have completed one year of service as defined by the Plan document.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Organization’s contributions and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization’s matching contribution is based on years of continuous service. A participant is fully vested after six years of continuous service.

Forfeitures: Forfeitures are those amounts of the Organization’s matching contributions in which a participant is not fully vested at the time of termination. Forfeitures are used to reduce future employer contributions or to pay Plan expenses. The remaining balances of forfeitures available to offset future contributions and administrative expenses as of December 31, 2024 and 2023 were \$11,257 and \$19,958, respectively. These accounts will be used to pay plan expenses or reduce future employer contributions. During 2024, forfeitures used to reduce employer contributions were \$19,122.

Payment of Benefits: On termination of service due to death, disability, retirement, or other termination of employment, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. In-service withdrawals are allowed at age 59 ½ or for hardship purposes.

Plan Termination: The Organization has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

Effective October 31, 2024, Bonita Springs Retirement Village, Inc. was acquired by ACTS Retirement Life Communities. As a result of this transaction, the Plan experienced an employer-initiated severance affecting at least 20% of its participants. This qualified as a partial plan termination under Internal Revenue Code regulations.

Administrative and Investment Management Expenses: Custodial fees may be paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. Certain administrative functions are performed by employees of the Organization and Adopting Employer. No such employees receive compensation from the Plan. Certain professional and other expenses of the Plan are paid by the Organization. Plan expenses are recorded when incurred.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contracts, are stated at fair value. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Risk and Uncertainties: The Plan provides for various investment options. Investments are exposed to various risks, such as interest rate, market, liquidity and credit risk. Market risk includes events such as pandemics. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. ("Lincoln").

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - INCOME TAX STATUS**

The Plan is established under Section 403(b) of the Internal Revenue Code (IRC), and is therefore exempt from federal income taxes under provisions of Section 501. The Plan is required to operate in conformity with the IRC to maintain its qualification. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 - INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan holds a benefit-responsive traditional investment contract with The Lincoln National Life Insurance Company ("Lincoln Insurance"). Lincoln Insurance maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of Lincoln Insurance or otherwise. The crediting interest rate is based on a formula agreed upon with Lincoln Insurance, but it may not be less than 1%. Lincoln Insurance reviews such interest rates on a quarterly basis for resetting.

**NOTE 6 - INVESTMENT CONTRACTS WITH INSURANCE COMPANY** (Continued)

Certain events limit the ability of the Plan to transact at contract value with the Lincoln Insurance. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary), or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Plan management believes that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is not probable.

The group fixed annuity contract permits Lincoln Insurance to terminate the agreement prior to the scheduled maturity date in the following circumstances: (1) Any charges billed to the contract owner have not been paid to Lincoln Insurance within 30 days, (2) The Plan ceases to meet the requirements of the IRC for purchasers of this contract, (3) At any time following the end of the third contract year, the contract owner's account balance is less than \$15,000, (4) At any time following the end of the third contract year, there is no deposit activity for a 24-consecutive-month period and the contract owner's account balance is less than \$50,000, (5) The contract owner fails to furnish requested information or other documentation, (6) Lincoln Insurance discovers any misrepresentation of material information, (7) Lincoln Insurance discontinues offering this contract form to the public, or (8) The Plan terminates its recordkeeping agreement with Lincoln Insurance.

**NOTE 7 - PARTIES-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds an unallocated investment contract with Lincoln Insurance. Lincoln Insurance is an affiliate of the Plan's trustee and recordkeeper; therefore, these transactions and the Plan's payment of trustee fees and investment management fees to Lincoln Insurance and any other administrative fees qualify as party-in-interest transactions.

**NOTE 8 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through September 25, 2025, which is the date the accompanying financial statements were available to be issued.

On February 26, 2025, the Board of Directors of SantaFe HealthCare, Inc. approved a resolution authorizing Authorized Executives to effectuate the termination of the Plan. The resolution granted full authority to the Authorized Executives to execute all necessary amendments, notify participants, and take all steps required to complete the termination of the Plan without the need for further board approval.

Pursuant to that authority, the Vice President of Human Resources, an Authorized Executive, issued a formal letter of intent to the Plan's recordkeeper directing the operational commencement of the Plan termination, including the cessation of contributions as of June 27, 2025, full vesting of all participants as of the termination date, and initiation of plan distribution procedures. The formal termination date of the Plan has been set for June 30, 2025 (unaudited).
