## Report of Independent Auditors

**1. Description of Plan**

The following description of the Hengst of North America Retirement Savings Plan (the "Plan") provides only general information. Participants may refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan which provides retirement benefits to employees of Hengst of North America, Inc. and employees of its sister company, Nordic Air Filtration North America Inc. (collectively the "Company"). The Retirement Plan Committee is the trustee of the Plan.

Eligibility to participate in the Plan is based on attainment of age eighteen and completion of three months of service with the Company. Employees may enter the Plan on the first of each month upon meeting these requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan Amendments**

Effective March 1, 2023, the Plan was amended and restated to (1) increase the employer safe harbor matching contribution formula to 100% of each eligible participant's elective deferrals up to 6% of the individual participant's eligible compensation, subject to limitations specified by applicable laws and regulations, and (2) change the calculation of employer safe harbor matching contributions from each pay period to each Plan year.

**Contributions**

Participants may contribute any percentage greater than or equal to 1% of their pretax annual compensation, as defined in the Plan, subject to contribution limitations specified by applicable laws and regulations. For the year ended December 31, 2024 and 2023, the Company made safe harbor matching contributions to each eligible participant's account equal to 100% of the first 6% of the individual participant's contributions, subject to limitations specified by applicable laws and regulations.

Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans.

**1. Description of Plan (continued)**

**Vesting**

Participants are 100% vested in their participant contributions and safe harbor employer matching contributions, plus actual earnings thereon, at all times.

**Notes Receivable from Participants**

Notes receivable from participants are not permitted under this Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and employer safe harbor matching contributions, earnings or losses thereon, and charged with an allocation of any administrative expenses paid by the Plan. Participants may elect to allocate current contributions among a variety of investment fund options. The allocations remain in effect until a new election is made.

Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

Upon retirement, disability, death, termination of employment, or attainment of age 59½, participants or their beneficiaries may elect to receive their vested portion of Plan assets in a single distribution or other distribution methods as allowed under the Plan. Upon termination of employment for reasons other than retirement, disability, or death, the participant's interest in the Plan will be paid to the participant as soon as administratively feasible upon participant request of a distribution.

Participants with account balances greater than \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or may choose among various installment options provided for by the plan. Upon termination of service, participants with an account balance greater than \$1,000 and less than \$5,000 will have their account rolled over into an IRA sponsored by Empower Trust Company, LLC for the benefit of the participant. Upon termination of service, participants with account balances less than \$1,000 will receive a lump-sum distribution.

Hardship distributions are permitted upon determination of financial hardship.

## **2. Basis of Presentation and Summary of Significant Accounting Policies**

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA.

### **Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

### **Estimates**

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for a fully benefit-responsive guaranteed annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's investments include the Key Guaranteed Portfolio Fund, a fully benefit-responsive guaranteed annuity contract with Empower Annuity Insurance Company of America ("Empower"). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed annuity contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement for this Plan asset. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Investment Valuation and Income Recognition (continued)**

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow Empower to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan's investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values in investment securities will occur in the near term and that these changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative expenses, including recordkeeping fees, are charged to individual participants' accounts. Any expenses not paid by the Plan are paid by the Company.

**3. Certified Investments**

Information presented in the accompanying financial statements as of, and for the years ended December 31, 2024 and 2023, related to investments, net appreciation in fair value of investments, and interest and dividends was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower (the custodians of the Plan).

**4. Fair Value Measurements**

The Plan's investments in mutual funds are reported at fair value in the accompanying statements of net assets available for plan benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

All of the Plan's mutual fund investments were valued using Level 1 inputs, based on quoted market prices of the shares held by the Plan.

Gains and losses (realized and unrealized) included in the statements of changes in net assets available for Plan benefits for the years ended December 31, 2024 and 2023 are reported in the net appreciation in fair value of investments. Unrealized gains and losses from the guaranteed annuity contract are not reported in the statements of changes in net assets available for Plan benefits as the accounts are presented at contract value.

**5. Related Parties and Parties-in-Interest**

All of the Plan's investments were held by the custodians of the Plan as of and for the years ended December 31, 2024 and 2023. Therefore, all transactions with the custodians qualify as party-in-interest transactions. The Plan paid approximately \$9,000 and \$8,000 annually for custodial, recordkeeping, and investment advisory fees during 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**6. Income Tax Status**

The Plan is a non-standardized pre-approved profit sharing plan, provided by Empower Retirement, LLC, designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The IRS issued an opinion letter dated November 14, 2022, which stated that the non-standardized pre-approved profit sharing plan, as then designed, was in compliance with the applicable sections of the IRC. Although the Plan has been amended and formally restated since the date of the most recent letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust was tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Prior to March 1, 2023, the Plan was a non-standardized pre-approved profit sharing plan, provided by Great-West Trust Company, LLC, designed to be in compliance with the applicable requirements of the IRC. The IRS issued an opinion letter dated June 30, 2020, which stated that the non-standardized pre-approved profit sharing plan, as then designed, was in compliance with the applicable sections of the IRC.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. No such liabilities are identified at December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
