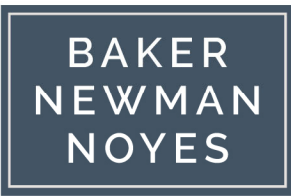

## INDEPENDENT AUDITORS' REPORT

The Plan Administrator and Participants  
Eaton Peabody, PA 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Eaton Peabody, PA 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### 1. Description of Plan

The following description of the Eaton Peabody, PA 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a 401(k) defined contribution retirement plan covering all eligible employees of Eaton Peabody, PA (the Company). Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

##### Eligibility

Employees are eligible to participate in the Plan when they have attained the age of 21. The Plan has no service requirements for purposes of participating in the Plan. Employees enter the Plan on the first day of each month coinciding with or next following the date the employee satisfies the Plan's eligibility requirements.

##### Contributions

The Plan allows for 401(k) pre-tax and Roth deferral options. Participants may contribute up to 75% of their eligible compensation, as defined by the Plan, or specify a specific dollar amount to be contributed each payroll period. Contributions are subject to certain limitations, such as provided by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are also allowed to make rollover contributions to the Plan of amounts received from certain other tax-qualified retirement plans.

The Plan provides for a safe harbor nonelective employer contribution for all eligible participants in an amount equal to 3% of the participant's eligible compensation.

The Plan also offers a discretionary nonelective employer contribution in an amount to be determined by the Board of Directors for each Plan year. Employees are required to complete at least 1,000 hours of service during the Plan year and must be employed on the last day of the Plan year in order to participate in any discretionary nonelective employer contribution. Discretionary nonelective employer contributions made to the Plan are allocated by an integrated allocation formula based on a percentage of each eligible participant's compensation plus a percentage of each eligible participant's compensation in excess of the integration level, as defined. No discretionary nonelective employer contributions were made in 2024.

#### 1. Description of Plan (Continued)

##### Investment Options

All participant and Company contributions are invested at the direction of each participant in any of the available investment options. One of the available options is a brokerage account. In a brokerage account, participants may hire their own investment manager or manage their own account through an outside brokerage firm.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's safe harbor nonelective contributions, as well as an allocation of (a) discretionary nonelective employer contributions, (b) Plan earnings and (c) charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately 100% vested in their voluntary contributions and the safe harbor nonelective employer contributions, plus actual earnings thereon. Vesting in discretionary employer nonelective contributions and any earnings thereon is based on years of continuous service. Participants become vested in discretionary employer nonelective contributions on a graded vesting schedule and are 100% vested after six years of service.

##### Notes Receivable From Participants

Participants may borrow from their accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum note amount is \$1,000. From January 1, 2023 to November 13, 2024, the Plan allowed up to 4 outstanding notes per participant at a time. Effective November 13, 2024, the Plan allowed a maximum of 3 outstanding notes per participant at a time. Participants with 4 existing outstanding notes were permitted to keep the notes, but are not eligible to apply for a new note until 2 of the 4 outstanding loans are paid in full. Note terms may not exceed five years unless for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is repaid through payroll deduction. Interest rates range from 4.25% – 9.50% at December 31, 2024 with various maturities through January 2033.

##### Payment of Benefits

Benefits may be paid upon termination, death, disability or retirement. The Plan allows for in-service distributions upon attaining age 59 ½. Benefits are payable in the form of a lump sum. Certain participants with legacy balances from a previously terminated money purchase pension plan have annuity-based distribution options, as further outlined in the Plan document.

#### 1. **Description of Plan (Continued)**

Vested account balances greater than \$1,000 and less than \$5,000 may be automatically distributed to an IRA on the participant's behalf upon termination of employment unless directed otherwise by the participant. Vested account balances of \$1,000 or less may be automatically distributed to the participant in a lump-sum on the participant's behalf upon termination of employment. Effective January 1, 2025, the Plan provided for the optional provision with the SECURE 2.0 Act to increase the mandatory cash out threshold from \$5,000 to \$7,000.

##### Forfeitures

Forfeitures of terminated participants' nonvested account balances may be used by the Plan to pay administrative expenses and any remaining amounts shall be used to reduce future employer contributions to the Plan. The balance in the forfeiture account at December 31, 2024 and 2023 was \$14,449 and \$7,868, respectively. The Plan used \$7,438 of the forfeitures during the year ended December 31, 2024 to pay administrative fees.

##### Administrative Expenses

The Company pays certain expenses incurred in the administration of the Plan. Certain fees incurred by the Plan for investment management and certain administrative services are paid through revenue sharing rather than direct payment.

##### Top-Heavy Provisions

The Plan is subject to the top-heavy requirements of the IRC. For the 2024 Plan year, the Plan was determined to be top-heavy. In accordance with the IRC, the Plan Sponsor made the required minimum contributions to non-key employees to satisfy the top-heavy requirements.

##### Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

On May 1, 2025, the Board of Directors of the Company voted to terminate the Plan effective May 1, 2025, as a result of the Company's shareholders' decision to close its office locations and cease performing client work on or before June 30, 2025. Effective May 1, 2025, all contributions to the Plan ceased. Furthermore, participants became 100% vested in their account balances. Rollovers and lump-sum distributions began being processed by September 19, 2025, and as of the date these financial statements were available to be issued, substantially all distributions have been made, with remaining accounts expected to be completed as soon as administratively feasible.

#### 2. **Summary of Significant Accounting Policies**

##### Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting.

##### Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan Administrator deems the note to be a distribution, the participant note balance is reduced and a benefit payment is recorded.

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

##### Contributions

Contributions from participants are recorded in the year in which payroll deductions are made. Employer contributions are recorded in the year for which the related employee service was performed.

##### Payment of Benefits

Benefit payments are recorded when paid.

##### Risks and Uncertainties

The Plan invests in various investment options which are exposed to various risks, such as interest rate, market, liquidity and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

##### *Subsequent Events*

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

#### 3. **Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Fidelity Management Trust Company, the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has determined that the trustee meets the requirements of a qualified institution defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator has obtained certifications from the trustee as of and for the year ended December 31, 2024 and as of December 31, 2023, stating that the information provided to the Plan Administrator by the trustee is complete and accurate. Such information includes investments, net appreciation in fair value of investments, interest and dividend income, investment transactions, notes receivable from participants, interest income on notes receivable from participants and related transactions.

##### *Collective Trust Fund*

The Plan holds an investment in the Federated Hermes Capital Preservation Fund IP (FHCP Fund), which is a stable value collective trust. The FHCP Fund seeks to preserve principal and current income. This fund seeks to maintain a stable net asset value (NAV) of \$10.00 per unit of participation. The FHCP Fund primarily invests in stable value products, including traditional guaranteed investment contracts (GIC), synthetic GICs, and money market instruments. There are no restrictions on participant redemption, which may occur daily. If the Plan were to initiate a full redemption of the collective trust fund, then the issuer reserves the right to require twelve months' advance notice. There are no unfunded commitments related to this collective trust fund at December 31, 2024.

#### 4. **Fair Value Measurements**

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

#### 4. **Fair Value Measurements (Continued)**

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the NAV of shares held by the Plan at year end, which are traded in an active market.

*Self-directed brokerage accounts:* Accounts primarily consist of cash, mutual funds, exchange-traded funds and common stocks that are valued at the closing prices reported on an active market.

*Common Collective Trust:* Valued at the NAV of units of a bank collective trust held by the Plan at year-end (see Note 3). The net asset value is used a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Tax Status**

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
