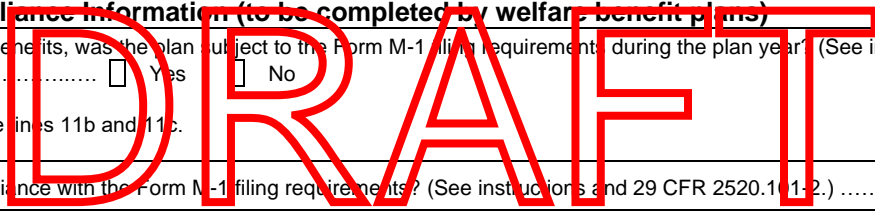

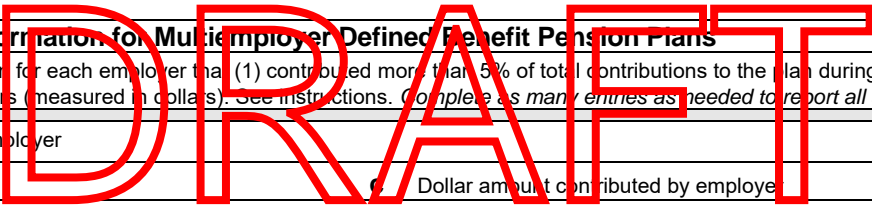

Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Safe-Harbor 401(k) Profit-Sharing Plan For Employees of Extrudex Aluminum, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of Safe-Harbor 401(k) Profit-Sharing Plan For Employees of Extrudex Aluminum, Inc., provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined-contribution plan covering all employees of Extrudex Aluminum, Inc. (the Company), who are 19 years of age or older and have completed six months of service for eligibility purposes. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Under the Plan's provisions, each participant may contribute an amount up to the elective deferral dollar limit and the Section 415 limitation of the Internal Revenue Code, as defined in the Plan. Participants may also roll over amounts representing distributions from other qualified defined-benefit or contribution plans. The Company makes a safe harbor matching contribution to the Plan which equals 100% that does not exceed 4% of the participant's compensation contributed to the Plan. The Company may elect to make an additional matching contribution or a discretionary employer contribution. No such contributions were made for the years ended December 31, 2024 and 2023. Upon enrollment in the Plan, a participant may direct employee contributions and Company contributions to any of the available investment options. Participants may change their investment options at their discretion. All of the balances of the Plan represent participant-directed investments.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the appropriate matching contribution and (b) Plan earnings (losses), as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

Vesting - Vesting in participants' accounts relating to the Company discretionary contribution is based on years of continuous service. A participant is 100% vested after six years of credited service. Participants are immediately vested in their deferrals and contributions rolled over from other qualified defined-benefit or contribution plans, the Company safe harbor contribution, plus actual earnings thereon.

Notes receivable from participants - Participants may borrow from their account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are collateralized by the balance in the participant's account and bear interest at a market rate of interest. The participant may be required to repay principal and interest ratably through payroll deductions based on payroll frequency or quarterly payments.

Payment of benefits - On termination of service, a participant will be entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments. Benefits are recorded when paid.

Forfeited accounts - For the years ended December 31, 2024 and 2023, forfeited accounts totaled \$6,734 and \$101, respectively. Forfeitures may be used to pay plan expenses or to reduce future Company contributions. During the years ended December 31, 2024 and 2023, Company contributions were reduced by \$6,734 and \$101, respectively. In addition, during each of the years ended December 31, 2024 and 2023, Plan expenses of \$0 were paid from the forfeiture account.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates and subsequent events - The preparation of financial statements in conformity with account principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates. In preparing the financial statements, including estimates and disclosures, management has considered the effects of subsequent events through September 30, 2025—the date the financial statements were available to be issued.

Investment valuation and income recognition - The Plan's investments are stated at fair value as of December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See NOTE C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold and unrealized gains and losses on investments held during the year.

Assets of the Plan are held in separate accounts administered by Mutual of America as of December 31, 2024 and 2023, representing investments in pooled separate accounts.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent participant loans are reclassified as distributions based upon the terms set forth in the Plan document.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 inputs consist of significant observable inputs other than quoted prices for identical assets.
- Level 3 inputs consist of significant unobservable inputs that are not corroborated by market data and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were used or available to the Plan.

NOTE E - ADMINISTRATION OF PLAN ASSETS, EXPENSES AND RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. Other administrative expenses are paid directly by Extrudex Aluminum, Inc. or are paid directly from Plan assets. Investment-related expenses are included in net appreciation in fair value of investments on the accompanying statements of changes in net assets available for benefits. Participants' loan fees and distribution fees are paid by the respective participant.

NOTE F - TAX STATUS

The Company believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, the Plan qualifies under IRC Section 401(a), and the related Trust is tax exempt as of December 31, 2024. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.
