Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of C.A.P.S. Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management having determined it is permissible in the circumstances, has elected to have the audit of C.A.P.S. Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of Plan

The following description of C.A.P.S. Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete information.

General:

The Plan is a defined contribution profit sharing plan covering all employees of Country Lane Woodworking, LLC, Patiova LLC, SK MFS LLC, and AM MFS LLC. Employees enter the plan on the first day of the month after completing six months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established January 1, 2022.

Contributions:

Each year, participants may contribute a dollar amount set by law of pre-tax annual compensation, as defined in the Plan, or can choose to make Roth 401(k) contributions, which are post tax. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For the years ended December 31, 2024 and 2023, the Company made a Safe Harbor Match, which includes a 100% match of salary deferrals equal to the first three percent of compensation and a 50% match of salary deferrals equal to the next two percent of compensation. In addition, the employer can make a discretionary profit sharing contribution.

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer matching contribution and (b) plan earnings and losses. Allocations are based on participant earnings or account balances, as defined. The employer profit-sharing contribution is allocated to eligible participants according to the ratio each participant's compensation for the plan year bears to the total compensation of all participants for the plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant has the option of directing his/her account balance to one or more different investment funds offered by the Plan. Participants may change investment options at their discretion.

Note 1. Description of Plan (Continued)

Vesting:

Participants are immediately vested in their contributions, plus actual earnings thereon. A participant is also 100% vested in rollover contributions, employer safe harbor contributions, and employer profit sharing contributions.

Payments of Benefits:

Upon termination of service, normal retirement, death or disability a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, can roll the amount over into another qualified plan, or delay the distribution until the participant is required by law to receive minimum required distributions. In addition, participants are eligible to take in-service distributions once they have attained the age of 59.5 and are eligible for hardship distributions under certain circumstances.

Forfeited Accounts:

At December 31, 2024, forfeited non-vested accounts totaled \$0.

Administrative expenses:

Most of the expenses incurred in administering the plan were paid directly by the plan sponsor.

The following are the significant accounting policies followed by the Plan:

Basis of Accounting:

The accounting records of the plan are maintained on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition:

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains or losses on investments bought or sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Administrative and Investment Fees:

The Investment fees are paid from the Plan's assets. The employer pays the remaining Plan administration costs.

Note 3. Financial Data Certified by the Custodian (Unaudited)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA for 2024. Under that section, no auditing procedures are required to be performed with respect to the information certified by Capital Bank and Trust Company, the trustee of the Plan. The trustee has certified the completeness and accuracy of all investments, reported in the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024.

Mutual Funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Late Deposits

As required by ERISA Section 2510.3-102, the plan sponsor is required to segregate employee contributions to the plan from its general assets as soon as practicable but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. The employer submitted a total of \$9,782 in participant contributions late into the plan. The employer is planning to enroll in the Voluntary Fiduciary Corrections Program to make the plan whole. As required by ERISA Section 2510.3-102, the plan sponsor is required to segregate employee contributions to the plan from its general assets as soon as practicable but in no event more than 16 business days following the end of the month in which amounts are withheld from wages.

Note 6. Tax Status

Effective January 1, 2022, the Company adopted a non-standardized prototype plan. The non-standardized prototype plan has received an opinion letter from the IRS, dated June 30 2020, stating that the plan is qualified under the appropriate section of the IRC. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all of their account balances.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances.

Note 9. Related Party Transactions and Party-In-Interest

Certain Plan investments are mutual funds affiliated with the plan trustee, the Capital Bank & Trust Company. These transactions qualify as party-in-interest transactions.

Note 10. Subsequent Events

Plan management has evaluated subsequent events through October 1, 2025. This date is the date the financial statements were available to be issued.

Note 11. Revenue Recognition

Revenue is recognized when control of the promised services is transferred to the customer in an amount that reflects the consideration expected in exchange for those services. The Financial reporting Executive Committee ("FinREC") issued pending content guidance for the employee benefit plans. Per the FinREC guidance, the cash flows generated by the Plan would not be considered revenue from customers due to the unique relationships created through a multi-employer benefit plan. Therefore, the cash inflows do not meet the requirement to be reported as revenue under ASC 606. No changes in the reporting of revenue are necessary for the Plan.

There was no material impact to any of the line items within the Plan's statement of Changes in Net Assets Available for Benefits or Statements of Net Assets Available for Benefits as a result of applying ASC 606 for the fiscal year ended December 31, 2024.
